Ms. White,

The files of the Children's Aid Society of Ottawa ("CAS") are rife with false information, errors and omissions. Obviously, evidence of this would not be within the file itself: it can only become clear once the contents of the CAS file is compared to truthful information.

Currently, Kiska is refusing to e-transfer to me his fraudulently-acquired, court-ordered, below-poverty-level, spousal support of \$1,230/month which is now two months overdue. Kindly familiarize yourself with the original family law file and then assign a new case worker whom has the capacity to protect my children from their wicked, biological father.

Regarding the children's own "lawyer", Debora Scholey**: she is equally as guilty as Mohammed Said ... as is Isabelle Guindon. Moving Isabelle Guindon from our file does not eliminate her guilt of the harm that she has already caused by refusing to assign a new case worker when she had the opportuity. It is my view that she still has the responsibility to report the crimes being committed by employees of the CAS to Ottawa Police Services. Hello Ms. Moore;

My name is Kelly White and I am Mohammed's new supervisor. Please note that Ms. Guindon; nor Ms. Moir are no longer connected to your file and should not be cc'd moving forward.

I would like to acknowledge receipt of your email requesting a new worker and indicating that Mohammed has lied in court and acted inappropriately. I have had an opportunity to review your family's file and there is no evidence of inappropriate behavior contained within. As indicated to you by Mohammed in a previous email, we are happy, and welcoming, of hearing from yourself and your doctor (s) regarding the state of your mental health. We continue to want to work cooperatively with you toward addressing the protection concerns. It is my understanding that you have made requests that your children be returned to your care. In order for that to be a consideration, there does need to be conversations regarding your mental health status. As you stated, Mohammed "continues to purport that you have some kind of chronic mental health illness." It is important that we have clear and fulsome conversations with yourself and your professionals in order to be able to understand the state of your mental health currently. Please find below an excerpt from Mohammed's correspondence to you on April 15th, 2020;

Once we are able to understand how your mental health is doing at the moment, we can begin discussions about what sort of contact you could have with the children. As you know, they are represented by their own lawyer, Ms. Debora Scholey, and so part of that discussion would be understanding what the children would feel comfortable with. It could start with an exchange of letters and photos, for example. As you're aware, the children haven't seen you in over a year and so any contact with them would need to be gradual.

Given that I do not have evidence of Mohammed acting inappropriately, I will not be changing your worker at this time. Please also understand, that changing a family's worker can be very disruptive to the process and is avoided wherever possible.

Ms. Moore; I can only imagine how difficult it must be to be disconnected from your children. The Society would like to support you to addressing the outstanding child protection concerns and potentially help you to re-establish a relationship with them. However, in order to do this, it is critical that you speak with the assigned worker. I encourage you to do so as soon as possible.

I am pleased that you are reaching out. I can assure you that the children are doing very well. They are currently doing their school work on line and their academic standings have improved. Cate has been consistently doing math tutoring which she loves and her marks in Math have gone up. At the end of each Math tutoring she used to go swimming. Before COVID-19 both children were involved in programs and activities in the community.

In order to discuss how and when you can become re-involved in the children's lives, we first need to be able to have a discussion about why the Society became involved, and how things are going for you now. Particularly, I would need to hear more about how you are addressing your mental health concerns. It would be helpful, if you are seeing a psychiatrist, psychologist, or a general physician.
