are you out of jail

(20210305 11:06 e.s.t.) I have been out of jail since October 13th, 2020. They only arrested me to prevent me from being able to defend myself against the CAS and the Crown. I had to stay out of Canada from March 2020 until September 2020 to upload enough evidence to my website so that if I was re-arrested, at least someone could print it off for me.

(20210305 11:09 e.s.t.) The only reason that I was able to get out on Bail in October was by offering to wear a \$400+/month GPS ankle-monitoring bracelet. If had not found extra cash tucked into my passport that I had forgotten about, then I would never have gotten out and I would have had zero evidence for the scandalous [November] 2020 hearing that I am now appealing.

(20210305 11:10 e.s.t.) As soon as I got out, they dropped the charges.

what did they charge you

(20210305 11:13 e.s.t.) Sean and Cate's dad has committed many, many crimes to cut me out of their lives completely. What he does not know is that my story was picked up by someone (I am not certain who) a few years ago. On Monday, significant changes to Canada's Divorce Act came into effect. Their dad is in BIG trouble. (He just does not know it yet and/or cannot believe it yet. (Just a sec, I will get you a link to a page that I am working on and explain.)

how old are sean and cate

(20210305 11:20 e.s.t.) Sean turns 15 in May and Cate is 13. They were, effectively, kidnapped by my ex February 1st, 2019 with the assistance of career criminals running the Children's Aid Society of Ottawa and some crooked cops of which Ottawa has a TON. Of the thirteen charges that they have thrown at me, there are only nine left and two of them are of their dad accus[ing] me of criminal harassment which is entirely bogus. (Their dad has some dirty Crown prosecutors in his back pocket.) The amount of corruption in this town that I have uncovered is mind-blowing. I am hoping to have the CAS disassembled and replaced by a government- run agency with accountability and oversight as described here: <http://pfi.rocks/entity/cas/sjm/>. (The CAS is a taxpayer-funded FOR PROFIT enterprise: most people do not know that. Accordingly, they are PAID to bust up families. I saw evidence that they are actually targeting our indigenous and African-Canadians. These beasts are truly wicked and need to be shut down and my case is THAT black and white [that] it might just be the case that will make that happen.)

It is my hope that, once we are re-united, they will want to build my For-Social-Benefit company with me to help other victims of domestic violence, the CAS and our crooked law enforcement/judicial system. I know that they are both exceptionally talented because of how young and well they performed on stage when they were merely 7 and 8 years old. If my lawsuits work out, we will not be wanting of money and we can build our business together, they can receive tutoring to keep up academically and we can sponsor some incredible events. It is that vision that keeps me going.

Anything. My life is literally an open book.

(20210305 11:45 e.s.t.) I just saw your other two messages from earlier. Cate has social media accounts but Sean's was deleted right after I made it known that I found out about them. And, Cate's was immediately locked. It is currently part of my bail conditions that if I communicate with them directly or indirectly then I am guilty of Failure to Comply, hence another charge. So, no, I will not ask you to do anything.

what is their social media username

(20210305 11:46 e.s.t.) If nothing else, that you now know of how much corruption exists in Ottawa is a good thing. This is happening to other loving mothers too. I met them in jail. In Ottawa, if a mother, say, stabs a father for raping their daughter, the mother will be charged with attempted murder and the daughter is trapped with the father. It is THAT bad. I ratted out a few of the crooked cops yesterday by posting evidence on my site at

(20210305 12:00 e.s.t.) Absolutely. It is my hope that you will. You all need to know that The Ottawa Ticket and The Ottawa Pipeline are VERY real and VERY wicked. Beautiful people (in particular, empathetic people) are being TARGETED in Ottawa for forced prostitution, drug addiction [and/] or The Prison Industry. My site remains under development because I am simultaneously preparing for court (Criminal, Divisional, Civil, Family and Small Claims ... all without a lawyer), plus updating Twitter followers under CaeJak. So, some of the links may be broken. There is a TON on evidence/information on

my Twitter account so if you and whoever else want to follow me there and at [pfi.ROCKS](#) you will be able to see what is happening real-time. That would be awesome if you told people. Raising awareness on corruption to protect our children, youth and teens should in no way be considered indirectly communicating with Sean and Cate by any LEGITIMATE judge (of which, there are some).

It is [REDACTED] but children, youth and teens need to be aware of what is going on in order to protect themselves.

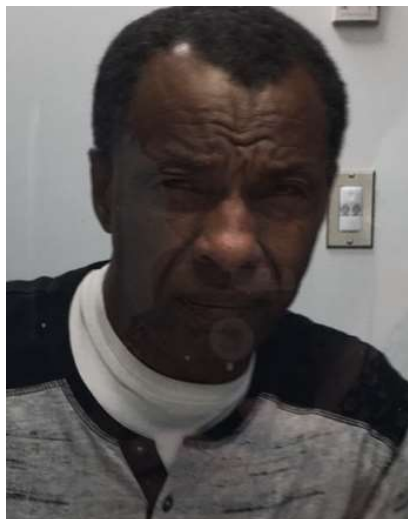
