Good morning Mailback Unit,

Before I appeal my denied appeal for financial support from NL's CSSD, would you please advise me on whatever **further** information you require to evidence the court-enabled fraud which was designed in Ontario to create my "homelessness"?

Attached is my e-mail to O'Shaugnessy House which contains a 7-page memo that details/evidences the form of perpetual domestic violence that I endure, as well as a copy of my 90-day bank statement. As previously explained, the "Children's Expenses"/month that will be claimed by my impossible-to-divorce-ex will **exceed** the below-poverty-level "Spousal Support"/month of \$1,230/month. This will convert me from a "payee" into a "payor" despite having no income. The 2018 "support order" was obtained via fraud and deception, and it was for this reason that I was permitted to de-register from the "mandatory" Ontario program (via the Financial Responsibility Office) in 2020.

50% of children's portion of the mortgage **alone** will be \$500/month. Likely, he will claim **at least** \$2,000/month in expenses; creating a **cumulative liability** of \$770/month for me ... retroactively for the past 5½ years. Accordingly, despite him owing me \$600,000 retroactively (in spousal support and occupational rent on a 5-bedroom, \$1M+ home), he'll be in a position to claim that I owe him \$50,000. It's a brilliant scam: fraudsters aren't idiots ... especially when they're accountants and can afford \$400/hour lawyers (with friends on the bench).

Also, kindly provide to me the contact information for someone with the authority to waive this policy which, in my case, simply exploits the loophole* and assists the fraudster as he:

- deducts spousal support from his taxes owing while, effectively, providing **zero** support,
- circumventing Canada's *Divorce Act* by denying both my legislation-protected right to parent my children as well as receive support of approximately \$7,500/month.

It's fraud. Please don't enable it.

In fact, would you also report this form of fraud to the police so that they become aware of it? I'm fairly certain John Kiska of Ottawa, Ontario has written a how-to manual: "How to Double your Money while Screwing your Wife"—and the loopholes that currently exist within Social Services Canada-wide makes it fairly easy for sadistic exes to get away with it.

*specifically, the loophole whereby SEA enforces **both** portions of the court order whereas the Mailback Unit only acknowledges **half** of it.

Good day,

With regards to your inquiry, please note that Ms. Moore is not entitled to anything at this time. Please advise Ms. Moore that she must register her Spousal Support order with the Support Enforcement Agency (SEA) in order for her Income Support to be properly assessed. As per the Income and Employment Support policy, she must avail of all possible income sources as Income Support is a payer of last resort. The spousal support payments she received from Ontario are considered non-exempt income, therefore, they must be deducted in full, from the existing Income Support Entitlement. In the case of her existing spousal support order for \$1230.00/month, this amount is to be included as income, which exceeds her monthly income support requirements. Based on documentation provided to this department, there are delinquent payments that have not currently been paid to her; therefore, **registration of her order with SEA is required prior to issuing any adjustments to her Income Support entitlement.** As per, Chapter 3: Assessment of Income (ii) Non-Exempt Income (i) Spousal Support Payments, clients are required to register with support enforcement prior to any delinquent payments being replaced or provide proof of registration prior to any adjustments being made. She may contact Support Enforcement Program at (709) 634-4172 for assistance with this process. As well, telephone contact information for legal aid is (709) 722-6981.
