With all due respect, *Detective* Gervais, I have not missed a single instance of reporting to OPS by *not* phoning in between 9-5 each Wednesday. As per attached, for example, I phoned TWICE on October 28, 2020. I phoned twice because I was frustrated leaving voicemails and not a single OPS employee could provide to me ANY information on a better way to "report" since my 20201013 release.

That Mike Boyce participated in the drafting of a Release Order that does not accommodate whatever process your organization follows for "record-keeping" has zero to do with me. Perhaps you should advise the Crown Attorney's Office to be more specific than to draft a Release Order with nothing more than a general number (as per attached) as a reporting condition which simply facilitates *another* potential false breach allegation. While my not-being-guilty has not stopped your organization from arresting, charging and

detaining me in the past, I would appreciate it if you could show some restraint going forward; especially since you are aware, or ought to be aware, of the domestic violence from which I have been attempting to protect my children and me FOR EIGHT YEARS and the upcoming hearings where I am attempting to finally be heard by the Superior Court of Justice without wearing leg irons!

That said, I was finally advised yesterday that Detective Dorion was whom I should contact with any questions, and not you.

Would one of you please advise me as to the specific process that you would like me to follow going forward?
