To whom it may concern,

Our daughter, Deirdre Ann Moore has been married to her husband Jonathan (John) William Kiska since July 2000, and to the best of our knowledge they have had a positive, productive and happy relationship since they met in 1996.

We have 2 wonderful grandchildren named Sean and Cate.

However, dating back to the March/April of 2013, we have had serious concerns about Deirdre's mental health. At this time, she was hospitalized for a period of 6 weeks at the Civic hospital. During this initial episode, we saw firsthand that Deirdre was experiencing a mental health illness. Upon her release, we were discouraged that Deirdre did not want to receive treatment or medication.

After the initial episode, John worked to keep his kids healthy and happy, as well as supporting his wife in every way possible.

Unfortunately, Deirdre had another episode during the summer of 2014. Again we experienced firsthand her erratic and bizarre behavior. During the Canada Day long weekend, the family were visiting us in Morrisburg. When we woke up one morning all the kitchen knives and prescription medicine were removed from the house and that all indication were that Deirdre had taken them.

We then went to the local park for Canada Day activities, at which point Deirdre became agitated and insisted she needed to go home right away. The kids were extremely upset and crying since they had not had a chance to play any games or go on any rides.

Over the next few days, efforts were made to try and get Deirdre to go to the hospital. Eventually she had the police take her to the Civic and was under hospital care for approximately 8 weeks. Again, upon her release she apparently refused to accept any treatment or medicine. She rented an apartment in Gatineau to apparently avoid being under a Community Treatment Order.

Eventually she moved back into the house with John and the kids. And again John worked to keep his kids healthy and happy, as well as his wife.

Sadly, the events of the past few weeks have demonstrated that Deirdre is not well. Deirdre taking the children away over the Thanksgiving weekend resulted in John getting the police involved in their location. Upon her return to the house early Sunday afternoon (October 11, 2015) with the kids, Deirdre subsequently voluntarily admitted herself to the hospital. These events were concerning to us given that she was in care and control of the children in that short timeframe.

We love Deirdre. We love our grandkids. We would like to see the family stay together.

It is our belief that Deirdre has demonstrated the need for productive medical attention and treatment in order for us to feel confident in her ability to provide appropriate level of parental guidance and care. Therefore, we feel that the kids should be under John's full and complete control on an interim and temporary basis.
