November 18th, 2016- File assigned to Telephone Intake worker Brenna Fraser by supervisor Liam Bowen. Direction is to contact her and find out from her what her worries are and what violence she may be experiencing from father.

November 18th, 2016- TMT Deirdre Moore- [REDACTED] - requested that she contact me to discuss information. The voice mail did not indicate who the number belonged to so I did not speak in detail.

November 18th, 2016- TCT Deirdre Moore- [REDACTED] - I explained the call from Dr. Ranjani and asked her to explain what her worries were that she shared with him. She started by saying that her husband has 'literally driven me crazy 4 times in the last 4 years'. She said it took her awhile to figure out there was a pattern but now she realizes he is a 'very strange man' and she can see the pattern starting again. She said typically by this time with the 'sexual, emotional and psychological, abuse she would get delusional and then have full blown psychosis. However, now she is on an anti anxiety medication, limotravine, and it is having a positive impact on her. She said she is able to 'brush him off' in reference to her husband trying to push her buttons. She said her point in speaking to the doctor yesterday was that she feels her husband is trying to 'suck her back in' and she felt that the doctor should know 'in case it goes south' and her mental health gets impacted. Her worries about this started in August.

She admitted that it is 'not wonderful' in her house right now but she doesn't want to divorce as she doesn't want to leave her children and would not want to be a part time parent. She said her husband filed for divorce last fall but they reconciled. She said that her husband is a great father although they have different parenting perspectives on how to raise their daughter (example given was she wants her to be independent and he seems to want to make her dependent).

Example of Psychological abuse was that her husband will hide wedding band when she wasn't wearing it. She didn't confront him. In turn she took his credit card and put it in the same place. This is proof.

Example of sexual abuse- She said that in the past she would 'Fackum' [REDACTED] at the hospital, there was one time where she woke up to her husband sleep out of the house and she has been careful not to drink too much on day weekend after they went to the water park. She said it was 'Fackum' it hit her really hard. She said that night she woke up to her husband 'Fackum' he said she now tries not to be around her husband. She does not engage with him around the home. This has caused some of her to call or text her saying "I demand to know who you are with".

One week ago he asked her if she wanted to get separated and want to get separated and that she was happy. She then told him doctors in the past about her being bipolar which resulted in her he got this help she had nothing to say to him.

She said he will undermines her parenting around the children and be 'condescending' to her around the children. She also said he will do things like go around singing songs such as 'one way or another I'm gonna get you' or 'you can check out but you can never leave'. She feels this is some way to push her buttons. She said that last year she found an article under the couch cushion that was about 'gaslighting' and she feels this may be what her husband is trying to do to her.

She feels the children are not aware that he has assaulted her or aware of the other forms of abuse because she is not engaging back with her husband. She said in the past they would argue back and this would cause a fight which would impact the children. But because she is not engaging she feels they do not know what is happening.

I asked if she felt that CAS intervention would help her family. She said she did not know because she does not want to leave the home and she does not feel that her husband will seek supports (he has only attended support groups for people living with others who have mental illness).

November 18th, 2016- Consult with supervisor Liam Bowman- worker to review all of the above with a VAW supervisor on Monday afternoon.

November 21st, 2016- TMT Deirdre Moore to Ottawa CAS worker Heather Clark (unclear why Mrs. Moore called Mrs. Clark). Deirdre states that 'John was worse over the weekend, following me around the house, not letting her be alone with the children, saying to the children that he had to stay with them for their safety, John was making a mess of the house so she would have to clean up after him, she contacted a lawyer and now wants a divorce, she has an appointment at 3:30 today, she was updating CAS in case John 'starts spreading stories about her as this is what he has done in the past, she welcomed a call back from a worker if there was any questions'.

November 21st, 2016- Consult with supervisor Liam Bowman who consulted with supervisor Wendy White. File to open as a 33H. 53B for assessment and support.
