On Tuesday July 8th 2014 at 1008 hrs. I, Cst T. MERDIAN was dispatched to 1244 Lampman Cres reference to an MHA call.

Information received was that caller John KISKA (1960-09-29, m) wanted to report his wife missing, who is bi-polar and off her medication.

Upon my arrival at the dispatch location at 1020 hrs. I met John KISKA who stated the following:

His wife Deirdre MOORE (1965-09-28, f) suffers from schizophrenia and had just recently been admitted to the Montfort Hospital because of her mental illness. Deirdre's mental illness began to surface appr. 18 months ago and she suffered a major "meltdown" on Canada Day.

32. To my re-collection I did not indicate to the Ottawa Police that Moore was diagnosed with schizophrenia. My only recollection is that an officer from the Ottawa Police indicated that people with schizophrenia will often bury and hide things. This was communicated to me as we were looking for Moore who had locked the house, set the alarm and left the house through an open window. In a panic we went down to the canal to see if there was any evidence of Moore being in the water. We then started to look for my purse (wallet) in which Moore had taken early that morning. It is true that her mental health episode's occurred approximately 18 months prior with her initial hospitalization in March 2013.

Yesterday evening Deirdre locked a storage room in the basement because she was concerned that CAS would take their children away because alcoholic beverages are being stored in this room. When he (KISKA) noticed last night that his purse, containing his wallet, was missing he asked Deirdre whether she had placed it in the locked storage room. Deirdre denied that, however refused to give him the keys for the room.

Deirdre didn't sleep all night just like the two nights before that. their two children, Sean KISKA (8-years old) and Cate KISKA (6-years old) went to day camp this morning and he (KISKA) went to work. When he returned home at appr. 0945 hrs. he found the door of the a.m storage room broken and his purse and empty wallet in another room. A basement window at the rear of the house was open.

J. KISKA advised that he would check the BMO branch on Prince of Wales Dr as he thought that Deirdre might have gone there to withdraw money. At 1052 hrs. J. KISKA flagged down Cst LATOURELL and advised him that staff at the bank indicated to him (KISKA) that Deirdre had been there today, however that they wouldn't provide any more information without police being present.

This avoided her being responsible to take her meds. Deidre hasn't taken her meds in over a year.

In an effort to keep the marriage John did not dispute or take action against Deidre's decision not to follow the Community Treatment Order.

Recently Deidre's behavior has been odd. Today she took all the knives and sharp scissors or razors and locked them in a portable safe.

Deidre has distanced herself from her parents and does not speak to them.

John popped the lock on the safe and found the knives locked away. There was no note included in the lock box.

There is a binder Deidre keeps of her thoughts. In it are some rants or conversations Q&A she has. One is a pretend conversation between her and Lance ARMSTRONG about his wife's mental health.

A Central Unit attended the residence of the Power of Attorney with negative results.

Deidre's parents arrived at the house to support John and also confirm that their daughter has mental health concerns.

39. In previous years, I had watched with earnest the news coverage of the confessions of Lance Armstrong and interview with Oprah; stating often how I couldn't believe what a bold-faced liar he was. *True*

42. In October 2015, I gave the OPS, among other things, a 2-page note that I stated was documentation of Moore's imaginary interview with Lance Armstrong.

42. I have no idea what Moore is referring to by her statement. I provided no comments to the Ottawa Police of that nature.

43. The 2-page note was not the result of Moore's imaginary interview with Lance Armstrong: it was a note she gave to me in September/October 2015 which compared me to Lance Armstrong. *True*

I advised John that Deidre and the children were safe and he should seek legal advice and if he has further concerns about Deidre's mental health he can contact her Dr Judy CHOW and look at options for forming her.

John was very upset by this information and was shocked that she can take the children in this manner. John spoke with Gatineau Police and explained his concerns for her mental health.

I explained to John that he should not attend the hotel, nor should he try and locate her room #.

On June 14, 2015, I DET PARADIS # 1553 reviewed this file as assigned through workflow.

At approx 1925hrs, I contacted the compl --John KISKA, 29 sep 60--. I advised him that I was the lead investigator of this file and my contact info.

41. In October 2015, I informed OPS that Moore had been diagnosed with Schizo-affective disorder.

41. I believe I indicated that Moore was diagnosed with Bi-Polar Affective Disorder, as well as other diagnosis including Schizo-Affective Disorder. These various diagnosis were given by treating psychiatrists from The Ottawa, Montfort and Queensway-Carleton hospitals during Moore's many hospitalizations. In addition, I believe I indicated that during Moore's hospitalizations she indicated both that she did not have a mental illness as well as not being bi-polar.

~~MOORE had voluntary admitted herself to the Civic Hospital on the 12 Oct 15 and he replied that she had indeed attended voluntarily the Civic but after hearing her story, the psychiatrist had formed MOORE. KISKA further added that MOORE had decided to extend her stay at the hospital voluntarily and was now on medication. She as been diagnosed with~~ Schizo-affective disorder ~~but further assessment are needed to confirm the initial diagnostic.~~

I have reviewed file 15-257822 and 15-259469 and obviously MOORE's actions are driven by mental illness. I will now be closing this file as the allegations made by MOORE appear to be unfounded and frivolous in nature.

No further action in this file by this office at this time.
