There have been many instances of emotional, verbal, psychological and sexual abuse. The abuser was the Applicant (Father), Jonathan Kiska, and the victim was the Respondent (Mother) Deirdre Moore. Much of this is hard to prove as there were never any bruises; however, there is evidence of emotional abuse with a series of emails, verbal abuse in the CAS files and psychological abuse in the Mother's medical files. The sexual abuse that was finally reported to the Ottawa Police Services was deemed "frivolous" because they believed Father when he said Mother was schizophrenic, which was ENTIRELY false.

The Respondent can demonstrate that (despite her departure from the matrimonial home) the Applicant's behaviour during these separation proceedings continues to be emotionally, psychologically and financially abusive.
