So then we're in July and August 2013; it appeared that she continued to be on the low side; her mood was low according to her husband; she spent a lot of time in bed; he had to prepare the meals for the kids and that they went on a family vacation trip in Mont Tremblant but apparently she spent a lot of time in bed during that vacation.

In September to October she was not as depressed and became physically a bit more active again, went to the gym and started to work; her work consisted of providing -- she might give obviously more information on that, but she worked on contract; she prepared an article that takes her some -- I don't know how many days every quarterly, I think; and she worked from her office in finance.

During December she went -- it looks like she became a bit depressed again, her husband describes her being flat-lined and nothing. And he works full-time so he had to get the Christmas tree, the decorations and wrap the gifts but apparently she managed to purchase the gifts.

Then in January to February 2014, she became more active again; her energy came back and became more focussed on physical fitness and exercising, a topic or an interest that is always important for Mrs. Moore.


