- 3. Most of the Affidavit submitted/served by

- 4. Kiska's Affidavit para 2 is false.
  - 5. Volume 8 includes (or included as filed) complete.

    TRS as well as NOAS for 2015, 2016 and 2017. (See Vol 8, Tab 1)
    I have included 2017 here again in exhibit A.
  - 6. The reason Tab 8 Vol I was filed is due to fact that Kiskz's lawyer, Wade Smith of Bell Baker LLP, ("Smith") repeatedly stated to the Court that he had never received any of my ITRS when he had.
  - 7. Volume 8, Tab 3 (the Affidavit for this Motion) includes another copy of my 2017 ITR and NOA.
- 0 8. Contrary to Kiskz's Affidevit para 2, 1 included no ITR in my Facture.
  - 9. Kiskz's Alfidarit parz 3 is menningless:

    One quick glance at an Income Tax Return form would tell you that:

     you need to report ALL dividends at line 120

     you need to report the other than eligible!

    dividends at line 180
  - 10. Kiska's Afficiant para 4 is equally meaningless
  - 11. Kiska's own Affidavit exhibit A page of confirms my paras #9 and #10 above

- 12. Kiska's para 5 claims that true copies of his ITRS are filed at exhibit A, B, C but they are inncomplete. No where is the Federal Tax Schedule or the other Schedules that indicate how the dividends were treated.
- 13. Kiskz's para 6? He very clearly stated that his dividends were eligible. As recorded in the transcript, your thonour asked Kiska's lawyer ("Smith") and both clearly stated that the dividends were eligible. They did not state "We are not sure".
- 14. I have already spoken to Kiskz's
  Affidavit para 7: it is utter non-sense.
  (see para 9 above in this Reply)
- 15. There is no evidence of Kiska's Affidavit para 8: it is just another Kiska statement.
- 16. There is no evidence of any "advise" or "review" by anyone named in Kiska's Affidavit para 9. It is just another Kiska statement.
- 17. Kiska's Affidavit para 9 and "supporting exhibits" D and E have no supporting evidence similar to his Application and all of his presentations and submissions to the Court (that have been facilitated by Smith).

- 18. Kiska's Affidavit para 10 is true although I was initially told that I would have to use the FRO to get any support payments.
- 19. Kiska's Affidavit para II is true; however, Kiska need not bring a Motion for me to disclose my medical files: I would easily consent.
- 20. I intend to use my medical files at trial as evidence regarding Criminal Defamation, Defamation, Intentional Infliction of Emotional Suffering, Negligent Infliction of Emotional Suffering, Parental Alienation and other violations of Civil Law and the Criminal Code of Canadar— all damages which Justice Summers has granted permission for me to seek because [my Motion documents] were rife with evidence."
- 21. If Kiska undergoes an extensive psychological assessment (as agreed upon by me) then I will gladly release my medical files on consent.

  There would be no need for a Motion.

27. Kiskz's Affidavit para 15 is not inconsistent with his usual "plea for help".

28. However,

- -I am self-represented because I have no choice.
- The level of Kiska's legal fees are proportionate only to the degree in which he continues to . . . "go for the jugular".
