Hi Leighann.

I met with you on June 13 at 10:30 and we discussed my case at length. At

the time, I wasn't in a position financially to retain you for representation.

Sadly, due to:

- a lack of spousal support,
- my inability to secure employment despite my efforts and
- refusal of my ex-husband to sell the matrimonial home

... I have been forced to list my home for sale. However, this means that I am now in a position to retain you.

I desperately need help. Although many who support me have stated that I have done very well "holding my own", my ex-husband and his lawyer appear to believe that they are above the law (and above the Family Law Rules (that goes without saying)).

As we discussed in June, Justice Summers permitted me to amend my Answer to seek extensive damages for violations of the Family Law Rules, Civil Law and the Criminal Code of Canada. Her Honours decision can be reviewed on <u>CanLii.org</u> under Kiska v. Moore.
