- 1. My name is Deirdre Moore, I live in Ottawa, Ontario (albeit currently homeless due to years of fraud and financial abuse—see **Exhibit A**) and I swear/affirm that the following is true.
- 2. Justice MacEachern's 20200809 endorsement for Gonen Snir's Motion to be removed from Record is not remotely lawful for many reasons including, but not limited to, those detailed in **Exhibit B**.
- Gonen Snir is a con-artist; however, the evidence of such exceeds the 10-page limit placed on this Affidavit as per MacEachern's unlawful 20200809 endorsement.
- 4. Threatened by Justice Tracy Engelking (SCJ) and lawyer Tara MacDougall (CAS) that OPGT would be appointed to deprive Moore of her right to self-represent, Moore retained Snir in November 2019 by signing his exploitative retainer agreement, an excerpt of which is displayed as **Exhibit C**.

5. Following four months of accomplishing nothing, Moore began to ask Snir to accomplish *something* and Snir immediately asked to be removed from Record; thus, triggering his \$60,000 automatic fee (paragraphs 9 and 10 of his retainer

agreement) despite zero useable advice or meaningful representation—he stated "I

think you would do a better job by yourself". (See **Exhibit D**)

6. When Moore refused, Snir began a course of extortion, defamatory libel and

perjury; evidenced by the Motion materials that he unlawfully served and filed on

May 22nd and August 21st (which I am prevented from referencing as they both

exceed the limit 10-page limit established in the illegal 20200809 endorsement).

7. Moore's 20200811 Motion materials to have Snir removed from Record properly

followed the Rules of Civil procedure, at least better than did those of Gonen

Snir; however, Pamela MacEachern rejected them.
