Mr. Douglas! Are you not familiar with your own industry's formal requirements of the Continuing Record under the Family Law Rules ("FLR")? They are published for all to see at https://ontariocourtforms.on.ca/static/media/uploads/courtforms/family/continuing_record/frcr-flr/Formal_Requirements_EN_Nov1406_ODA.pdf!

You also seem to be suggesting that (while the MAG counter staff ignores the *CJA*'s Family Law rules) there is **zero** process regarding accountability or oversight? Is this not an invitation for organized crime to run amok with reckless abandon at significant expense to taxpayers? Seriously, what would prevent 100% infiltration by those interested in theft, fraud and extortion if Ottawa's court services have no accountability or oversight?

Regarding your second point: it is, in fact, <u>a requirement</u> to serve an updated Table of Contents ("TOC") with <u>each</u> Family Court document pursuant to FLR Rule 9 (12) which states that:

"A party serving documents shall,

- (a) if the continuing record has not been separated,
 - (i) serve and file any documents that are not already in the continuing record, and
 - (ii) serve with the documents an updated cumulative table of contents listing the documents being filed; and
- (b) if the continuing record has been separated,
 - (i) serve and file any documents that are not already in the party's separate record, and
 - (ii) serve with the documents an updated cumulative table of contents listing the documents being filed in the party's separate record. O. Reg. 89/04, s. 4.

Again, MAG staff is guilty of violating CCC's s. 126 Disobey a Statute, at a minimum.

Regarding evidence that proves the FC-19-CP-000008 has been tampered with, I literally sent it to you. Here is my copy (again) that references the 20190408-related materials: https://twb.rocks/wp-content/uploads/2023/10/20190808_FC-19-CP08-0_01_Original-CR_Table-of-Contents.pdf. The TOC that you provided excluded these key entries.

With all due respect, you seem like some sort of mis-programmed Artificial Intelligence application that has zero capacity to process real-time information with which it has not been pre-programmed.

Kindly escalate this matter to your supervisor immediately.

This, despite the *CJA*'s Family Law Rules which specify at Rule 17(13.1) the timing of service for Conference Briefs:
 - "The party requesting the conference (or, if the conference is not requested by a party, the applicant or party making the motion) shall serve and file the documents required to be filed for the conference under subrule (13) not later than six days before the date scheduled for the conference and the other party shall do so not later than four days before that date. O. Reg. 202/01, s. 5 (5); O. Reg. 69/15, s. 6 (2); O. Reg. 298/18, s. 12 (2); O. Reg. 535/18, s. 5 (3)." (see https://www.canlii.org/en/on/laws/regu/o-reg-114-99/latest/o-reg-114-99.html#sec17subsec13)* and
- the date of the documents used to illegally** grant sole custody and access of my children to my wickedly abusive husband: 20190408. Yes, my husband's Affidavit was sworn on 20190408 and it was filed on 20190408 (see Attachment #3). In fact, all of my husband's accomplices' documents were not filed until 20190408. When was the hearing? 20190408. This, despite the rules regarding service and filing of Affidavits and other court documents. I asked for an adjournment as I had not received any materials nor had the opportunity to respond. Crooked SCJ judge Calum MacLeod:
 - denied my request (see my request in the 20190408 transcript (Attachment #4) at the bottom of page 14 and MacLeod's denial in his endorsement (see Attachment #5))
