Dear Dr. Thomas Quatroche,

re: ECMCC's Zone 5-2's Incompetence, Negligence and Criminality

I was detained in Zone 5-2 of your facility from Thursday, March 22, 2025 to Wednesday, April 30, 2025 and the experience was horrific. I did everything I could to seek assistance: there was none anywhere to be found. Below is a chronological summary of events that refers to *28 exhibits* including typed copies of my previous correspondence to you at Exhibit AB. I would like to meet with you as soon as possible to discuss, among other things, that which I have uncovered and evidenced regarding Erie County Medical Center Corporation ("ECMCC") Zone 5-2's incompetence, negligence and criminality.

Chronological Summary of Events:

- 1. On 20250313, I returned to Buffalo, New York to:
 - a. collect some research for a follow-up article on the disgusting reality that is the vaping industry: see 2019 article at https://twb.rocks/upig/media and
 - b. glean interest from Americans for my upcoming "twb.ROCKS Investigative Journalism!" contest: see announcement at https://twb.rocks/upig/contest/announcement.
- 2. On 20250320, following a week of continued delays and persecution from my home province of Ontario (see partial whistle-blowing details at https://twb.rocks/archives/y2025/m202503), I thought it would be wise for me to obtain a U.S. version of my *unfilled*, Canadian prescription for a CNS-depressant. Accordingly, I approached the Buffalo General Medical Center; however, they stated that they had no capacity to assist me and *must* detain me in order to effect a transfer

- elsewhere. By midnight, I was transferred to ECMCC at 462 Grider Street (and forced to endure its C.P.E.P. unit for over 41 hours).
- 3. On 20250322, I was transferred to ECMCC's Zone 5-2 by approximately 17:00.
- 4. On **20250324**, at approximately 11:59, a woman named Brenna Fox ("Fox") approached me to discuss my reasons for being at ECMCC. However, as:
 - a. lunch had just been served,
 - b. we were in a crowded dining room (inappropriate for such a personal discussion) and
 - c. Fox admitted that "[she] had not yet reviewed [my] chart",

our meeting was adjourned on consent.

Then, Fox drafted her Treatment Over Objection Evaluation ("TOOE", see Exhibit A) 22 hours prior to our *first* clinical interview.

- 5. On **20250325**, at approximately 10:53, Fox and I met for just over half an hour: she in no way indicated that she had already produced a TOOE and merely stated that "[I] had given [her] a lot to think about". (As she revealed that she was from Alberta, Canada, in addition to describing my whistleblowing and investigative journalism initiatives, I discussed with Fox some of the plans being announced by:
 - a. Klaus Schwab's World Economic Forum and
 - b. Policy Horizons Canada (see https://twb.rocks/policy-horizons and Exhibit B). By 16:18, Fox and some psychiatrist named Michael T. Guppenberger had signed a 7-page Behavioral Health Treatment Plan ("Plan") laden with such a severed degree of error, omission and malicious obfuscation ("EO&MO") that one can only conclude I was not their first or only target. Their Plan is included as Exhibit C and my EO&MO Analysis of their Plan is included at Exhibit D and published at https://twb.rocks/blank-00/living/safety/ecmcc/thomas-quatroche.
- 6. Somewhere between **20250325-27**, ECMCC "Risk Analyst" Martha Mumbach ("Mumbach") issued a petition so that "Treatment Over Objection" could be court ordered (see *undated* documents labelled "Petition" and "Verification" at Exhibit E).

- 7. On **20250326**, without ever meeting me, Zone 5-2's psychiatrists Michael T. Guppenberger ("Guppenberger") and Yogesh D. Bakhai ("Bakhai") signed the Affirmations that were used to obtain a court order enabling ECMCC's without-fully-informed-consent, involuntary drugging of me with known toxins (see Exhibits F and G, respectively).
- 8. On **20250328**, a Zone 5-2 Nurse Nicole served on me:
 - a. Mumbach's Petition and Verification,
 - b. ECMCC's lawyer's (that is, Magavern Magavern Grimm LLP ("MMG")) 20250327 Notice of Petition and Affirmation of Service (see Exhibit H) and
 - c. Guppenberger's and Bakhai's Affirmations.

Fox's 20250328 TOOE and Bakhai's 20250327 Chart Update (see Exhibit I) were *excluded* from the materials served on me. When I asked Fox where the missing documents were, she stated "you can start with those".

- 9. On Saturday **20250329**, Nurse Nicole served on me the final two documents of ECMCC's court submissionⁱ: Fox's 20250324 TOOE and Bakhai's 20250427 Chart Update noted at para. 8 above: court was scheduled to occur on 20250402 and I had *zero* access to any legislation, case law/resources or any of *my* confiscated documents/evidence.
- 10. On **20250329** I attempted to comprehend the combined risk profiles of ECMCC's proposed drug combinations by contacting Internal Pharmacy (see letter at Exhibit J): they asked me not to contact them again.
- 11. I immediately wrote the outline for #twbROCKS #Article "Psychiatric Drug Cocktails: is fully-informed consent even possible?" (see copy of original at Exhibit K).
- 12. On **20250401**, Guppenberger breezed into my room for about 60 seconds. He wanted to know if I had any questions about court; but, he refused to address any of my prepared questions listed at https://twb.rocks/wp-content/uploads/2025/05/20250401-12-Questions-for-ECMCC-Michael-Guppenberger.pdf and included as Exhibit L.

- 13. On **20250402**, Given only 10 minutes to defend myself and with *zero* ability to serve or file documents, Paula L. Feroleto ("Feroleto") chose to order the forced [drugging] of me based only on Fox's, Bakhai's and Guppenberger's unsubstantiated libel and Guppenberger's baseless, incourt slander. This, despite my reasonable request for an adjournment and a key witness: see Erie County Supreme Court ("ECSC") order and my 2-page agenda for court at https://twb.rocks/wp-content/uploads/2025/05/Moore-v.-ECMC-Court-Submissions-28.001-28.002.pdf and included as Exhibit M.
- 14. On **20250404**, I attempted to comprehend Fox's position/motivations; however, she ended our meeting before I could complete the interview. Then, I attempted to confirm her brief answers by handing to her a one-page letter, the list of questions (ie. my 20250404 Agenda) and my record of her initial answers. Despite my efforts (see Exhibit N), Fox refused to provide any meaningful response.
- 15. On **20250409**, I attended court *again* and Guppenberger lied, *again*. Also, MMG claimed that they had not received my Court Submissions #1-#3 even though I had a fax confirmation of a successful transmission (see Court Submissions Table of Contents at Exhibit O and fax confirmations at Exhibit P).
 - Despite my stated grounds for a conditional adjournment (see Exhibit Q), ECSC's Raymond W. Walter ("Walter") reserved his decision and, *inappropriately*, handed to me his business card.
- 16. On **20250410**, Walter ordered the continuation of my illegal detention (and drugging): see ECSC court order at https://twb.rocks/wp-content/uploads/2025/05/Moore-v.-ECMC-Court-Submissions-43.001-43.002.pdf included here as Exhibit R.
- 17. On **20250414**, unbeknownst to me, a Canada-wide warrant was issued for my arrestⁱⁱ (see e-mail from the court included as Exhibit S).
- 18. <u>Fact</u>: As denials by the court et al. of key witnesses and third-party records rendered its ability to reach a "beyond-a-reasonable-doubt" decision of guilt on *any* of the Crown'sⁱⁱⁱ breach allegations ascjak@outlook.com

- technically *impossible*, I should have been acquitted; now, however, I fear for my safety due to the risk of being apprehended and forced to endure an in-custody trial without access to *any* of my evidence.
- 19. On **20250421** Fox committed extortion by handing me a note that read: "[agree to ingesting lithium and you can be discharged]" (see copy of her note (marked-up) at Exhibit T). I was experiencing zero symptoms of psychosis, mania nor depression, however, I was forced to combine toxin haloperidol *with* toxin lithium while:
 - a. having zero means to research the new, heightened, risk profile of this unwarranted, unordered drug cocktail and
 - b. being able to dance circles^{iv} around Zone 5-2 staff intellectually, mentally, spiritually and, likely, physically.
- 20. On **20250422**, desperate to be relieved of the mental and physical torture that is ECMCC's Zone 5-2, I consented to ingesting both the lithium and the haloperidol under duress. When Fox received my consent, she stated:

"[in addition to being psychotic and bi-polar, you are a narcissist with a Cluster B personality disorder]".

As I wrote to you in my letter of that same day, "your Nurse Practitioner [Brenna Fox] is criminally insane, Mr. Quatroche".

21. **By 20250423**:

- a. the forced dosage of haloperidol had increased to 10 mg and
- b. my ECMCC hospital bill had reached \$86,269.39 (according to the ECMCC Billing Department).
- 22. On **20250424**, I was finally permitted to pay for my expired whistle-blowing/advocacy site www.twb.ROCKS; albeit, with a "redemption/late fee" of \$75USD/\$108.75 CAD (see Exhibit U).

- 23. On **20250425**, I wrote my 10th letter to you entitled "Petty Cash, Petitions and Processes" (see page 10 of Exhibit Y)
- 24. On **20250428**, I submitted a *scathing* 38-page package to Buffalo's Mental Hygiene Legal Services' David Lim in order to prepare for an appeal (see Fax Cover Sheet, Cover letter and Fax Confirmation at Exhibit V).
- 25. On **20250429**, ECMCC responded to my 20250425 letter with a 20250428 generic "To whom it may concern" letter signed by so-called Social Worker Marsha Reed, an individual previously complicit in *preventing* me from paying my bills (see Exhibit W).
- 26. On 20250429, an individual for whom I neglected to record the name:
 - a. approached me in my room,
 - b. accepted a copy of my scathing 38-page package noted at para. 24 above,
 - c. stated that they would forward it to "ECMCC legal" and
 - d. thanked me.
- 27. The **following day**, on **202501430** by 10:30, Fox had signed the discharge forms and the discharge planner announced that I would be leaving shortly: I was transported to the Gennsee Street "homeless" shelter by taxi at ~16:00 ... *without* the short-term prescription for a CNS-depressant (prn) that I sought 20250320.
- 28. On **20250501**, I contacted lawyer Lauren Konarowski and Ottawa's Crown Attorney's Office regarding my missed court appearance (see Exhibit X).
- 29. By **20250502**, I had finished scanning the hundreds of pages of testimony and evidence amassed against ECMCC's Zone 5-2 and began to make plans to return to Ontario.
- 30. On **20250503**, I was temporarily detained by Canada Border Patrol Services because of the Canada-wide warrant issued for my arrest (as noted at para. 17).
- 31. By **20250518**, despite significant effort (see evidence published at https://twb.rocks/domestic-terrorism/perpetrators/entities/ontario-court-of-justice/canada-wide-warrant), I have been unable to have the warrant terminated/vacated/rescinded and have been forced to live like a fugitive.

Dr. Quatroche, I wrote to you *ten* times and provided *at least* 40 enclosures that evidenced the incompetence, negligence and criminality of ECMCC's Zone 5-2:

- a. on 20250406 with a letter entitled "[Systematized Plausible Deniability]" (with **10** enclosures),
- b. on 20250408 with a letter entitled "Beyond a Reasonable Doubt" (with 5 enclosures),
- c. on 20250409 with a letter entitled "Grandiose Allegations" (with 7 enclosures),
- d. on 20250410 with a letter entitled "Lawyers and Judges, Accountants (oh my!)" (with 7 enclosures),
- e. on 20250414 with a letter entitled "MH ECHKO Audit Results" (with 4 enclosures),
- f. on 20250416 with a letter entitled "Financial Gain—the second requirement ... human trafficking" (with 3 enclosures),
- g. on 20250417 with a letter entitled "Financial Losses, Site Down & "Fence is High" (with 3 enclosures),
- h. on 20250421 with a letter entitled "Fox's Ludicrous Discharge Plan",
- i. on 20250422 with a letter entitled "Fox's new threat re: lithium or no discharge" (with 3 enclosures) and
- j. on 20250425 with a letter entitled "Petty Cash, Petitions and Processes" regarding:
 - i. a refund of my \$75USD "redemption/late fee" and
 - ii. the responsibility for payment of what would be a \$100,000USD+ hospital bill caused solely by the incompetence, negligence and criminality of those associated with ECMCC's Zone 5-2.

As clearly expressed multiple times, your Zone 5-2 has:

- zero legitimate oversight and
- *zero* accountability.

It is for this reason that it has been infiltrated by conscience-free sociopaths who literally could not care less about the safety or well-being of their patients. In addition, the actions and inactions of ECMCC's Zone 5-2 equate to, at a minimum, insurance company fraud.

Though the consequences of ECMCC's six weeks of incompetence, negligence and criminality continue to have a *severe* impact on me, I felt it was important to inform you, again, of the problem: I was *not* their only target and I have been made aware that their targeting of healthy individuals has continued since my departure. Accordingly, in addition to a refund of my \$75USD redemption/late fee, I am

- payment of my existing ECMCC bill (\$104,389 less "self-pay discount" = \$19,299; see Exhibit
 by your organization,
- 2. <u>compensation</u> for my six-week investigation^v of your Zone 5-2 and the resulting, undeniable evidence produced for your use,
- 3. <u>termination</u> (at a minimum), with cause, of the following ECMCC-positioned individuals:
 - a. Nurse Practitioner Brenna Fox,
 - b. psychiatrist Dr. Michael T. Guppenberger and
 - c. psychiatrist Dr. Yogesh D. Bakhai,
- 4. <u>retention</u> of consulting services (via my company SAQOTU Inc.) in order to assess:
 - a. the competency of your Zone 5-2 nursing staff,
 - b. the competency of your C.P.E.P. psychiatric staff,
 - c. the competency of individuals being considered to replace Bakhai, Guppenberger and Fox; and,
 - d. the effectiveness of the Occupational Therapy, Recreational Therapy and/or any other programs offered to ECMCC's so-called "Behavioral Health" patients; and,
- 5. <u>provision</u> of information to your Mayor, Governor and President of the likely participation of both Feroleto and Walter (and Magavern Magavern Grimm LLP) in Medicaid Fraud.

At a minimum, ECMCC's "Behavioral Hygiene" services are a class action waiting to happen, Dr. Quatroche: I am confident that I can assist you to implement change immediately in order to reduce the likelihood of such a potentially donation-crippling event.
