Ms. Brenna Fox,

re: Records vs. Reality & Files vs. Facts

The number of "interviews" we have had since my 20250322 arrival at ECMCC's Zone 5-2 equals two:

- a) on 20250325 from 10:53 to 11:30, your interview began by asking me "Have you ever been hospitalized?" and ended with you stating "Returning your clothes should be no problem" and "You've given me a lot to think about".
- b) on 20250404 from ~10:15 to 10:40, I interviewed you. I requested the meeting and prepared the enclosed agenda.

During the 20250404 interview, you claimed that I did not give you any chance to reply and claimed that my interview notes were deficient. (Conducting an interview without being able to record prevents detailed note-taking.) Furthermore, your refusal to answer questions — and merely attempt to re-direct me to less important issues — began at section C: Combined-Drugging Risk Profiles. You actually attempted to claim that your proposal did not combine any drugs.

Brenna, I can read. Your proposed drug combinations are listed in:

- a) your scandalous 20250324¹ "Treatment Over Objection Evaluation" ("TOOE") contained in ECMCC's 20250327 court submission (see CS1 10.001) and
- b) Paula Feroleto's scandalous² 20250402 decision at page 2. (See CS3)
