## Good day,

I have been attempting to amend an illegally-obtained, fraudulent support order (see enclosure #1 below) for over five years; however, the Applicant (John Kiska, "Kiska") has successfully utilized accomplices positioned throughout Ottawa's legal-judicial system to avoid this event and, in fact, our entire divorce. Despite all protections from domestic violence codified in Canada's *Divorce Act*, Kiska continues to financially and psychologically abuse me and my 100% gaslit children. This fact is evidenced throughout my whistleblowing/advocacy site including new page "My Urgent Motion" (see <a href="https://twb.rocks/domestic-terrorism/perpetrators/individuals/john-kiska/fc-15-2446/2025-urgent-motion">https://twb.rocks/domestic-terrorism/perpetrators/individuals/john-kiska/fc-15-2446/2025-urgent-motion</a>) which will evidence the many ways in which Canada's federal *Divorce Act* has been circumvented via multiple *provincial-legislation* avoidance techniques.

The most recent order for FC-15-2446 was from Pamela MacEachern (see enclosure #2 below): despite the illegal and unlawful nature of the entire event (and the outcome), it remains the most recent order on file. Given there were previously *three* settlement conferences (and an illegally-avoided trial date following his false allegation of criminal harassment which led to arrest, detention and multiple illegal, unlawful court orders which rewarded Kiska for his crimes of Conspiracy to Prosecute, Defamatory Libel, Public Mischief, Mischief, etc.), what is the process for scheduling this next hearing?

I have now been attempting to divorce fraudster Kiska for longer than we were married: his ability to successfully use Ottawa's legal-judicial system to "beggar" our children's *only* protective parent (ie. me) reveals the true criminal nature of the capital of Canada's so-called "justice" system and its preoccupation with ensuring a stream of "broken children" for its various "industries" remains intact.
