I confirm receipt of your 20250617 1710 e-mail. Thank you for the additional evidence against the RCMP's pathological liar Matt Peggs who, in his 20250617 materials, neglected to mention his office's <u>return call</u> to me on 20230713 (see link to A/V recording with partial testimony at <a href="https://twb.rocks/domestic-terrorism/perpetrators/individuals/matt-peggs">https://twb.rocks/domestic-terrorism/perpetrators/individuals/matt-peggs</a>). Unbeknownst to Peggs, in 2022 I was provided with his name and number by an <u>undercover RCMP Officer</u> who claimed Peggs was dirty and not to be trusted by anyone.
