Ms. Konarowski,

To avoid any miscommunication, kindly respond to my preliminary questions in written form:

1. **When** was my trial cut from three days to one day and **why** wasn't I informed of this major change during the 20250616 "Trial Readiness" hearing when my request for an adjournment was denied?
2. **When** were the charges **increased** from one to three?
3. **Why** was my trial cut from three days to one day?
4. **Why** were the charges increased from one to three, when the Crown already dropped four out of the five bogus 20231216 charges?
5. **When** will my pre-trial Applications be heard?
6. **When** will Matt Peggs' pre-trial Application be heard?
7. **How long** will I have to refute Peggs' Application and will I have access to internet-enabled A/V equipment to do so?
8. **At what point** in the trial will I be cross-examining OPSB Sovan Try?
9. **Which** of my witnesses will be present so I can examine them?
10. **For how long** am I permitted to examine/cross-examine each witness?
11. **How long** do I have to present my four-tiered defence?
12. **How** will I present my mountain of evidence to the court when I am only in a position to store it digitally? Will I have access to a computer, WiFi and "projector"/large screen so I can present my audio-visual evidence?
