FOREWORD

Are We Still Waiting for the "Great" or "Seven-Year" Tribulation?

The majority of Christians today are awaiting the second coming of Jesus. While some await a rapture, others anticipate a significant seven-year tribulation period. This is due to the interpretation of the prophecy found in Daniel 9:24-27. Many consider it as a roadmap leading to the second coming of Christ. This prophecy is viewed as yet to be fulfilled, with believers eagerly awaiting the fulfillment of these events in the return of our Savior.

But what if these events already took place, and the scriptures themselves reveal that to us?

Daniel's Messianic Prophecy

In the midst of the Babylonian exile, Daniel, a devout servant of God, fervently prayed, understanding that the prophesied seventy years of captivity were nearing completion. Daniel sought God's mercy and guidance as the appointed time for the restoration of Jerusalem and the return of the Israelites to their land approached.

After his prayer, Gabriel, a divine messenger of God, shared with Daniel important knowledge regarding the restoration of the temple of Jerusalem, up until the establishment of the Messianic Kingdom. He explains that it will be seventy "weeks" from the decree to restore and rebuild Jerusalem, to the establishment of the Messianic Kingdom.

Daniel 9:24 - 490 Years Until the Establishment of Righteousness

"Seventy weeks are decreed for your people and your holy city to finish transgression, to put an end to sin, to atone for wickedness, to bring in everlasting righteousness, to seal up vision and prophecy and to anoint the Most Holy Place."

"Seventy weeks are decreed for your people and your holy city" Daniel's prayer was related to the seventy years of his peoples' Babylonian captivity. Gabriel responded by speaking of *seventy* weeks. Therefore, he was speaking of seventy years of weeks. That would be 490 years: 70 years x 7 = 490 years.

"To finish the transgression, to put an end to sin, to atone for wickedness, to bring in everlasting righteousness" These phrases express the ultimate goals of the prophecy, including the resolution of sin and the establishment of righteousness through divine intervention.

"To seal both vision and prophet and to anoint a most holy place" The Hebrew words used here for "most holy place" are "qodesh qodashim", which literally translates to "holy of holies" or "most holy." Israel's temple played a central role in their worship. Israel was a nation that God entered a covenant with to produce the Messiah, and when they fulfilled their legal obligation of obedience, they benefited from His guidance, protection, and His presence. God's presence was in the inner sanctuary, the holiest part of the temple, the "Holy of Holies".

Therefore, when the establishment of the Messianic Kingdom was to take place on earth (Revelation 21:2), it's where the new "Most Holy Place", or "Holy of Holies" would naturally be located. But rather limited to a small nation, this time it will be at the center of all of righteous humanity.

Gabriel then goes on to explains what is to take place within those 70 years.

Daniel 9:25 - Messiah's Death and the Rebuilding of Jerusalem

"Know and understand this: From the time the word goes out to restore and rebuild Jerusalem until Messiah the Prince, there will be seven 'weeks,' and sixty-two 'weeks.' It will be rebuilt with streets and a trench, but in times of trouble."

"From the going forth of the word to restore and rebuild Jerusalem" This marks the starting point of the prophecy, which historically corresponds to the decree issued by King Cyrus of Persia allowing the Jews to rebuild Jerusalem. (Nehemiah 2:1-8)

"Until Messiah the Prince there shall be seven 'weeks' and sixty-two 'weeks'" This timeframe represents a total 483 years, from the decree to rebuild Jerusalem until the Messiah. This does not include the last "week", or seven years.

"The street shall be built again, and the wall, even in troublous times" This refers to the rebuilding of Jerusalem's infrastructure, which would occur under difficult circumstances during the restoration period.

Daniel 9:26 - Messiah's Death & Tribulation

"After the sixty-two 'weeks,' the Messiah will be put to death and will have nothing. The people of the prince who is to come will destroy the city and the sanctuary. And its end will come like a flood: War will continue until the end, and desolations have been decreed."

"After the sixty-two 'weeks,' the Anointed One will be put to death and will have nothing" After the rebuilding of Jerusalem, there would be sixty-two 'weeks' or 434 years until the Messiah's death. He will have nothing, in the sense that he was yet to establish his rule over the earth.

"The people of the ruler who will come will destroy the city and the sanctuary." This is referring to the city of Jerusalem where the temple was located. The

sanctuary was the innermost chamber of the temple, known as the Holy of Holies. This was the most sacred space where the Ark of the Covenant was kept, as well as the dwelling place of God's presence among his people, as mentioned above. Access to the Holy of Holies was highly restricted and reserved for specific rituals performed by the high priest on behalf of the people.

By the time of Jesus, Satan had managed to gain control of the majority of the world's governing (and likely religious) elements. That is why Jesus refers to him as the ruler, or prince, of this world in John 12:31; John 14:30 and John 16:11. As such, Satan is the one who has the city and the sanctuary destroyed, signifying the end of God's presence and rule, and the establishment of his own. In biblical times, it was common for conquering kings to overthrow the kingdoms they defeated and destroy or subjugate their cities. The destruction of the city and sanctuary likely signified a takeover and the establishment of an inverted form of Godly worship.

"And its end will come like a flood: War will continue until the end, and desolations have been decreed." The Hebrew word for "end" used in this verse is "qetz". This word suggests a decisive conclusion or termination, akin to the overwhelming force of a flood that brings destruction. This verse is telling us of the termination or downfall of the ruler's authority or rulership. However, until that end comes, wars and great devastation is prophesied to happen as a result of the people of the ruler.

Daniel 9:27 - Seven Years Until Desolation of Satan's Rule

"And he will confirm a covenant with the many for one week, but in the middle of the one week he will put a stop to sacrifice and grain offering; and on the wing of abominations will come the one who makes desolate, until a complete destruction, one that is decreed, is poured out on the one who makes desolate." "And he will confirm a covenant with the many for one 'week" Linguistically, in Daniel 9:27, it appears that the covenant is made by "he" (the ruler) with "many" (the people). This suggests a direct association between the ruler's actions and both the covenant-making and the ceasing of religious practices. In mimicking God's practice of establishing covenants with his people in the past, Satan also establishes a covenant with the people. He does so for the entire duration of the final seven years, for the purpose of fulfilling Satan's will.

"but in the middle of the one 'week' he will put a stop to sacrifice and grain offering" As these events commence at the death of the Messiah, it is at the middle of the remaining 'week' that the ruler will destroy the city and the sanctuary, the center of worship for God's people. The destruction of Jerusalem took place shortly after the death of Jesus, 3.5 years later. This would coincide with the understanding that, once Jesus was appointed King in the heavens, war would have broken out in heaven. Satan was then hurled down to earth, with great rage, knowing his time was short. (Rev 12:7-12)

History has told us that Jerusalem was destroyed well after the death of Jesus. According to whom? Particularly the historical records of the Jewish historian Flavius Josephus in his work "The Jewish War." According to Josephus and other historical sources, the Roman army, led by Titus, besieged and ultimately captured Jerusalem in 70 AD, resulting in the destruction of the city and its holy Temple. It is claimed that historical evidence, along with archaeological findings, supports the understanding that Jerusalem suffered a devastating destruction in 70 AD.

However, the following threads will prove that this history was completely falsified to hide the fact that the Messianic Kingdom was established seven years after the death of the Messiah. In doing so, he defeated Satan's attempt to establish his rule on earth. Would that not be the first part of history that Satan would want erased as soon as his rule, this time an uninterrupted one, took place in the short season?

"on the wing of abominations will come the one who makes desolate, until a complete destruction, one that is decreed, is poured out on the one who makes desolate." In biblical prophecy, particularly in the book of Daniel, "abominations" often refer to acts or practices that are offensive to God. "On the wing" could imply the swift or sudden arrival of these abominations, suggesting a rapid and overwhelming onslaught of evil or corruption.

This corresponds with the warnings of Jesus when he makes reference to Daniel 9:27 in the New Testament while warning his disciples of the upcoming great tribulation. Jesus speaks of the "abomination of desolation" "standing" in the holy place in Matthew 24:15, Mark 13:14, and Luke 21:20. The term "standing" implies a presence or manifestation of something unholy within the temple precincts - the ruler's attempt to establish himself as divine and the supreme authority.

Even so, Gabriel ensures that the ruler does not rule for long. Satan's rulership is short-lived, destined to end in complete destruction. This final defeat occurred when Jesus, in a decisive victory, defeated Satan and his forces in a climactic battle, banishing Satan into the abyss.

The Church Age

It is a common belief that there is an interruption that took place between the 69 "weeks" and 1 "week". This is commonly referred to as the "church age"; the period of time many believe we are in today. This interpretation is based on passages such as Matthew 16:18, where Jesus tells Peter, "And I tell you, you are Peter, and on this rock, I will build my church, and the gates of hell shall not prevail against it." Additionally, the letters written to the churches in the New Testament, particularly in the book of Revelation, are seen as addressing issues relevant to the church age. The idea of the church age is that it emphasizes the role of the church in spreading the message of salvation and preparing believers for the return of Christ.

It is important to note when examining the Greek of Matthew 16:18, the word "church" is translated from the Greek word "ekklēsia". This word means a

gathering of people, or an assembly of people. These are the ones that Peter was asked to take care of, who Jesus referred to as his "little sheep". In John 21:15-17, Jesus asks Peter three times if he loves him, and each time Peter responds affirmatively. After each affirmation, Jesus instructs Peter to "feed my lambs," "take care of my sheep," and "feed my sheep," symbolizing Peter's role as a shepherd and leader among Christ's followers. Here Jesus is emphasizing the importance of protecting and caring for his followers. Why is this important? Because of the period of tribulation they would be facing shortly after Jesus' death – Peter was to be the rock of the people, caring for them through the most tumultuous time in history.

Is the idea of the tribulation taking place at that time supported by scripture?

The Statue of Daniel

The statue in the book of Daniel, found in Daniel 2:31-45, is a vision given to the Babylonian king Nebuchadnezzar. In this vision, Nebuchadnezzar sees a towering statue made of different materials, each representing a successive world empire. Here's a breakdown of the components of the statue and their symbolic meaning:

Head of Gold: This represents the Babylonian Empire, specifically Nebuchadnezzar's reign, which was known for its wealth, power, and grandeur.

Chest and Arms of Silver: This represents the succeeding empire, historically interpreted as the Medo-Persian Empire, which conquered Babylon and ruled over a vast territory.

Belly and Thighs of Bronze: This represents the next empire, often understood as the Greek Empire under Alexander the Great and his successors. The Greeks were known for their military prowess and expansion.

Legs of Iron: These symbolize the fourth empire, commonly identified as the Roman Empire. The iron legs represent the strength and durability of Rome's

military might and political dominance.

Feet of Iron and Clay: The final part of the statue, the feet and toes made of a mixture of iron and clay, symbolize a divided kingdom or a period of fragmentation and weakness.

By the days of Jesus, the final part of the statue — feet of iron and clay — was already being realized. The Roman Empire was already in decline, with scriptural evidence to support that claim.

Rome: Already in Decline

There are several pieces of evidence from the New Testament that suggest Rome was already in a state of decline during Jesus' time. These factors help us see that Rome's influence and control over its territories during Jesus' ministry were not as firm and centralized as it was in earlier periods of the empire:

Rome's Allowance of Self-Governance:

Rome granted a significant degree of autonomy to local authorities, including religious leaders and regional governments. For example, the Jewish Sanhedrin had considerable authority in matters of Jewish law and governance, including the ability to administer justice



within the Jewish community (Matthew 26:57-68, John 18:12-14).

Herod's Rule: Herod the Great, who ruled over Judea during Jesus' birth, was appointed by Rome, exercising substantial authority over the region. However, Herod's rule was marked by instability and cruelty. This suggests a weakening grip of Roman authority likely due to challenges to Roman control and difficulties in maintaining order within the territories under Roman governance. (Matthew 2:1-23).

Pilate's Governance: Pontius Pilate, the Roman governor of Judea during Jesus' death, demonstrated a degree of reluctance to assert Roman authority in local religious matters. He deferred to the Jewish leaders and crowd pressure in the trial of Jesus, indicating a lack of firm control over local affairs (Matthew 27:11-26, John 18:28-40).

Political Fragmentation: The Roman Empire was characterized by internal political divisions and power struggles. This fragmentation weakened centralized control and contributed to instability within the empire (Luke 2:1-3).

Destruction of the Statue

Daniel 2:44,45 tells us what happens to the statue: "In the time of those kings, the God of heaven will set up a kingdom that will never be destroyed, nor will it be left to another people. It will crush all those kingdoms and bring them to an end, but it will itself endure forever. This is the meaning of the vision of the rock cut out of a mountain, but not by human hands—a rock that broke the iron, the bronze, the clay, the silver and the gold to pieces." It is in the days of the Kingdoms of the statue that God puts an end to the rule of all other kingdoms. God's Kingdom will never be passed down to another person, as it was never intended for us to be governed by humans. Rather, authority is given to the son of man, as shown in Daniel chapter 7.

Proceeding the anointing of the son of man, Daniel chapter 7 describes Daniel's dream of four beasts. These beasts correspond to the statue in Daniel chapter 2,

as well as the establishment of God's Kingdom, including when it is established.

The Beasts of Daniel

In the book of Daniel, the beasts symbolize successive world empires and their rulers, each with its own characteristics and significance. These beasts, or world empires, correspond with the world empires of the statue in Daniel chapter 2. In Daniel 7:7,8 Rome is depicted as a terrifying and dreadful beast having iron teeth and ten horns. The ten horns likely symbolize divisions or rulers within the empire – the clay and the iron.

In Daniel 7:9-14 it speaks of the destruction of the beasts due to divine judgment. This is followed by the "son of man coming with the clouds of heaven". (for a better understanding of the significance of the title "son of man" please see the post "Jesus' Role in Dominion" here.) In Daniel 7:14, the "son of man" is given "authority, glory and sovereign power; all nations and peoples of every language worshiped him. His dominion is an everlasting dominion that will not pass away, and his kingdom is one that will never be destroyed." The establishment of the Messianic Kingdom takes place after the destruction of the last beast—Rome. This takes place during its declining stage, the time of the iron and clay mixture of the statue - which was already taking place in Jesus' day. This also aligns with the beast of Revelation chapter 13 described as having a "fatal wound" on its head symbolizing the period of decline of the Roman Empire. It only regained its resurgence due to the authority given to it by the "dragon" during its short time of rulership during the great tribulation, only to be brought to its end by Jesus.

The Short Season of Satan

Therefore, we can see that the period of time we are living in is not the Church Age. Jesus established his Kingdom one "week", or seven years, after his death. The following threads will examine the evidence that proves that Jesus did, in fact, establish his Kingdom here on earth during that time, and the evidence that proves that we have been living in the short season of deception under Satan.






Hierarchy of Needs




HIERARCHY OF NEEDS




Historical Architecture and Remaining Antiquities









Intriguing Commonalities Among Antiquities




Unraveling Clues: Advanced Societies Behind Ancient Architectural Marvels

The Erosion of Design and Craftsmanship




Approximately 200,000 children were relocated all over the world including Europe, America, Russia, Australia & Canada.




Urbanization and the Decline of Community

Consider: would Tartaria be in harmony with our Creator's original purpose for humanity to cultivate and expand the park-like setting they were placed in?


How did He react when the people of Nimrod's time deviated from His decree, constructing grand cities?

- 1. Examination of the original Hebrew/Greek/Aramaic texts of various Biblical scriptures. There will be discussion on scriptures that support the idea of a restored world under the rule of Christ through his Kingdom and how it would be interrupted for a 'short season' of deception under Satan the era in which we are currently living.
- 2. Our Creator embodies two fundamental qualities: love and logic. Therefore, truth, originating from our God, embodies these qualities. Having been made in the image of our Creator, the originator of light and truth, we possess light within us and the innate ability to detect truth, provided we do not allow outside programming to override our original makeup.

Jesus Prepared the People for Difficult Times Ahead

When considering the audience to whom Jesus directed his message, we see that, out of his love and compassion, he prepared the people for events that would occur in the near future. He made it clear that they were going to face difficult times ahead.

Jesus' use of language, including terms like "soon" or "at hand," within his teachings was linguistically appropriate for conveying a sense of urgency. The choice of these words would reasonably imply to his audience – those to whom he directed his words — that very trying times, a great tribulation, was expected to occur in the near future, a time of great severity and intensity that had never occurred before in human history, and would never occur again.

The following scriptures help us understand how Jesus prepared his disciples for the events that they were going to experience:

Matthew 24:3-14, Mark 13:5-13, and Luke 21:8-19: Jesus discusses the signs marking the end of the 'age' (Greek 'aiōn'), which includes various indicators such as wars, famines, earthquakes, persecution, false prophets, lawlessness, and the spread of the good news of God's Kingdom. It's noteworthy that the Greek word 'aiōn' signifies a particular era or period, rather than denoting the physical world. Therefore, Jesus was not referring to the end of our world.

Luke 10:18: Jesus, using a linguistic style common in his time to express certainty about future events, vividly describes witnessing Satan's swift fall from heaven as a symbol of his defeat and expulsion from authority.

John 16:33: Jesus uses language that emphasizes the certainty of future events. He consoles his disciples by acknowledging the trials they will face but encourages them to focus on his victory over the world, assuring them of the ultimate triumph that will be experienced through him.

When Did The Kingdom of God Arrive?

Jesus made clear that the end of the age and the arrival of God's Kingdom would take place during their lifetime:

Matthew 24:34, Mark 13:30, Luke 21:32: Jesus is addressing his disciples and talking about the signs of the end times or the culmination of a particular era. The phrase "this generation" (Greek genea) refers to the people living at that time - that generation living during Jesus' time or within that historical period. Jesus assures them that certain events he mentioned would occur within the lifetime of those present, without the passing away of that generation before those events take place.

Matthew 5:37: Jesus said, "Simply let your 'Yes' be 'Yes,' and your 'No,' 'No'; anything beyond this comes from the evil one." In this passage, Jesus is emphasizing the importance of honesty, integrity, and straightforwardness in communication. He encourages people to be truthful and reliable in their speech, letting their words be trustworthy without the need for oaths or elaborate assurances. This teaching promotes sincerity and reliability in one's words and actions. So would not Jesus be going against his own council by giving the wrong impression and being unclear?

Jesus repeatedly told his audience that the kingdom of God was coming very soon:

Mark 1:15 "The time has come... the kingdom of God is at hand (Greek engizō)."

Matthew 3:2 "Repent, for the kingdom of heaven is at hand (Greek engizō)."

Matthew 4:17 "Repent, for the kingdom of heaven is at hand (Greek engizō)."

Matthew 10:7 "The kingdom of heaven is at hand (Greek engizō)."

The Greek word used here, "engizo", implies the sense of being close or at hand. Jesus used this language to emphasize that the Kingdom of God was not a distant or far-off reality.

So consider: where would the love or logic lie in Jesus using language that led the audience to believe he was coming soon, preparing them for an imminent event, only to discuss an event that actually takes place well into the future? Why would he suggest that the generation present would witness the end of that age, despite that not occurring?

An Earthly Restoration?

The events discussed above likely occurred after Satan was expelled from heaven,

culminating in an epic war that resulted in Satan's defeat. Revelation 20 speaks of the events that follow after Satan's defeat and removal, paving the way for the restoration of creation. This supports Jesus' words regarding the future:

Matthew 5:5: "Blessed are the meek, for they will inherit the earth (Greek 'ge' meaning land, ground, etc.)."

Matthew 19:28: Jesus promises his apostles that in the regeneration of the world they will sit on their thrones alongside him. This specific verse occurs within a conversation between Jesus and his apostles, where Peter questions Jesus about the disciples' future rewards for leaving everything to follow him.

The Greek word 'palingenesia', translated into 'regeneration', is at times interpreted as 'new world'. 'Palingenesia' conveys the meaning of renewal, rebirth, or a fresh start - not the replacement of something.

The belief in a physical restoration of all creation is not uncommon in earlier times. This idea is evident in Job 33:24-28, where an account portrays someone being helped by God, experiencing not only spiritual renewal but also a physical rejuvenation, with their flesh becoming fresher than a child's. The Hebrew word 'basar' is used, meaning 'flesh', 'skin', 'body', or that which comprises all living things.

Additional scriptural evidence confirming the concept of Earthly restoration:

Isaiah 11:6-9 describes a future time when no harm would be brought on anyone, and the knowledge of YHWH would be complete on a worldwide scale.

Isaiah 65:17-25 foretells a new (Hebrew "hadas") heavens and a new (Hebrew "hadas") earth where former troubles are forgotten. It speaks of joy, longevity, abundance, and safety, where people build houses and enjoy the fruit of their labor, with no harm or destruction. The Hebrew root word for "hadas" can be translated 'repair' or 'renew' in addition to 'new'.

Isaiah 35:5, 6, 10 portrays a transformed earth where the eyes of the blind are opened, the ears of the deaf unstopped, the lame leap like deer, and the mute shout for joy. It speaks of a highway of holiness where there is everlasting joy and gladness, and sorrow and sighing flee away.

Revelation 21:1-5 envisions a new heaven and a new earth where God dwells among His people. It describes the absence of death, mourning, crying, and pain, and God making all things new, (Greek "kainos"). This Greek word "kainos" means newness in quality, representing something that is fresh, renewed, or qualitatively different rather than merely chronologically new.

Isaiah 65:25: "The wolf and the lamb shall graze together; the lion shall eat straw like the ox, and dust shall be the serpent's food. They shall not hurt or destroy in all my holy mountain, says YHWH."

Isaiah 33:24: "And no inhabitant will say, 'I am sick'; the people who dwell there will be forgiven their sins."

Revelation 22:3: "No longer will there be anything accursed, but the throne of God and of the Lamb will be in New Jerusalem and his servants will worship him."

Micah 4:3,4: "He shall judge between many people, and shall settle disputes for strong nations far and wide; and they shall beat their swords into plowshares, and their spears into pruning hooks; nation shall not lift up sword against nation, neither shall they learn war anymore. But they shall sit every man under his vine and under his fig tree, and no one shall make them afraid, for the mouth of YHWH of armies has spoken."

Jeremiah 31:34: "And no longer shall each one teach his neighbor and each his brother, saying, 'Know YHWH,' for they shall all know me, from the least of them to the greatest, declares YHWH. For I will forgive their iniquity, and I will remember their sin no more."

The collective scriptures vividly depict a future of restoration and renewal on Earth under God's Kingdom. These verses envision a transformed world, where there is no more suffering, but rather unity, peace, and spiritual enlightenment, reaching its intended state — reflecting God's ultimate purpose for an Earth restored to harmony.

What Would Jesus' Millennial Reign Have Been Like?

Life under Jesus' Millennial Reign would be the very manifestation of God's qualities of love and logic:

- After enduring intense suffering due to Satan's great rage and deception, humanity likely suffered mentally, emotionally, and physically. In response, Jesus displayed love and care, healing the people (Revelation 22:2) just as a loving parent closely embraces an injured child, providing solace and nurturing support to restore them to a state of well-being a reflection of God's even greater love for humanity.
- Balance would have been restored, reinstating the divine feminine state of the woman and the divine masculine state of the man. Their equally powerful roles were restored, roles that have been heavily distorted since the first human pair lost their harmonious, balanced state with God, nature, and themselves (Genesis 3).
- Jesus returned in the time period he promised, during the generation he addressed, the generation that would not pass away before the end of that age (Matthew 24:34, Mark 13:30, Luke 21:32). He established God's Kingdom on earth, as was God's will, which he made clear was not of this world (John 18:36) a new government called New Jerusalem. (In Jesus' day Jerusalem was the focal point for Jewish worship and governance.)
- **Revelation 21:2:** The Holy City, New Jerusalem, comes down out of heaven, physically located on the earth with Jesus now dwelling among the people.

- Jesus' Kingdom was possibly located in the center of the level plane earth, what has been referred to as Hyperborea, meaning "Beyond the North Wind", or the "land of a thousand names", a geographical area called different names by various religions, such as Agarta/Agartha, Garden of Eden, Shambhala. If the measurements of Jerusalem were not symbolic, Hyperborea of older maps shows land mass that would have fit the measurements of New Jerusalem (Revelation 21:15-17). Either way, would it not make the most sense for God to locate His Kingdom at the center of Earth?
- Revelation 22:14: Only those who seeked purity and followed God's ways were able to access the waters of life, much like the first human pair who were only able to access the tree of life as long as they did not break their covenant with God (YHWH). Those who partook of the life-giving waters would have been fully restored to their intended state and would not have experience sickness, old age, or death.
- Revelation 22:15: There would exist those who chose to defy God's ways (as all have free will to choose their own course). However, their influence would have been greatly limited in Jesus' Kingdom of truth, light, abundance, and empowerment. It would have stifled any growth of evil, especially without Satan's influence.
- Isaiah 65:17-25: Humanity would have gained knowledge and skills that would have empowered them with everything they needed to reach their fullest potential, living the highest standard of living possible that which is fitting for divine creation.
- Isaiah 11:9: It is likely that what we refer to as a belief system today was simply a way of life based on known truths rather than most religions today that put heavy emphasis on dogma or indoctrination, a way of thinking rather than a way of living.

Humanity would have grown and expanded under God's Kingdom, as God originally purposed, filling the earth with generations that never experience life under the influence of evil. This Kingdom of God would never be brought to ruin (Danial 2:44).

However, for a short period of time, or a "short season", the Devil (a title meaning "slanderer" or "false accuser") would be released into the world for a short time, resulting in worldwide deception under Satan (Revelation 20).

Erasing History: A Worldwide Reset






True to his sociopathic tendencies, Satan would likely have projected all the



Poverty Laws: In the 19th century, our controllers enacted laws like the Poor Law Amendment Act of 1834 which created economic challenges and extreme biases towards unwed and widowed mothers. This would include any woman who did not have a husband to provide for the family's needs, whether it was because he was incarcerated or committed to a mental institution. It had a broad impact on vulnerable women, compelling them to forfeit their children in order to qualify for welfare. The welfare system provided work to women through workhouses which did not allow them to continue care for their children. The workhouse experience for women was characterized by hard labor, harsh living conditions, strict compliance to rigid rules, and a loss of personal freedom.


Similar laws and implications were widespread in Western countries, including Europe and North America. In the United States, poor laws and workhouses existed in various states, more commonly referred to as poorhouses or almshouses.

Orphanages, Workhouses & Baby Farms: In the 19th century, orphanages experienced a surge, becoming widespread not only in Britain but also across the world. Hundreds of thousands were placed in orphanages and workhouses, despite many having at least one living parent.


The 19th century also saw the exploitation of vulnerable mothers through the practice of "Baby farming". Individuals would take in infants for a fee, no questions asked, ostensibly to care for them. However, it was a cover for the trafficking or sale of infants, with children advertised for adoption or taken in by individuals for profit-driven purposes. Living conditions were dire, and infant mortality rates were high.

Children were also sent to workhouses. The ages of children in workhouses varied, but it was not uncommon for there to be children as young as five or six. They were assigned labor jobs that likely belonged to men lost in wars, were imprisoned, or committed to mental institutions.

Despite their significant roles, these orphans received limited education, leaving them uninformed about their true history. The lack of historical awareness contributed to their susceptibility to manipulation, fostering a generation conditioned to accept whatever distorted version of history our controllers deemed suitable.

Admitting they were wrong would threaten this carefully crafted ego, leading them to resist any information that challenges their perceived exceptionalism.

Self-Serving Bias: Self-serving bias is the tendency to attribute positive events to one's own character but attribute negative events to external factors. The resistant individuals may apply this bias by interpreting any loss on their part as a positive outcome, reinforcing their belief that they are making the right choices for the greater good. An illustrative example is individuals who stand by their decision to take the Covid-19 vaccine, despite serious side effects, believing they made the right choice for 'the greater good' and refusing to acknowledge the potential harm.

Cultural Cognition and Paradigm Preservation: People with a fixed mindset often interpret information in a way that aligns with their existing beliefs and values, a concept known as cultural cognition. The resistant individuals have built paradigms that serve their self-interests, and they selectively interpret or dismiss information that contradicts these paradigms. This contributes to cognitive dissonance. New or conflicting information causes psychological discomfort, leading to its rejection due to clashes with their constructed paradigms.

In-Group Bias and Groupthink: The resistant individuals may exhibit in-group bias, favoring their own group and disregarding the concerns or perspectives of those outside their ideological circle. Groupthink, a phenomenon where individuals prioritize harmony and conformity over critical thinking, can further solidify their collective commitment to the false narrative.

Crisis of Meaning: Admitting to the deception and facing the consequences could create a crisis of meaning for the resistant individuals. They have derived a sense of purpose and identity from their false narrative, and acknowledging the truth might leave them grappling with existential questions and a loss of direction.

Moral Licensing: Moral licensing is the phenomenon where individuals allow themselves to engage in immoral behavior after previously engaging in moral behavior. In this case, the resistant individuals might justify following orders,

including participating in harmful actions, by pointing to their perceived moral superiority due to their past adherence to the false narrative.

Thus, their choices and actions become not only a reflection of the external deception but also a manifestation of deeply ingrained psychological defense mechanisms and distorted perceptions of self and morality.

And likely many, without ever realizing, they align themselves with Satan—exactly what is fitting of the term "Gog and Magog".

But what tactics may Satan use to deceive his large army to go up to battle?

Satan's Desperate Bid for Control

Satan embodies the quintessential sociopath, marked by a mindset focused on self-preservation and a strategic pursuit of control. His choice to take such extreme actions, risking the wrath of our Creator, suggests a profound belief that his grip on control or influence is irreversibly slipping away. Opting for such a drastic move that puts him in harm's way would only result from an impending loss of power. This highlights a desperate attempt to retain control—a characteristic trait of sociopaths, where maintaining dominance overrides the fear of personal destruction.

As a master manipulator losing control of the narrative, it is highly likely he will exploit the truths exposing the evils of his establishment, working to twist it to his advantage. Utilizing a favorite tactic of sociopaths, he may project these exposed evils onto a manufactured scapegoat—malevolent 'alien beings' that 'brainwashed' our leaders and others into committing such atrocities.

The Deceptive Role of Extraterrestrials

Ronald Reagan, on multiple occasions, suggested that facing a common threat from beyond Earth could unite people across nations.

We cannot say this is a new concept. Many of us understand how entertainment has served as poorly disguised propaganda over the decades. The idea of malevolent alien beings influencing or brainwashing humanity, including leaders, is a recurring theme in science fiction narratives. Decades of science fiction movies have often portrayed aliens as potential threats or enemies, showcasing various scenarios where humans must unite against extraterrestrial forces.

There are already rumblings of events attributed to extraterrestrial beings. The purpose of the alien deception may likely be to:

- 1. Act as a cover to unite humanity against a common enemy "responsible" for the evil atrocities recently exposed, and
- 2. Place 'the beloved city' and 'the camp of the saints' as humanity's extraterrestrial threat location, deceiving the world into uniting together to annihilate its perceived common enemy.

We are likely to witness sightings of various beings, with the government covering it up in a poorly orchestrated yet purposeful manner to capture public interest. Subsequently, whistleblowers and government documentation may emerge, supposedly proving the existence of extraterrestrial life. Once it attains undeniable recognition, our world leaders might be compelled to address the perceived crisis — a scenario manufactured to execute the 'problem-reaction-solution' strategy. This involves manipulating a situation, controlling the narrative or response, and offering a solution aligned with their agenda or goals. To maximize impact, they will likely employ tactics that instigate fear, confusion, and chaos on a worldwide scale.

It is also possible that Satan presents himself as humanity's savior—whether as Jesus, a benevolent alien being, Allah (Islam), Kalki (Hinduism), Maitreya (Buddhism), or all of the above. He would make it seem as though a highly anticipated religious figure or humanity's savior has arrived to rescue humanity from evil.

Either way, Project Blue Beam will likely play a significant role in advancing his illusory narrative. He may also introduce so-called 'aliens,' gene-spliced creations resulting from diabolical experimentation at places like Area 51. It is also likely that the technology developed and tested for decades (think UFOs/UAPs) will be used, all of which is based on the technological achievements from Jesus' reign. The purpose? To instill fear and act as evidence to convince the populace to come together to defeat their common enemy—an enemy they will likely identify as being located where 'the beloved city' and 'the camp of the saints' just so happens to be.

The Purpose of the Uncountable Army

Revelation 20:9 tells us the purpose of this uncountable army. They will come from the 'breadths of the earth,' to wage war against 'the camp of the Saints' and the 'beloved city.' But what is the "beloved city"?

The Beloved City

The phrase "beloved city" in Revelation 20:9 in the original Greek translates directly to "the city, the beloved" or "the city, the loved one" in English, signifying a city that is dearly loved or cherished.

It is important to note that the book of Revelation is organized around specific themes or topics rather than a strict chronological order. The chapter following Revelation 20 may help us shed light on what this beloved city is. In Revelation 21, New Jerusalem is described as a city coming down from heaven, adorned as a bride for her husband, and where God dwells with His people. The characteristics and descriptions provided in Revelation 21 strongly align with the term "beloved city" mentioned earlier in Revelation 20:9.

Why is it Called New Jerusalem?

In Jesus' day, Jerusalem was the focal point for Israelite worship and governance. Considering the audience for whom the book of Revelation was written, they would have understood the meaning of "New Jerusalem"—the holy city that would govern both the physical and spiritual aspects of our realm. In Revelation 21:2, this holy city, New Jerusalem, came down out of heaven after Jesus' battle with Satan, resulting in Satan's banishment. This means New Jerusalem, the beloved city, was physically located on Earth, with Jesus dwelling among the people, as promised.

This includes all those who have been bought from the earth for the specific role of serving as rulers and priests, reigning on Earth (Revelation 5:9-10). These are separate from the "camp of the saints" as discussed in Revelation 20:9. Why?

"Kings" is translated from the Greek word "basileian," which pertains to rulership, kingship, or kingdom.

"Priests" is translated from the Greek word "hiereis," which refers to priests or those who perform religious duties or rituals.

These individuals make up part of the beloved city; therefore, the "camp of the saints" refers to another group.

The Camp of the Saints

In Revelation 20:9-10 the word "camp" is used to describe the area or space where God's people are situated and surrounded.

The Greek word used in Revelation 20:9 for "camp" is "parembolē", which can refer to a temporary dwelling or encampment.

The term "saints" is the Greek word "hagion". It is derived from "hagios", meaning

"holy," "sacred," or "set apart." To capture the essence of the Greek word while staying truest to its meaning, an English phrase like "the consecrated ones" or "the set-apart ones" might be the closest equivalent. These phrases embody the idea of being specially dedicated, sanctified, or separated for a specific purpose, which aligns with the essence of the Greek term "hagiōn".

Would these not be the individuals that had "separated" themselves from those that were deceived by Satan? Have they not proved themselves "holy" or "set apart" in their actions of not falling for Satan's deception? Is it not logical that these individuals would have joined Jesus in his banishment? It would be fitting that these ones would be located where Jesus' Kingdom is situated.

Also, the term "camp" is fitting for their current situation, as they are temporarily dwelling around Jesus' beloved city waiting for the completion of the short season.

Where Is the 'Beloved City' and the 'Camp of the Saints' Located?

Jesus' Kingdom was likely situated in the center of the level plane earth. Certain early maps depict a physical location called Hyperborea. In Greek mythology, Hyperborea, meaning "Beyond the North Wind," was situated in the far north and represented a place of divine favor, spiritual purity, abundance, and prosperity, where inhabitants enjoyed long or even immortal lives.

Various cultures reference a land in the far north. Norse Mythology speaks of a realm located in the far north, associated with gods and divine beings. The oral traditions of the Indigenous peoples of the Arctic discuss sacred or spiritually significant lands and places of plenty. European "Medieval" maps and writings use the term "Ultima Thule," a Latin phrase translating to "farthest Thule" or "beyond Thule." Thule, in this context, refers to a distant, mysterious place.

Siberian and Central Asian Folklore mention a mythical kingdom sharing similarities with Hyperborea, often associated with spiritual enlightenment and

sometimes located in the north. This mysterious paradise, Shambhala, is referred to as the "land of a thousand names" due to being labeled with so many names.

This geographical region in the far north is also likely where the Garden of Eden was situated. It would be a logical area as the first human pair were commanded to fill the earth, allowing for the expansion of humanity from a central location. Would it not make the most sense for God to locate His kingdom at the center of earth as well? Would these not be important truths the heliocentric model immediately hides as it teaches a globe earth with no center?

However, our maps currently don't show anything there. Google Earth doesn't even display ice at the North Pole—absolutely nothing. Whether New Jerusalem is there and we cannot see it, or it's underwater, or will rematerialize, we can only speculate. But scripturally, we know that humanity will become aware of it and be deceived into warring against it.

The Final Battle

As Satan deceives an innumerable multitude into battle, these individuals will come from "the breadth of the earth" to oppose Jesus' governmental system (the beloved city) and those who resisted Satan's deception at the beginning of the short season (the camp of the saints).

However, their misguided allegiance to ego-centric paradigms leads them down a destructive path. As soon as they surround the Holy City and the camp of the "saints," or set-apart ones, Revelation 20:9 vividly describes God's decisive response: "fire came down from God out of heaven and devoured them."

In this moment, those who embraced the qualities of Satan's evil system face the consequence of their choices. God dispatches fire from heaven not as an aggressive action but as a protective measure, eliminating the threat they pose to the sanctity of His Kingdom. This divine intervention underscores the justice of

defending the beloved city and its inhabitants from the destructive intentions of those who actively sought to bring harm.

The narrative then swiftly shifts to the judgment of Satan himself (Rev 20:10). He is held accountable for deceiving the people into warring against Jesus' governmental system, sealing his ultimate fate of eternal destruction. Thus, the conclusive events in Revelation 20 echo the assurance that God's Kingdom prevails unscathed, and those ensnared by ego-centric paradigms face the inevitable consequences of their rebellion in the context of divine justice and defense.

PART 5 - LIFE AFTER THE SHORT SEASON

When humanity uses its free will and sovereignty to stand up against Satan, they will put into motion a set of events that ultimately lead to Satan's destruction. Once the deception of humanity has permanently ended, humanity will resume under the rule of God's Kingdom.

Many who claim to follow Jesus preach that they must repent now so to avoid destruction. However, that is not reflected in the book of Revelation.

Must Everyone Accept Jesus Before He Comes?

To understand the love of our Creator, we need to consider God's qualities reflective in us as parents. Let's say you had your children taken from you and placed under the care of a cunning family member who instigated the entire ordeal. Because of your concern for your children, you had some letters sent to them to help and comfort them as you worked to gain back custody. Your children receive the letters, but no one can agree on whether they are from you or not. Some accept them all without question, others believe they have been doctored, while still, others completely reject them as fraudulent. Consequently, some follow the advice in the letters, some follow parts, and others reject them entirely.

You are aware of the dire situation your children have been put in, one that will cause them to endure cruel mistreatment that results in physical and emotional wounds. Once you gain back custody, and the moment you lay eyes on them, what would be your immediate reaction? Would it be to pass judgment immediately, rewarding only those who followed your word and punishing or even condemning those who didn't? By no means! The moment they are within arm's reach, you would embrace your children tightly, wiping away their tears, yearning to alleviate every ounce of pain and suffering they endured. And yet, this love is only a reflection of the love our God has for us.

That is why in Revelation 22:2 God uses the leaves of the trees of life as a healing for the people. Just as a loving parent understands that their children have been bruised and battered, traumatized, lost and confused, so does our Creator. He keenly senses the profound impact this era of deception has left on us, more intimately than anyone else could fathom.

That is why the healing will take place on every level—emotionally, mentally, physically, and spiritually—bringing us back to the state God intended. Then, with this clean slate, each individual will be given the opportunity to regain life and be a part of God's Kingdom, if they so choose. But how could God offer this to everyone, even those that practiced "wrongdoing" or "sin"?

We Are Products of Our Environment

Most people don't often contemplate the factors that shape individuals. Unbeknownst to the majority, we are heavily influenced by our environment. Many in this world haven't experienced an environment that fosters their growth as intended by God.

The majority grows up in the bottom two tiers of the Hierarchy of Human Needs, where survival takes precedence, hindering the development of crucial qualities like love—a fundamental element in human development. This, coupled with limited access to nutrition, directly impacts health and development. We're also cognizant of the repercussions of vaccines and other prevalent chemicals in our food, water, clothes, and the air. These directly affect brain development and hormonal balance, influencing cognitive function, emotional well-being, and long-term mental health.

For instance, those attracted to the same sex often experience improper or imbalanced hormones due to various environmental factors. In the past, hormonal imbalances were corrected with natural medicines, but conventional medicine today often overlooks and leaves these imbalances untreated. Additionally, trauma, such as sexual or physical abuse, and early-age

programming glorifying same-sex relationships, including social favoritism towards these ones, can influence someone's sexual orientation.

Given these considerations, does it not appear reasonable that our Creator, possessing a profound understanding of our makeup and the destructive impact of manipulation and deception, would extend an invitation to all?

Who Will Not Gain Life?

This does not imply that God will accept all and any practices under His Kingdom rule.

In our severed state, we are considered "dead" in the eyes of God (Rev 20:12), much like a cut flower. However, He offers the opportunity to gain life, a state where we are reconnected to God and have access to the fruit of the tree of life (as the first human pair relied on for life - Gen 2:9). Our healing will lead to a clean slate, free from any trauma, restored back to how we are meant to be. This means we are completely accountable and without the influence of evil. With complete access to God and truth, we cannot blame anyone other than ourselves for our future decisions.

Revelation 21:27 emphasizes that "nothing impure will ever enter [the Kingdom], nor will anyone who does what is shameful or deceitful; only those whose names are written in the Lamb's book of life." Additionally, Revelation 22:14,15 distinguishes between those who follow God's way, granting them the "right to the tree of life" and access through the city gates, and those outside the city—termed 'dogs'—who engage in sorcery, sexual immorality, murder, idolatry, and the practice of lies. This makes it clear that there are individuals who will not want to be a part of Jesus' Kingdom and, therefore, will not gain access to life.

An Invitation Extended to All

This invitation isn't limited to the living. Revelation 20:13 reveals that, once Satan is destroyed, "The sea gave up the dead who were in it, and Death and Hades delivered up the dead who were in them. And they were judged, each one according to his works." This means all those who have died will be given the same opportunity as those who made it through the short season.

This concept aligns with the anticipation expressed by Job. He firmly believed that God longed to bring him back into a renewed and restored life, as reflected in his hopeful statement in Job 14:15: "If someone dies, will they live again? All the days of my hard service I will wait for my renewal to come. You will call and I will answer you; you will long for the creature your hands have made." However, as sovereign beings, our access to life will hinge on our 'erga' (Greek word), which translates to 'works' or 'tasks' (Rev 20:13). 'Erga' refers to actions, deeds, or labors that individuals perform or tasks that need to be accomplished.

Therefore, whether we are considered worthy of life under God's judgment will depend on how we make use of our fresh start.

Does not this arrangement reflect God's respect for our free will, while also embodying his harmonious qualities of love and logic? Has not our Creator dignified us as sovereign beings, with the opportunity to decide our own fate?

It's important to note, however, that life under Jesus will not be a utopian state as often conveyed in movies or other forms of entertainment. There will always be challenges, but the difference is we will have all the knowledge, skills, and resources available to overcome these challenges. We will learn to live in harmony with God's creation, including each other, where we will once again realize a world where peace and harmony not only prevail but flourish—a world that aligns seamlessly with our Creator's divine purpose for humanity.
