## CELESTIAL EVENTS SIGNALING THE END OF SATAN'S RULE?

### INTRODUCTION

## **The Purpose of Satan's Short Season**

Why was Satan allowed a period of time of uninterrupted rule? The answer lies in the role of dominion, how we were created, and our God-given autonomy.

### *Humanity's Rejection of God's Dominion*

Humanity was created in the image of God as rulers, with the purpose of having dominion, or rulership, over this earth. (Genesis 1:26-28) With that, we were given sovereignty and free will. (Genesis 2:16-17) It was our choice whether we would accept God's authority, or dominion, over us. The first human pair, who had entered a legal contract with God in accepting his dominion (Hosea 6:7), chose to reject God's dominion over them, opting for independence instead.

God recognizes and respects human autonomy. Therefore, he stepped aside, relinquishing his dominion over humanity as a whole, allowing them to individually choose for themselves what is right or wrong and who they wanted as their "god".

We could say, in a sense, that the throne of dominion over humanity was now vacant. After the first human pair asserted their independence, individuals and entire nations alike began to determine for themselves whom they would worship or acknowledge as their god. This is why God presented his covenant to the nation of Israel. He offered them prosperity, protection and spiritual guidance if they would remain loyal to him, recognizing his authority as their God. They accepted, thus becoming the nation that would produce the Messiah/Christ.

There were individuals throughout history outside of Israel that chose our Creator as their God. We have the example of Job (Book of Job), Melchizedek (Genesis 14:18-20), and Naaman (2 Kings 5:1-19) among others. However, by the time Jesus arrived, he made it clear that Satan was the "prince of the world", having deceived

the vast majority of the world into giving him their worship. During the period of time leading up to Jesus' Millennial Reign, God was very active in his involvement with humanity. He communicated with various individuals, and sent angels that could even materialize into human form. He answered prayers, gave dreams and even performed miracles to demonstrate his power and presence in the lives of people.

### *Jesus' Dominion & His Millennial Reign*

When Jesus came back, he battled against Satan for dominion over this earth, and victoriously won the battle. He threw Satan in the abyss for a thousand years, established his Kingdom on earth, and his dominion was accepted by humanity. He likely followed God's example of establishing a covenant with the people, which they accepted. He was then given a thousand years to prove himself as the rightful ruler over humanity. Why a thousand years? It is a logical timeframe within which Jesus' qualifications as a ruler can be proven, and the durability of his Kingdom can be tested over time.

### *Satan's Dominion*

Upon his release, Satan managed to deceive the entire world. He deceived them into rejecting Jesus' rulership, and into accepting him.

Just as Jesus received a period of uninterrupted rule, Satan would also have been granted a time free from intervention by God and His son. But what would uninterrupted rule actually entail? While Satan would have to work within the parameters of God's Natural Law, just as Jesus did, God and Jesus do not directly intervene in human affairs as before. Rather, individuals that desire God's intervention or involvement on a personal level, have the right to do so as sovereign beings. On an individual basis, their involvement and influence may still occur, but in a more subtle or indirect way.

But why was Satan only given a "short season"?

Luke 8:17 states, "For there is nothing hidden that will not be disclosed, and nothing concealed that will not be known or brought out into the open." Satan, likely aware of this principle, would not desire a longer period of time for the purpose of maintaining his deception, as it would increase the risk of his schemes being uncovered. Instead, a shorter period would allow him to perpetuate his deception without as much risk of exposure.

Today gives evidence of that. The more Satan pushes humanity into slavery and giving up their sovereignty, the more people realize something isn't right and start to wake up. The more you take away from someone, the more they will retaliate. This is reflective of God's laws of nature. Our Creator designed the natural world with built-in mechanisms that maintain balance and order, even in the face of disruptions or disturbances. In reflection of our God, humans are also like natural systems, having the ability to recognize and address problems in order to maintain stability and functionality.

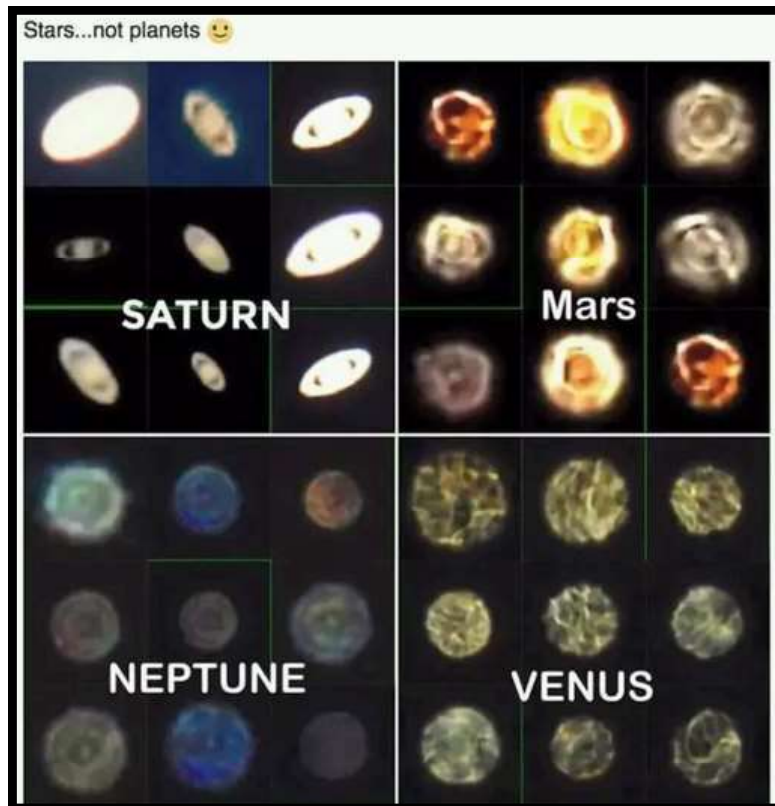
### **Has the Short Season Ended?**

We can be certain that this short season under Satan has been constructed to keep us deceived and ignorant to truths Satan doesn't want revealed to us. It is also likely that if there was an event to take place that indicated the end of Satan's period of rule, we would be kept blind to it. What would he use to do so?

### *The Heliocentric Model*

The Heliocentric model has been used to cover up the fact that we live on a level plane within a dome (the firmament), that our earth has a center, as well as this level plane's significance in relation to Jesus' Kingdom. It also falsifies the wandering stars of our celestial dome by teaching that they are planets existing in a solar system millions of miles away. ## *Religion*

Religion in this short season has been designed to act as a form of control, while also blinding us to the truth of our period of time. Most Christian denominations believe we are still waiting for the coming of Jesus, and teach complacency to evil by ensuring they patiently ‘wait on their Savior’. Many believe that our hope is in heaven, and that Jesus’ coming is spiritual or symbolic. Non-Christian religions often do not recognize a Creator of all things, the role of Jesus, or the existence of Satan, and therefore are unaware of the time period we live in.

Some Christian denominations teach that the second coming already took place, but claim it was only in a spiritual/symbolic sense. Others teach we are in the time period of the Wild Beast, the Mark of the Beast, and approaching the Great Tribulation, while our controllers purposefully making it appear as if we are living in that time period. Religion also has blinded us to the power we were created to have and the purpose we were created with.

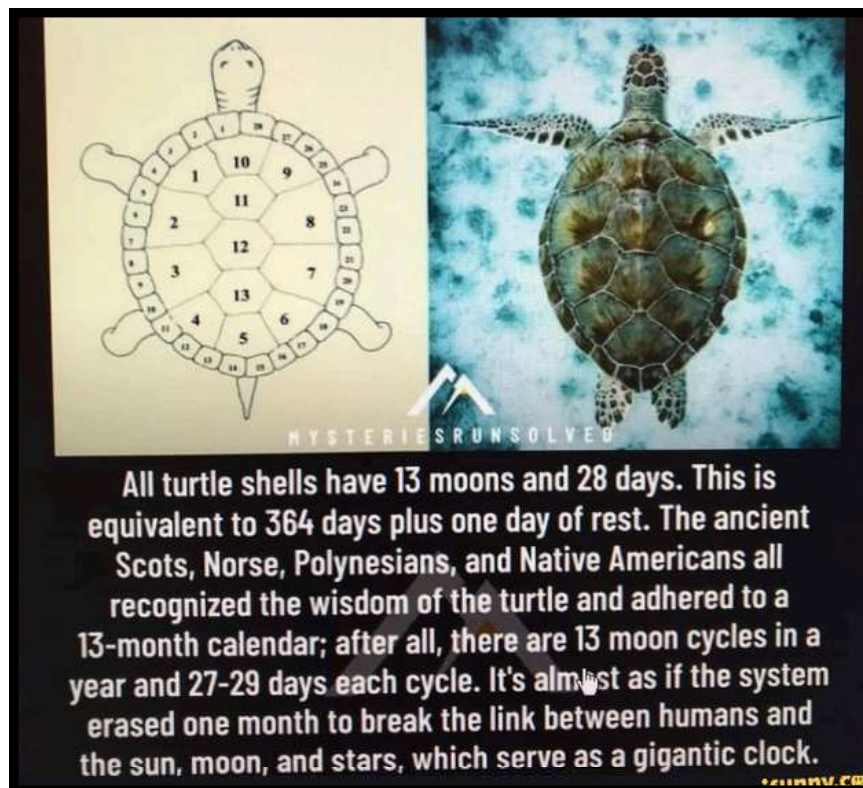
Religion has also played a significant role in guaranteeing the spiritual darkness of society. How so? God bestowed upon man the strengths needed to navigate the physical aspects of society, while the woman was created with the strengths necessary to guide humanity in a spiritual sense. Thanks to the figure “Apostle” Paul, today’s Christian religion has reversed that role, giving it to the man. Today, we do not have the privilege the nation of Israel had – God’s guidance. Therefore, to have society today recognize man as the spiritual leaders of the world, who have not been created by God to play that role, would that not guarantee humanity remains in spiritual darkness? By society being built in a way that does not allow the human race to function as God intended, does that not ensure humanity will never truly find their path to truth?

## *The Gregorian Calendar*

The Gregorian calendar, our current calendar system, has 12 months based on the Earth's falsified orbit around the sun. In contrast, the months and days of the Hebrew calendar of the Old Testament is based on the phases of the moon. The year, according to the Gregorian calendar, begins in the middle of a season — winter — rather than starting the year at the end of a season, or a complete cycle of the seasons. In contrast, the Hebrew calendar system has the new year start in the season of renewal — Spring. By removing us from a calendar that goes with the cycles of the heavenly bodies and the earth, we no longer give the same value to these days or pay attention to events that take place on these significant days.

As the people of the world are programmed to accept the above belief systems, it ensures we are completely ignorant to the events of our day, including the short season under Satan, let alone to the end of his rule. Considering what and who we are up against, is it even possible for us to discover when Satan's short season ends?





## Was Satan Allotted a Specific Period of Time?

Just as Jesus was aware of the length of time given to him – a thousand years – Satan would have also been aware of the period of time given to him. As his time started at the end of the Millennial Reign, he would have known when his period of time would end as well. Given the shortness of this period, it would have been in Satan's interest for the people to know, igniting a sense of urgency among them. But what would be used to signal the end of Satan's rule?

Civilizations of that time relied heavily on observing the sky to track time, determine dates, and establish deadlines. The sky served as the world's clock and calendar. The fixed positions of stars in the night sky provided a reference for navigation and timekeeping. The visible movements of planets, such as Mercury, Venus, Mars, Jupiter, and Saturn, across the sky were carefully observed by ancient astronomers. These planetary motions were predictable and could be used to establish calendars and predict future celestial events.

For our day, there are two celestial events that may be worth noting:

- The occultation of Jupiter and the moon on the winter solstice of December 2023, and
- The solar eclipse on April 8, 2024.



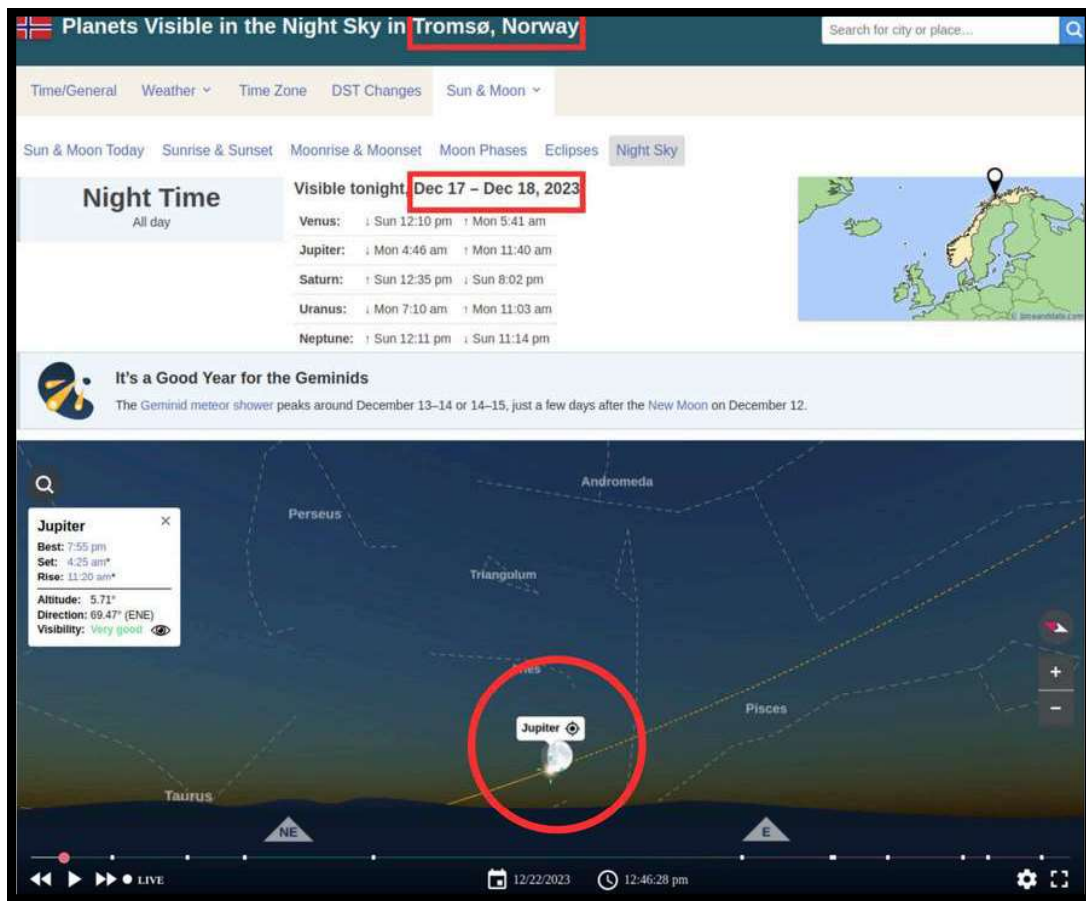


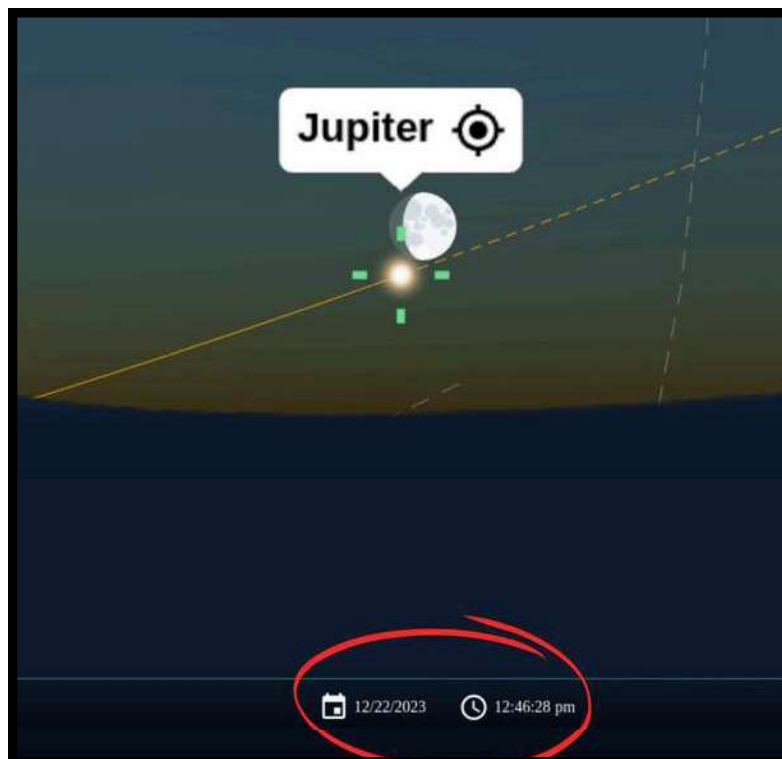
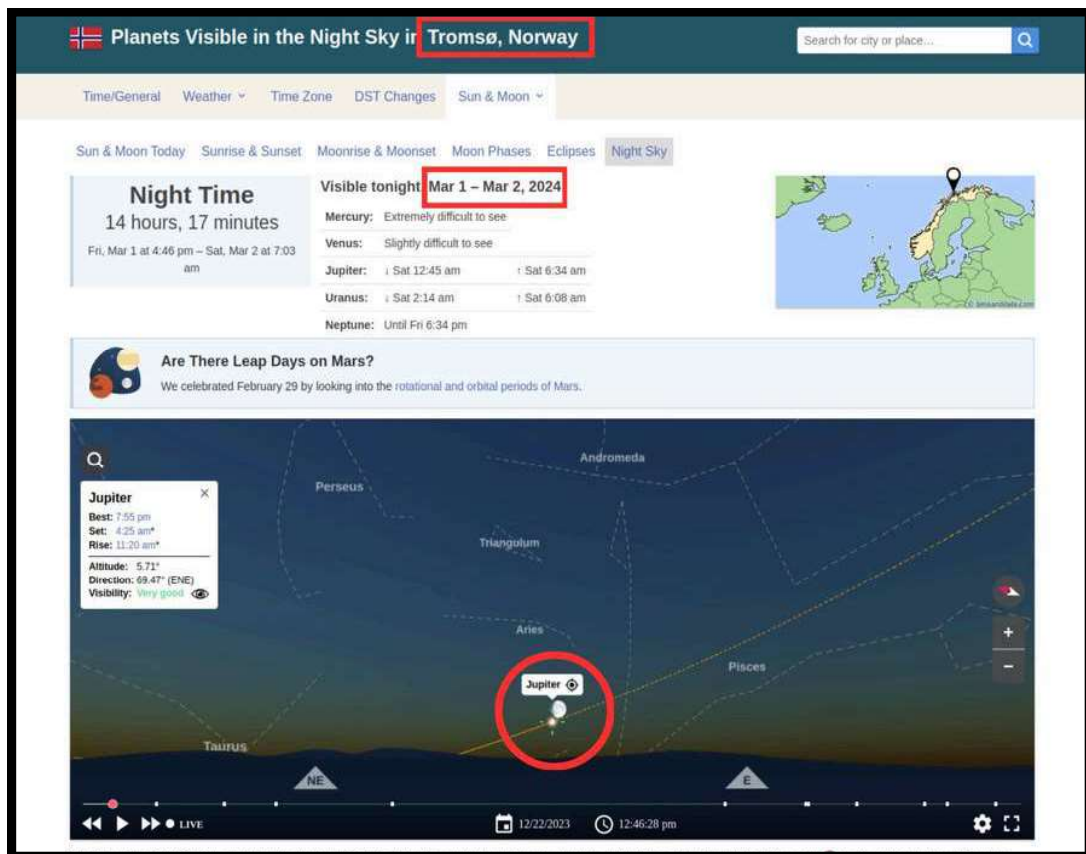
## **2023 Winter Solstice Occultation**

On the winter solstice of December 2023 there was an occultation, or crossing, of two celestial bodies – Jupiter and the moon. The crossing of Jupiter and the moon was only visible in the most Northern part of our dome earth – the center. However, when examining the screenshot taken on December 17, 2023 with a screenshot from March 1, 2024 of the same event, at the same time, in the same location, there is a discrepancy. The image from 2023 shows Jupiter passing through the moon – an occultation. However, the image from 2024 shows a conjunction – Jupiter appearing close to the moon.

Websites like TimeandDate.com and online planetariums generally provide accurate celestial predictions based on astronomical calculations and observations. Astronomical calculations and observations are generally highly accurate, especially with advancements in technology and methodologies. However, they also show a conjunction, not an occultation. Why was there an adjustment from an occultation of Jupiter and the Moon during the winter solstice to a conjunction instead?

Is there any possibility that there is some sort of significance to this event? Occultations occur all the time with celestial bodies, so what was different about this event?







## April 2024 Solar Eclipse

There is also the solar eclipse of April 2024 that is considered to be of significance. On April 8, 2024, a total solar eclipse will cross North America, passing over Mexico, the United States, and Canada.

The path of the eclipse is also of interest. When combined with the total solar eclipse of August 21, 2017, and the annular solar eclipse of October 14, 2023, as shown in the image, we see a specific shape emerge – one that corresponds with the first letter of the Hebrew alphabet. The two solar eclipses together create a shape that corresponds with the last letter of the Hebrew alphabet (which will be discussed further on).

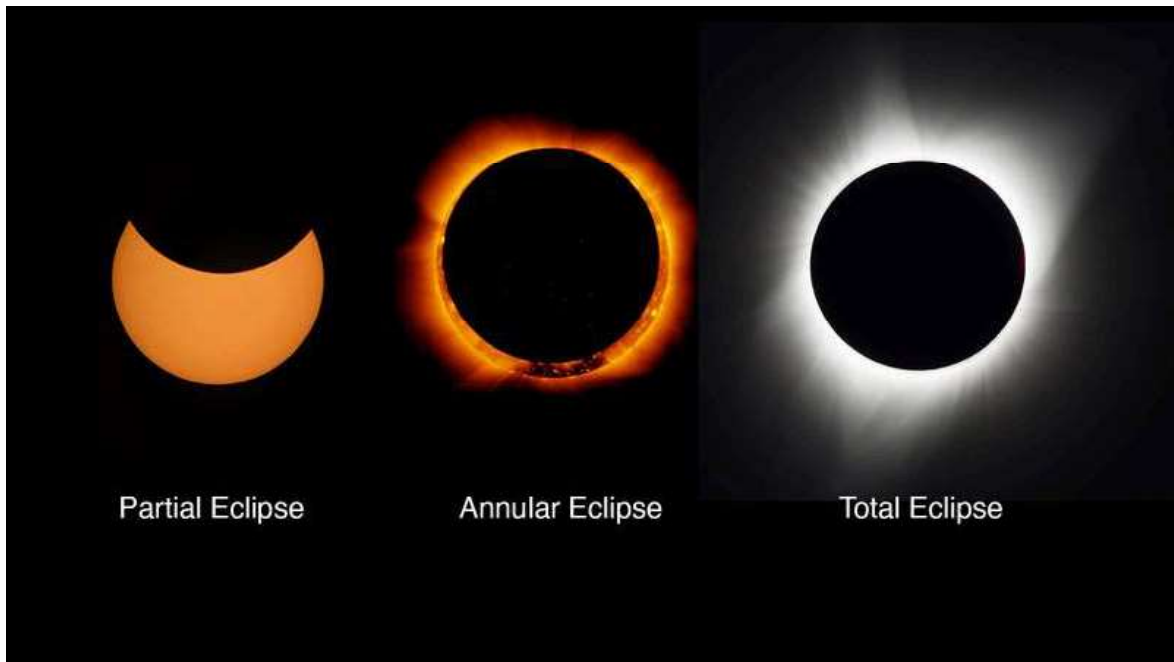
It is also interesting to note that this event takes place a day before the new year, according to the Old Testament. This is based on passages such as Exodus 12:2, where God instructs Moses and Aaron to establish Nisan as the first month of the year for the Israelites:

*“This month shall be the beginning of months for you; it is to be the first month of the year to you.”*

The new year, with Nisan as the first month of the year, begins in the springtime (Hebrew “Aviv”). So, unlike our Gregorian calendar system, God has established April as the first month of the year. For 2024, the first day of Spring and the beginning of the new year falls on April 9th – the day after the solar eclipse.

Is it possible that the eclipse and Jupiter occultation are of significance to us regarding the time we are living in?

What if it's possible to attribute these celestial events to the end of Satan's short season? Wouldn't it make logical sense that the end of Satan's era would be signaled by a predictable celestial event that could not be controlled?

All three eclipses of 2017, 2023, 2024



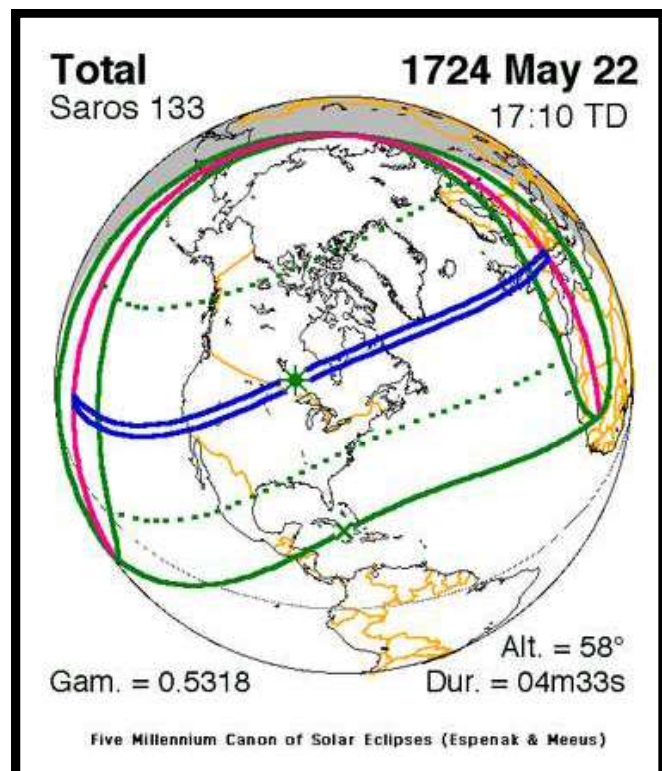


## 1724 Total Solar Eclipse

Another interesting fact is related to the total solar eclipse of May 22, 1724. This eclipse first crossed over Britain before reaching America. It had a path that extended over Canada's Quebec region before reaching America. From there, it continued its trajectory downward, passing over the region that would later become Los Angeles.

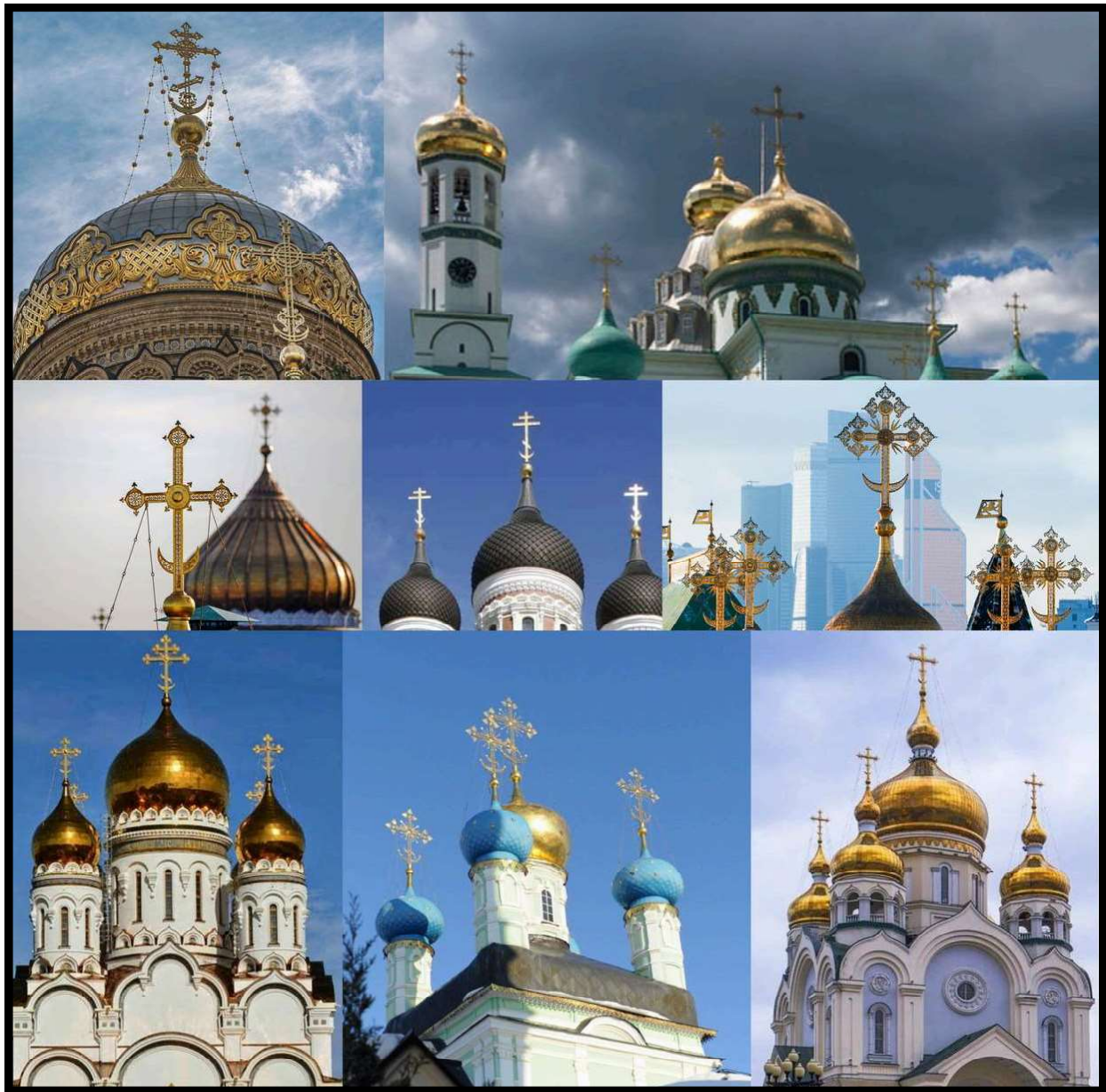
This event took place almost 300 years before the total solar eclipse of 2024. Is it possible that this marked the beginning of the short season? The 1724 total solar eclipse took place in May. Could Jesus' Rule have ended that previous winter solstice in December? How long did it take for Satan to be released, or to convince the people? Did Jesus give them until a certain date to decide what side they would choose? If it involved travel, would not time be given after the winter? Was the deadline signaled by a celestial event? It is a curious coincidence that this total solar eclipse took place over Britain. Britain was positioned as the epicenter where control would be exerted through its world banking system and the banking laws that continue to govern the world to this day (more on this topic later).

Once the world had entered the short season, is it not likely that the future celestial event, or "deadline" would have had a profound influence on society? It doubtlessly affected daily life, beliefs, and cultural production, leaving lasting imprints on society. Does it not stand to reason that visible reminders, such as antiquities and early architectural structures, would serve as poignant reminders of this crucial time period?



## Examining Ancient Structures and Artifacts

When examining architectural structures, domes were a common design element worldwide. Unfortunately, many have undergone changes, with the removal or replacement of spires. However, with those that remain, we find domes with distinct design elements on the spires. The most common design element is what is referred to as the “cross” or “crucifix”, however we notice other design elements present in multiple spires above domes. For example, upon closer look, the “cross” often contains a star burst. Could this lead us to clues?



## *The Crucifix*

Today, the cross is considered a representation of Jesus' death. If that is so, that would mean the practice of honoring the cross was kept throughout the thousand years of Jesus's reign up into present day. Would it not make more sense that the people during Jesus' Millennial Reign, rather than honoring the supposed shape of the object Jesus died on, celebrated their liberation under Jesus? Possibly an annual celebration of humanity's darkness to light? This would be in keeping with the traditional observance of the Passover, an annual celebration of Israel's liberation from Egypt.

## *Starburst*

The presence of spires adorned with crosses or crucifixes featuring a starburst is not uncommon. In Revelation 22:16, Jesus unequivocally identifies himself as "the bright Morning Star," employing the definitive article "the" to underscore his unparalleled identity and divine supremacy. This explicit declaration emphasizes Jesus' unique authority and role as the ultimate source of light and salvation.

Some may attempt to draw a parallel by referencing Isaiah 14:12, where Satan is described as a morning star. However, it's essential to note a critical distinction: while Isaiah employs the term for descriptive purposes, there is no definitive article used, indicating that it is not a title but merely a descriptor. This contrast reinforces the exclusivity of Jesus' claim as the true Morning Star, distinct from any other entity.

## *Arrows*

A number of the images above show a set of arrows under the crucifix. Even though they may be presented in different design forms, they maintain the idea of pointing in two opposite directions. Could this be in reference to the two paths presented to them: one led by Jesus and the other by Satan?

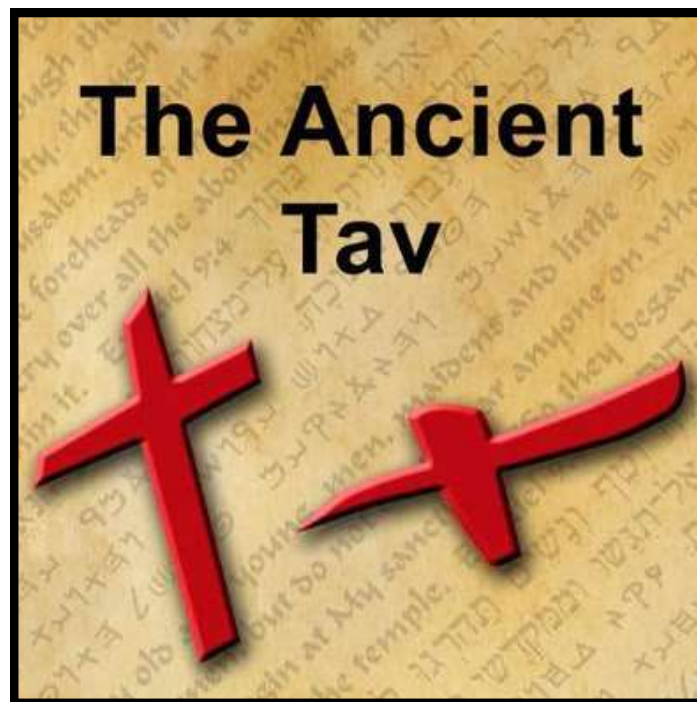
## *Meaning in the Short Season*

The letter “Tav” in Hebrew is similar in shape to the lower case “t” in the English alphabet. The “Tav” symbolizes completion as the last letter of the alphabet, marking the end of a process or cycle.

With that in mind, would it not make sense that the starburst cross represents the end of Jesus’ Millennial Reign? As such, would it not be a noteworthy event during the short season, as the deceived would have viewed the end of Jesus’ reign as their moment of liberation? And would not Satan want faithful followers of Christ, unaware of what it truly represents, to give honor to such an object?

So, if the starburst crucifix symbolized the end of Jesus’ Millennial Reign, could the arrows signify the purpose of the time period that followed, a time designated to prove which ruler was superior: either Jesus’ rule or Satan’s?

Another notable design element of these spires is the presence of a crescent at the base, as is shown in the images below. Could the crescent also be of any significance?





## *The Crescent*

It is also interesting to note that the crescent moon is a common symbol in the Islamic faith. It is often seen as a prominent symbol adorning the spires of mosque domes. While some only display a moon, a number contain both a star and a moon. In fact, many antiquities from other cultures display a star within a moon, including coins, flags and banners, artwork, architecture, seals and insignia, and jewelry. In fact, there are a number of pieces that display both the crescent, star, and cross. For example, coins attributed to the 4th to 15th century contain all three symbols.











What could be the significance of the cross, the star and crescent?

If Jesus refers to himself as the morning star, and the symbol of the cross is found on items with the star and crescent together, could this be referring to the expectation of a celestial event involving Jesus, the moon and a bright celestial body?

If so, which part of the world would it be visible? What time of the year would it be expected? What celestial body would be visible within the moon?

There may be an unlikely place we can find clues: a well-known celebration around the winter solstice – Christmas. Could it shine light on the significance of these symbols, and even the 2023 Jupiter occultation on the winter solstice?

## **Examining the Origins of Christmas**

We are told that in the 4th century, Pope Julius I chose December 25th to celebrate the birth of Jesus Christ, and that it was likely to coincide with existing pagan festivals like Saturnalia in Rome or the winter solstice celebrations in various other cultures. It is also claimed that the celebration of Christmas on December 25th, as well as the incorporation of certain customs, were influenced by efforts to Christianize existing pagan festivals. It is claimed that ancient practices such as decorating evergreen trees, exchanging gifts, and celebrating the winter solstice were observed by various cultures, centuries before the emergence of Christianity. For instance, the Romans celebrated Saturnalia in late December, while Germanic and Norse peoples honored the winter solstice with rituals and festivities. These pagan customs are said to date back to centuries before the emergence of Christianity and continued through the Middle Ages, which spanned from approximately the 5th to the 15th centuries.

However, when we understand that Jesus returned during the lifetime of his disciples, and, after warring with Satan, he established his Millennial Reign, we realize these historical accounts are completely fabricated. There was no period of “antiquity” followed by a dark age or even a Middle Ages. That means the time period these so-called traditions came from never existed. Therefore, the so-called adoption of “pagan” practices would have had to come into existence before the Millennial reign and readopted in the short season. Or they come into existence during the short season. But if these came into existence during the short season, why hide the origins, as they would already be pagan?

While it is still possible that it may have pagan origins, ask yourself this: How is it possible for humanity to have rediscovered and reincorporated the pagan practices that took place a thousand years or more before the short season?

Is it not possible that what we have today is a watered down version of what was an annual celebration of Jesus' Millennial Reign, the most significant event in human history up to that date?

As wicked/evil/darkness does not have the ability to create – a quality belonging to God and those reflecting his qualities – would it not make sense that these traditions would be adopted by Satan, as he deceived the people into believing he was their liberator? And as time passed, would he not use his usual tactic of “cultural erasure” or “cultural assimilation”? This tactic involves gradually erasing or altering cultural practices and beliefs over generations, leading to the adoption of new customs and the forgetting of previous traditions. This process often involves reinterpreting the origins of traditions to align with the agenda of those in power, ultimately resulting in the loss of cultural identity and heritage.

Is it at all possible that Christmas customs are not pagan, but are actually related to Jesus' Millennial Reign?

### *Christmas*

When examining the origins of the word “Christmas”, it is interesting to find that Christmas was not originally a celebration of Jesus' birth. The term “mass” or “mæsse” originated from the Latin word “missa,” which was used in reference to what is called the “Eucharistic celebration”. The Eucharist commemorates the Last Supper, where Jesus shared bread and wine with his disciples before his death. Though history tells us this practice was first introduced by the Catholic Church, this celebration was first, not initially of the birth of Jesus, but rather, his death.

## *Winter Solstice*

The winter solstice marks the shortest day and longest night of the year in the Northern Hemisphere. Celebrating Jesus liberating humanity on winter solstice would then act as a solemn reminder of how Christ's Millennial Reign ended darkness and brought light into the world.

Now, the prophecy of Daniel 9:24-27 speaks about the death of the “anointed one”, the Messiah, or Christ, which would be followed by one week, or seven years (each day representing a year – Ezekiel 4:6; Numbers 14:34). At the completion of this ‘seven’, the Messiah returned, destroying what was wicked and ending the evil influence of Satan, the “prince of the world” (John 12:31). If, after the death of Jesus, there were seven years before his return, then that would mean his death and return would take place at the same time of the year – winter solstice.

## *Bethlehem Star/The Christmas Star*

The star is said to represent the star of Bethlehem that led the wise men to Jesus when he was born. The Star of Bethlehem first led the wise men to King Herod in Judea, believing it signaled the birth of a new king. Herod, troubled by this news, directed them to Bethlehem and asked to be informed of their findings.

However, warned in a dream, the wise men avoided Herod on their return journey. Learning of their deception, Herod ordered the massacre of all male children in Bethlehem who were two years old and under. This was a horrific event predicted by God, but never willed by him, therefore, the star likely was not from God, but rather Satan. He likely used an illusion of a star rather than a real star in his deception. Satan wanted the death of his rival. In regards to the Christmas star, Satan would have wanted his star to replace the original star that was part of the celebration of Jesus' Millennial Reign.

Remember, as discussed earlier, Jesus refers to himself as the bright morning star (Revelation 22:16). This would be an appropriate title for Jesus, as it emphasizes his essential role in the salvation of humanity. Therefore, the star above the tree

likely was in reference to Jesus as the “Bright Morning Star” that liberated humanity from darkness, guiding them to salvation.

### *Christmas Tree*

The tree of life in the Garden of Eden was lost to humanity when it chose an independent course from God. Revelation 22, however, explains how those that belong to God would gain access to the tree of life once again – their source of eternal life. This took place when Jesus established God’s kingdom on earth. Gaining access to the tree would be an integral part of the restoration of humanity, therefore it is reasonable to conclude that the tree would, therefore, play a central role in the celebration of Jesus’ Reign.

### *Baubles*

As the fruit of the tree of life gave eternal life to those consuming it, it is likely that the baubles represent these fruits.

### *Christmas Lights*

The tree of life was situated in the holy city, New Jerusalem, (which came down to earth from heaven), a city that was filled with God's light day and night, and the light of the lamb. Therefore, for those around the world involved in the celebration, light would represent continuous light surrounding the tree of life. (And keep in mind, our lights today are an inferior version of technology they had under Jesus’ reign).

### *Gift Giving*

As Jesus gave life in abundance to his people through the fruit of the tree, a celebration would logically include giving and sharing gifts with loved ones.



## *Making the Connections*

Therefore, Christmas was meant to celebrate Christ Jesus (the morning STAR) and his GIVING of life through the fruit (BAUBLES) of the TREE of life, a time of LIGHT and CELEBRATION, taking place on SOLSTICE the shortest day of the year, representing humanity's spiritual shift from DARKNESS to LIGHT.

If Christmas was originally a celebration of the Millennial, or thousand year, reign of Jesus here on earth – it was exactly that: a specific period of time allotted to Jesus. That means that if his reign started on the winter solstice, the end of that thousand years would land on the winter solstice. To be followed by what? The release of Satan, and the commencement of the short season of worldwide deception. As such, it is logical to assume that the period of time allotted to Satan also ends on the winter solstice.

Now that we understand the time of year when Satan's rule ends, where might we anticipate the celestial event of a bright celestial body crossing paths with the moon to occur?

### **2023 Winter Solstice Jupiter & Moon Occultation**

It's important to note that the ancient architectural buildings with the spires containing the cross, morning star and crescent have these spires situated in the center of a dome. This location aligns with where Jesus' Kingdom was located – the center of our dome earth. Hence, it is where the celestial event will most likely take place – what we refer to as the “Arctic”.

But what celestial body will cross paths with the moon? It will likely be the brightest object in the sky other than the moon.

Venus is typically the brightest natural object in the night sky after the Moon. Venus has a higher apparent magnitude (a measure of an object's brightness) than Jupiter, making it appear brighter. However, Venus does not rise above the

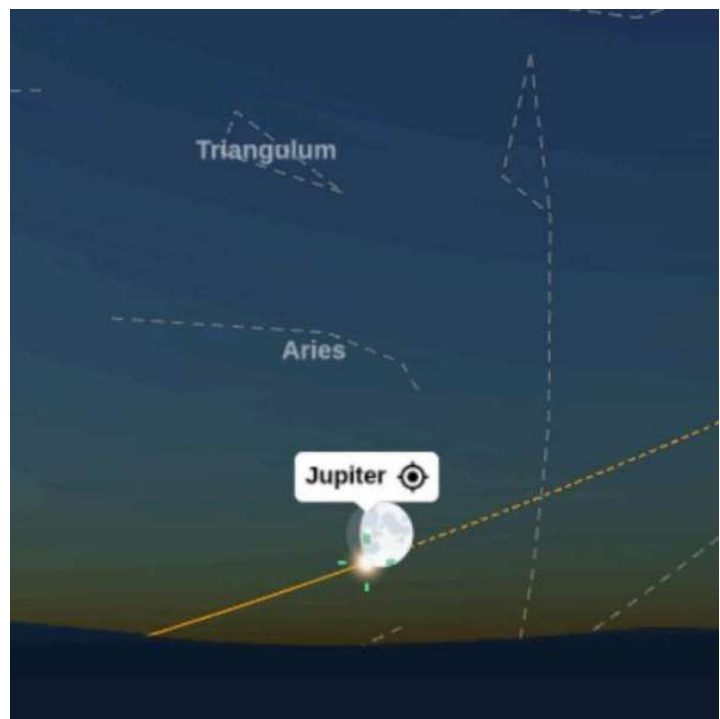
horizon in the Arctic during the winter solstice. In the morning sky during winter, *Jupiter is the brightest celestial object.*

Today's society has been taught to believe that Jupiter is a planet, not a star. The heliocentric model has hidden knowledge that was well known by our ancestors – that these objects above our level plane are wondering stars within the inner surface of the celestial dome or firmament. By blinding us to this truth, we fall further away from understanding the significance of the symbol of the star and moon.


Looking as far back as the 17th century, Jupiter has not directly crossed paths with the moon on the winter solstice. The first Jupiter and moon occultation to take place in the past four centuries was on December 22, 2023. The images below (also shared in post 5) show Jupiter crossing the path of the moon at 12:46pm in Tromsø, Norway, located North of the Arctic Circle. The winter solstice in Tromsø, Norway, occurred on December 22, 2023, at approximately 4:59 AM local time, ending at approximately 5:00 PM local time.

So, the celestial body that crosses paths with the moon on the winter solstice, in the center of our earth, is Jupiter. The momentous event that has influenced cultures for centuries, and which signals the end of Satan's rule.

But what about the eclipse of 2024? Is it possible this may also hold meaning to us as well?



## **The Great American Eclipse of April 2024**

The upcoming Great American Eclipse of April 2024 is generating considerable excitement due to its extraordinary rarity. Total solar eclipses are a celestial phenomenon, during which the path of totality—where the moon entirely obscures the sun—is usually confined to a limited geographic area.

The April 2024 total solar eclipse will take place across North America. It will cross from Mazatlán, Mexico to Newfoundland, Canada. It is a highly anticipated event where millions will observe the shadow of the Moon crossing all the way from Mexico, through the United States, to Canada.

In recent times, America has witnessed several noteworthy eclipses, including the following:

**The Total Eclipse of August 21, 2017:** This eclipse was special because it was the first time since 1918 that a total eclipse went from the Pacific to the Atlantic across America. It was also the first time since the founding of America, in 1776, that an eclipse's total path stayed entirely within the U.S. In fact, the last total solar eclipse to take place across America was on May 22, 1724.

**The Annular Solar Eclipse of October 14, 2023:** The October 2023 annular eclipse crossed America from Oregon to Texas. An annular eclipse differs from a total eclipse by leaving a ring of sunlight visible. A total solar eclipse fully obscures the Sun.

### *The American Eclipses and Their Significance*

When we look at the path of these three eclipses over America, we notice it creates a specific shape – one that is identical to the Paleo-Hebrew letter “Aleph”.

Paleo-Hebrew was the original script the Hebrew books of the Bible were written

in. The first letter of the Hebrew alphabet is the “Aleph”. The Paleo-Hebrew Aleph is shaped similar to the English upper case “A” on it’s side, as you can see in the image below. This is the shape created by the above three eclipses over America.

If we were to count only the total solar eclipses, (August 2017 and April 2024), they resemble the Paleo-Hebrew letter “Tav”. It is the final letter of the Hebrew alphabet, which also signifies the conclusion or culmination of something. As discussed earlier, the letter “Tav” in Hebrew is similar in shape to the lower case “t” in the English alphabet.

“Aleph” and “Tav” together are often interpreted as a symbol for God in Hebrew, representing the entirety of existence from beginning to end, as God encompasses all things. (The video below provides a good visual of the eclipses and their paths, resembling the Aleph and Tav.)

This brings to mind the phrase used in Revelation: “Alpha and Omega”. Revelation is written in Greek. The phrase “Alpha and Omega” uses the first and last letters of the Greek alphabet. In Hebrew, this would translate to the first and last letters of the Hebrew alphabet, “Aleph” and “Tav”.

In the Book of Revelation, the term “Alpha and Omega” initially refers to Almighty God, highlighting His eternal nature and supreme authority (Revelation 1:8). As the narrative progresses, once Jesus, the Lamb, presents his sacrifice to the throne of Almighty God, he is exalted to a position of honor and authority (Revelation 5:5-6). From this point on, he has shared rulership on the throne of the Almighty (Revelation 3:21). Along with that, he also shares certain titles. While Almighty God is the only one referred to as the “Almighty” and “the one who is, who was and who will be”, signifying God’s timeless nature, Jesus now shares the title “Alpha and Omega”. By Revelation 22:13, Jesus’ use of this title shows his central role in bringing about God’s plan for humanity’s salvation. It highlights his significance and authority alongside Almighty God. This progression reflects

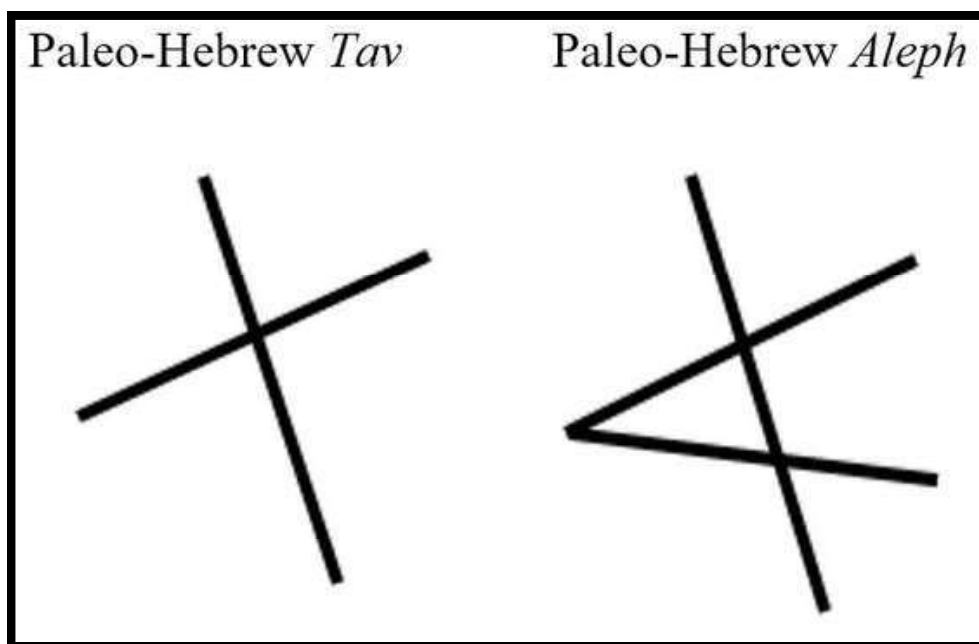
Jesus' central role in God's plan of salvation. This role was intended for Jesus from the beginning, and it is one in which he will share for eternity, the “First and the Last” as ruler of our world.

The alignment of these three eclipses over America, forming the “Aleph” and the “Tav” on the last day of the year, according to the Hebrew calendar of the Old Testament, is likely signaling the end of an era: Satan’s short season. This celestial event is signaling a transition, or turning point in history, the end of a period of darkness. It proclaims the dawn of a new era. An era of transformation and renewal under the rule of Jesus: the “Alpha and Omega”.

## **The Hidden History of the Holy Lands**

In this age of deception under Satan, our entire world has been built to be an inversion. An inversion of what we were designed to be, an inversion of truth, an inversion of history. All to keep us blind, ignorant and powerless – exactly what is required of slaves. One of the great deceptions of our age is where the Biblical lands are located.

### *Kincaid's Cave*

The Smithsonian Institution, one of the most influential organizations in shaping our understanding of history and culture, has contributed significantly to our understanding of the “Holy Land”. Today, the term “Holy Land” is often used to refer to the geographic region that includes modern-day Israel, the Palestinian territories (such as the West Bank and Gaza Strip), parts of Lebanon, western Jordan, and southwestern Syria. But is that really where the “Holy Land” was located?

In 1908, President Teddy Roosevelt wanted to declare the Grand Canyon off-limits to all timber and mining operations. He eventually got his way, establishing the Grand Canyon as a protected area. A man named G. E. Kincaid explored the area before it was closed off. Kincaid's exploration and discovery in the Grand Canyon includes the discovery of a hidden underground city containing artifacts reminiscent of ancient Egyptian culture. Kincaid said he uncovered mummies, hieroglyphs, and other relics within a cavern system deep within the canyon. G. E. Kincaid sent notes to the Smithsonian about what he found, asking for financial and logistical support.

The Smithsonian provided S. A. Jordan with a team of around forty. G. E. Kincaid recorded detailed evidence of what he found, including what he concluded was a city that was inhabited by tens of thousands at one point. His discoveries proved the existence of an advanced civilization that should not have existed based on the accepted archeological narrative.

Unfortunately, Kincaid and Jordan disappeared after that, and the Smithsonian to this day denies any association with either. An article of the discoveries in the Arizona Gazette newspaper of April 5, 1909 is labeled as the great Hoax of 1909. The area of discovery is today off-limits and enforced by government agencies. There are an estimated 1000 caves in the Grand Canyon, yet only one is available to the public. Approximately 90% of the Grand Canyon is off limits and is strictly regulated.

# EXPLORATIONS IN GRAND CANYON

The latest news of the progress of the explorations of what is now regarded by scientists as not only the chief archaeological discovery in the United States, but one of the most valuable in the world, which was mentioned some time ago in the Gazette, was brought to the city yesterday by G. K. Kinkaid, the explorer who found the great underground chamber of the Grand Canyon during a trip from Green River, Wyoming, down the Colorado in a wooden boat, to Yuma, several months ago. According to the story related yesterday to the Gazette by Mr. Kinkaid, the archaeologists of the Smithsonian Institute, which is directing the explorations, have made discoveries which almost conclusively prove that the race which inhabited the mysterious cavern, known as such, was a human race, with an oriental origin, possibly from Egypt, tracing back to Hammurabi. If their theories are borne out by the translation of the tablets engraved with hieroglyphics, the mystery of the prehistoric peoples of North America, their ancient life, who they were and whence they came, will be solved. Egypt and the Nile and Arizona and the Colorado will be linked by a historical chain running back to ages which stagger the wildest fancy of the beholder.

**A Thorough Investigation.**  
Under the direction of Prof. S. A. Jordan, the Smithsonian Institute is now prosecuting the most thorough explorations, which will be continued until the last link in the chain is forged. Nearly a mile underground, about 1400 feet below the surface, the four main

feet ventilation of the cavern, the steady draught that blows through, indicates that it has another outlet to the surface.

## Mr. Kinkaid's Report.

Mr. Kinkaid was the first white child born to Idaho and has been an explorer and hunter all his life, thirty years having been in the service of the Smithsonian Institute. Even briefly recounted, his history sounds fabulous, almost grotesque.

First, I would impress that the cavern is nearly inaccessible. The entrance is 1185 feet down the sheer canyon wall. It is located on government land and no visitor will be allowed there under penalty of trespass. The scientists wish to work unmolested, without fear of the archaeological discoveries being disturbed by curio or relic hunters. A trip there would be fruitless, and the visitor would be sent on his way. The story of how I found the cavern has been related, but in a paragraph. I was journeying down the Colorado river in a boat, alone, looking for mineral. Some forty-two miles up the river from the El Tovar Crystal Canyon I saw on the east wall, stains in the sedimentary formation about 2000 feet above the river bed. There was no trail to this point, but I finally reached it with great difficulty. Above a shelf which hid it from view from the river, was the mouth of the cave. There are steps leading from this entrance some thirty yards in which was, at the time the cavern was inhabited, the level of the river. When I saw the stone marks on the wall inside the entrance, I became interested, secured my gun and went in. During that trip I went into several hundred feet along the main passage; till I came to the spot in which I discovered the tunnels. One of these I stood up and photographed by flashlight. I gathered a number of relics, which I carried down the Colorado to Yuma, from whence I shipped them to Washington with details of the discovery. Following this the explorations were undertaken.

## The Passages.

"The main passageway is about 15 feet wide, narrowing to 8 feet toward the farther end. About 57 feet from the entrance, the first wide passages branch off to the right and left, along which, on both sides, are a number of rooms about the size of ordinary living rooms of today, though some are 30 or 40 feet square. These are entered by oval-shaped doors and are ventilated by round air spaces through the walls into the passages. The walls are about 3 feet 8 inches in thickness. The passages are chiseled or hewn as straight as could be laid out by an engineer. The ceilings of many of the rooms converge to a center. The side passages near the entrance run at a sharp angle from the main hall, but toward the rear they gradually reach a right angle in direction.

## The Shrine.

"Over a hundred feet from the entrance is the cross-hall, several hundred feet long, in which was found the idol or image of the people's god, sitting cross-legged, with a horn flower or lily in each hand. The east of the

### *The Promised Land: Originally in America?*

The promised land given to the Israelites likely included the areas of California to Utah. Nevada and Utah resemble the arid landscapes of ancient Israel's Negev Desert, while their mountains resemble the mountainous terrain of biblical Judah. ### *The Dead Sea Scrolls*

The Dead Sea Scrolls were discovered in the region that is now part of modern day Israel. They were found in several caves near the northwest shore of the Dead Sea, in what is known as the West Bank area, specifically in the vicinity of the ancient settlement of Qumran.

Some will argue that the discovery of these scrolls proves that the Holy Lands existed in the said Holy Lands of today.

However, let's consider a few facts.

It is interesting to note that, it was only a few years before the establishment of the state of Israel that the Dead Sea Scrolls were discovered. Researchers have

assembled a collection of 981 different manuscripts (discovered in 1946/1947 and in 1956) from 11 caves. These caves lie in the immediate vicinity of the Hellenistic Jewish settlement at the site of Khirbet Qumran in the eastern Judean Desert, in the West Bank. Hellenistic refers to the period following the conquests of Alexander the Great, during which Greek culture, language, and influence spread across the Mediterranean and into the Middle East. The claim is that it lasted from the death of Alexander in 323 BCE until the establishment of the Roman Empire in 31 BCE.

This short season under Satan has been built to bury the truth. Historians, scholars, and theologians tell us that the Greek scriptures were written decades after the death of Jesus in order to reach the masses. All part of a ministry that is said to have taken place over decades. 1894 A fire in Conrad, Iowa destroyed the downtown, which was quickly rebuilt in brick.

1894 The downtown of Dalton, Ohio was destroyed in a fire that was suspected to have been caused by arson, costing \$250,000.

1896 Paris, Texas - much of the town.

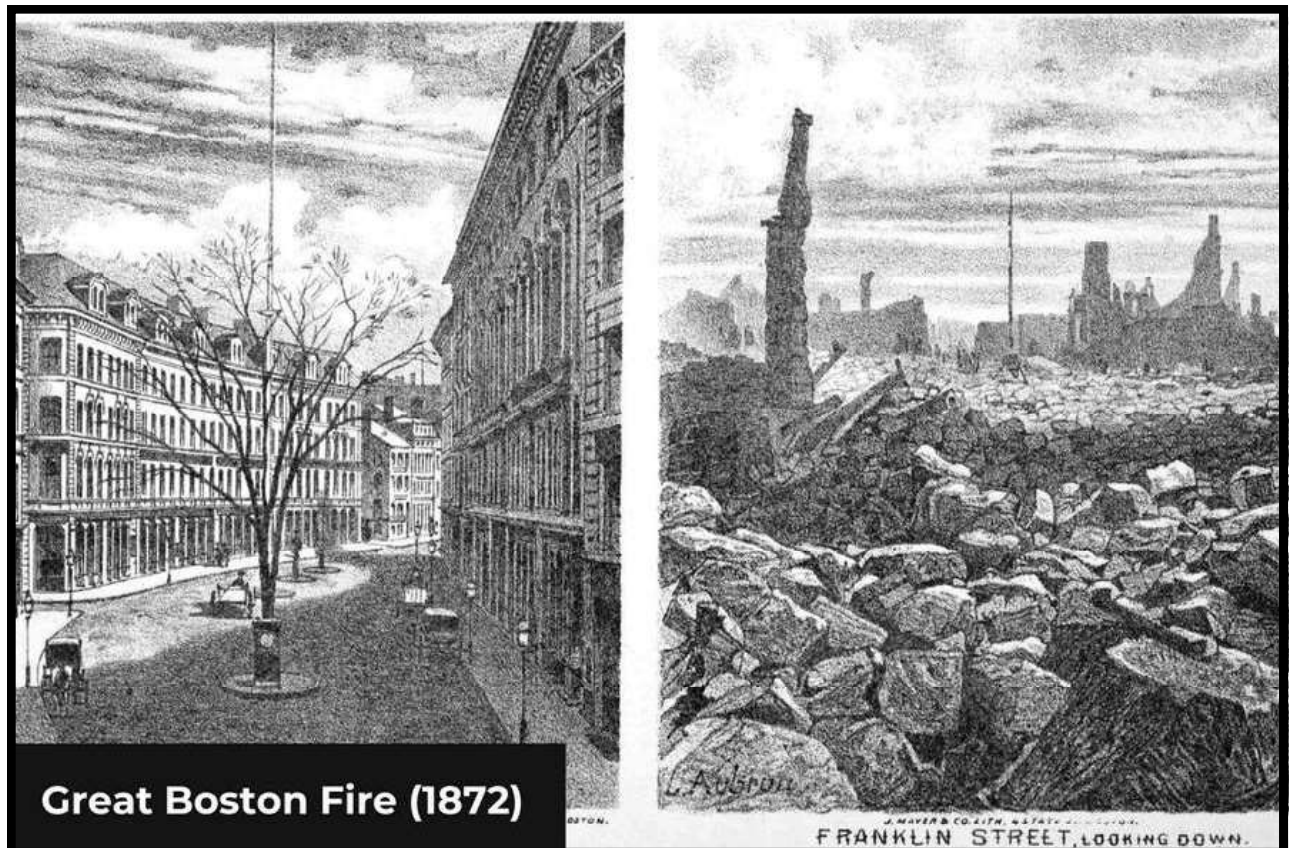

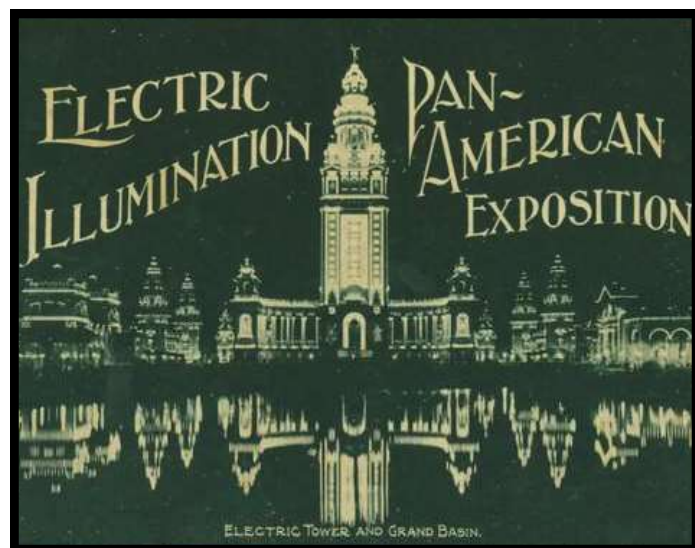


## United States World Fairs of the 19th and Early 20th Century

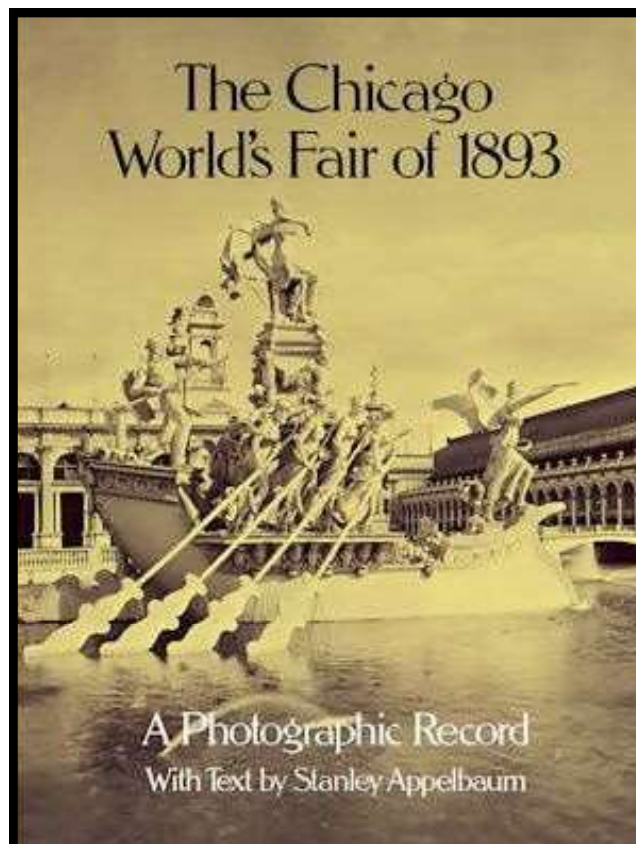
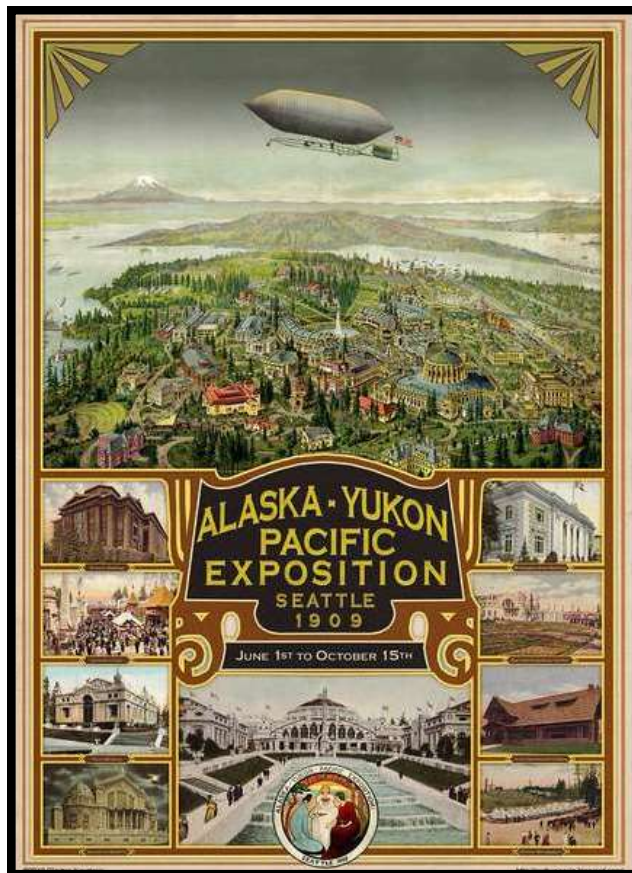
Next, we will examine the United States World Fairs of the early 19th century to early 20th century.

The majority of the buildings at these fairs were said to be constructed to be temporary, using wood and plaster. Many of the buildings were demolished at the end of the fair, while others disappeared over time due to fire.

However, why don't you allow your eyes to tell you if these structures were really built to be temporary, or, they were magnificent buildings of old that would have threatened the narrative of primitive civilizations.



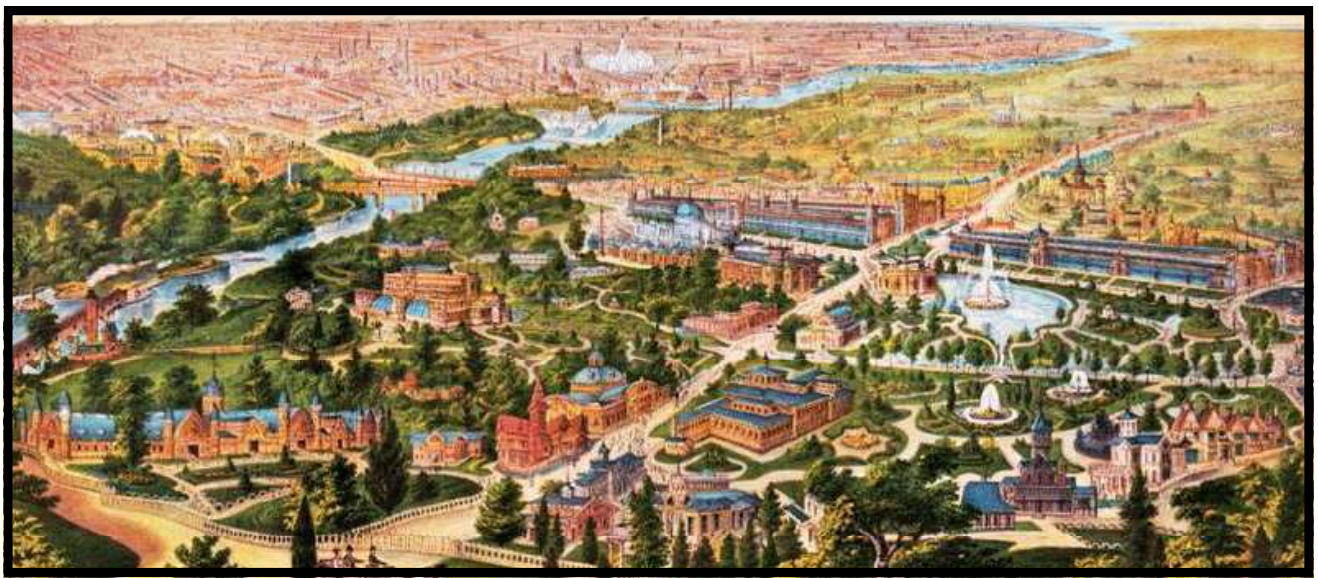




## **United States World Fairs: Centennial Exposition (1876) - Philadelphia, Pennsylvania**

Official Narrative: Held in Philadelphia, Pennsylvania, this fair celebrated the 100th anniversary of the signing of the Declaration of Independence. It showcased the technological and cultural advancements of the United States and featured exhibits from various countries around the world.

Many of the buildings were dismantled after the fair, but some, like Memorial Hall, were preserved and repurposed. Memorial Hall now serves as a cultural center within Fairmount Park in Philadelphia.







## **United States World Fairs: World's Columbian Exposition (1893) - Chicago, Illinois**

Official Narrative: Also known as the Chicago World's Fair, this event commemorated the 400th anniversary of Christopher Columbus's arrival in the Americas. It took place in Chicago, Illinois, and introduced many innovative technologies and architectural marvels, including the Ferris Wheel.

## United States World Fairs: Trans-Mississippi Exposition (1898) - Omaha, Nebraska

Most of the fair's buildings were said to be temporary and were demolished after the event. Forest Park, where the fair was held, remains a public park in St. Louis, and some features, such as the Grand Basin, still exist today.







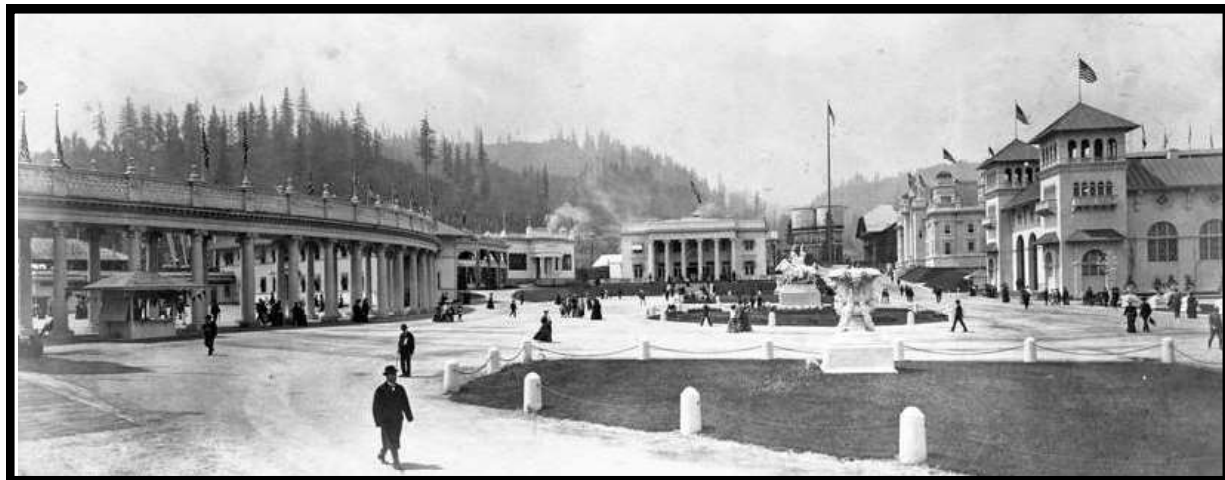




## United States World Fairs: Lewis and Clark Centennial Exposition (1905) - Portland, Oregon

Official Narrative: This fair commemorated the 100th anniversary of the Lewis and Clark Expedition and was held in Portland, Oregon. It highlighted the exploration and settlement of the American West and featured exhibits on regional history and development.

The fairgrounds were dismantled after the event, and the site was redeveloped. Some features, like the Oregon State Building (now the Oregon State Forestry Building), were preserved and relocated.







## **United States World Fairs: Panama–California Exposition (1915-1916) - San Diego, California**

Official Narrative: Held in San Diego, California, this fair celebrated the completion of the Panama Canal and highlighted the achievements of the western United States. It emphasized the cultural connections between the Americas and introduced Spanish Colonial Revival architecture to the region.

It showcased technological advancements, artistic achievements, and cultural exchange on a global scale.

Most structures at the fair were said to be temporary and were thus demolished afterward. Some, such as the Palace of Fine Arts, were preserved and are still present today.







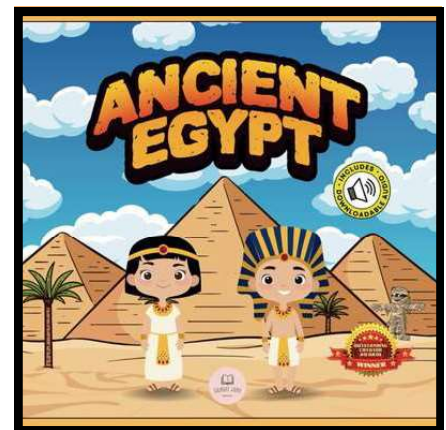
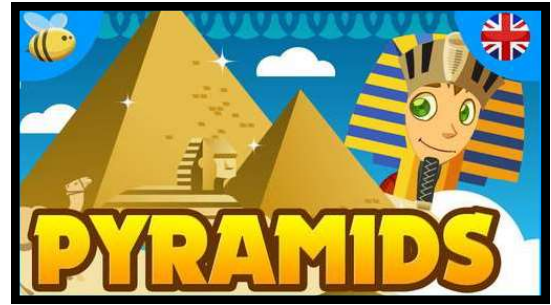
## Why Lie About Bible Lands' Origins in America?

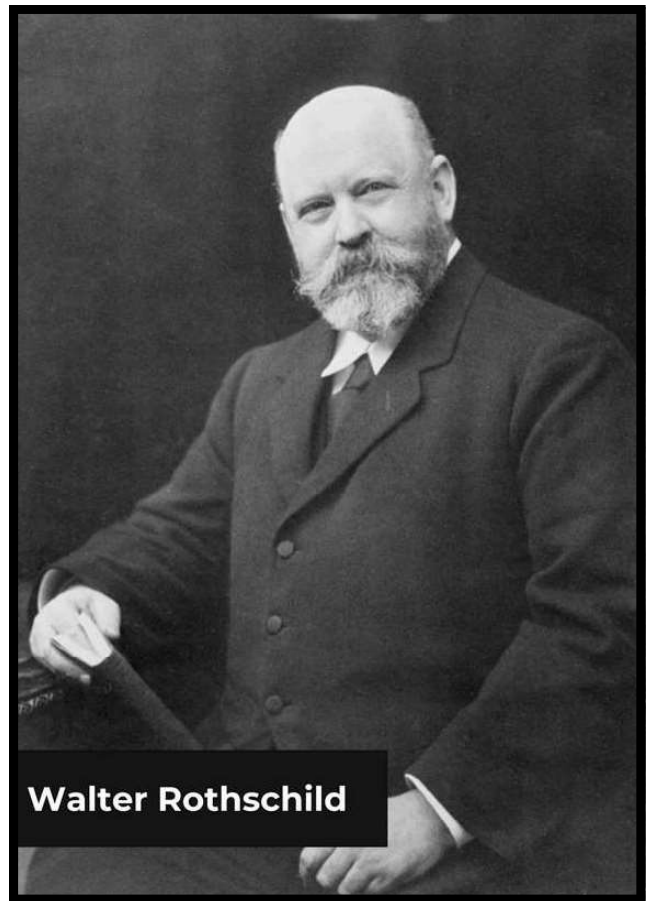


## Modern Day Holy Lands And Religion

## *The Origins of Judaism, Christianity & Islam*

Judaism, Christianity, and Islam all trace their origins back to Abraham. Judaism and Christianity tract their ties back to Abraham through Isaac, while Islam traces their ties back to Abraham through his son Ishmael.

**Judaism:** Today's Jews practice various forms of Judaism. They claim it is the same religion practiced by God's chosen people, the Israelite nation. However, since the destruction of Jerusalem in 70 CE, Judaism has experienced significant changes. Most Jews practice Orthodox Judaism, which arose in the 18th century (interesting timing). They are the smallest of the world's major religions, but are considered a major religion due to its influence on Christianity and Islam.

**Christianity:** Christianity is said to trace its origins back to the days of Jesus in the first century. It is the largest and most widespread religion in the world. The most prominent denomination is the Catholic Church. Both Orthodox Christianity and the Catholic Church claim they originated in the 1st Century C.E. It is said that Christianity split between Catholic and Orthodox in 1054 C.E. Today, there are more than 45,000 denominations around the world.

**Islam:** Islam is said to have been founded by the Prophet Muhammad in the early 7th Century C.E. It is the second-largest religion after Christianity, making up more than 25% of the world population. Islam does not look too kindly upon Jews or Christians. According to our mainstream history, Christians took part in the Crusades in order to free the Holy Land from Islamic control. These crusades are said to have taken place between 1095 and 1291 C.E. The crusaders are remembered as a barbaric people that assaulted the Muslim world, slaughtering tens of thousands of innocent people. And as regards to Jews, Muslims view them as their darkest enemy.



However, there is a lot of discrepancy in these historical claims. Why? Jesus returned during the lifetime of his disciples, seven years after his death, as prophesied by Daniel. Using the Gregorian calendar as reference, Jesus was said to have died around 33 AD. That means Jesus's Millennial Reign took place within the 1st and 10th century AD. Additionally, each tradition anticipates the arrival of significant figures who will play key roles in these prophesied events. For example, in Christianity, the return of Jesus Christ is expected. In Islam, the appearance of Imam Mahdi and the return of Jesus (Isa) are anticipated. In Judaism, the coming of the Messiah is awaited.

The powerful Rothschild family, with the help of the world powers Britain and America, strategically placed the state of Israel among millions of Muslims in order to create a perfect storm. A perfect storm for our controller's end game



designed to capitalize on the end time beliefs of these major religions. At least, that was the plan.

## **The End Game**

Despite the great effort to hide the significance of recent celestial events, it is difficult to imagine that the importance was ever lost on our controllers. By a certain date, they had to prove their argument: humanity's complacency towards the existence of evil and its unity in accepting the current governmental system. This would be done through a one world government that had complete control over the people. It was a plan that would require humanity to accept the terms of the new era. Despite a few hiccups, it would have seemed everything was going according to plan: until the unprecedented 2016 U.S. Presidential election.

### *The 2016 U.S. Presidential Election*

Hillary Clinton, a seasoned politician and former Secretary of State, was positioned to win the Presidential election of 2016. From the time she was to take office on January 20, 2017, to December 22, 2023, there was approximately 6 years and 11 months – almost seven years to complete the final phase of their diabolical task. Christians believe this will lead to the coming of Christ, which would culminate in

the defeat of evil forces at the Battle of Armageddon.

By recreating these events, Satan's minions would deceive the predominately Christian Western World population into believing they were experiencing Bible prophecy. The perfect cover our controllers needed to usher in their New World Order. But this time, without the people's Savior to step in. Satan planned to fully utilize his period of uninterrupted rule to his advantage.

By reenacting the events of old, it would have set the stage for another prophecy Christians would be in expectation of: the deadly persecution of Christians. In fact, before the Messiah appears some Jews are also expecting persecution of those remaining faithful to Jewish beliefs and practices, while some Muslims are expecting trials that will test their faith.

Under Hillary Clinton the "deadly" pandemic was to take place worldwide. ### *All According to Plan*

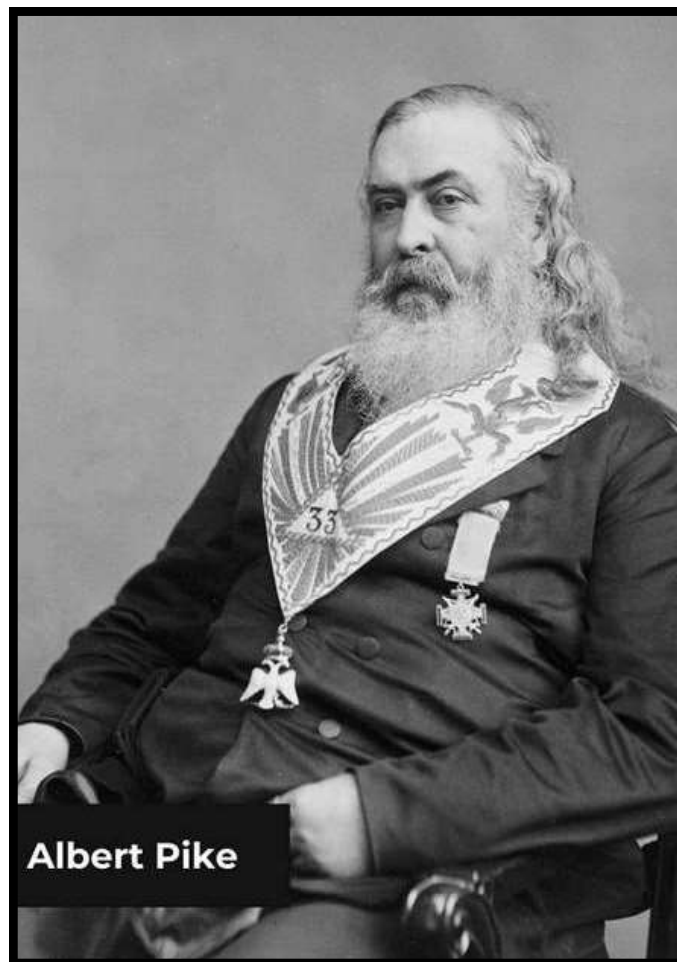
According to a letter from a man named Albert Pike, who was a 33rd degree Freemason and Occultist, he speaks of three world wars that were planned in an attempt to take over the world. The purpose of the Second World War was to destroy Nazism and strengthen the political Zionists "enough to institute a sovereign state of Israel in Palestine". The Third World War was to fan the flames of hatred "between the political Zionists and the leaders of the Islamic World." The purpose of the war would be for both the Muslims and Jews to annihilate each other.

According to Albert Pike's letter, the Muslims, and Jews would fight to destroy each other, forcing the rest of the world to become embroiled in a "fight to the point of complete physical, moral, spiritual and economical exhaustion". This would be followed by the unleashing of unbelievers and atheists, using them as scapegoats for the "social cataclysm which in all its horror will show clearly to the nations the effect of absolute atheism, origin of savagery and of the most bloody turmoil." By this time, Christians would become disillusioned with their faith and their belief in a God, "without compass or direction, anxious for an ideal but without knowing where to render its adoration". For what purpose? So they were prepared to "receive the true light through the universal manifestation of the pure doctrine of Lucifer, brought finally out in the public view." But what could we expect after the April 8th eclipse?

Jesus emphasized that one can discern someone's true nature by observing their 'fruits'. Similarly, we can ascertain whether Jesus has returned by examining the outcomes or 'fruits' of events following the April 8th solar eclipse.

What can we anticipate? The era we have entered parallels the time between the expulsion of the first human pair from the Garden of Eden and the Millennial Reign of Christ, as discussed earlier. That means that God can once again become directly involved with humanity. What will that look like?

### *Signs of A New Era*

How Jesus chooses to handle the new Era will be based on his intimate understanding of the human psyche and a complete understanding of the situation that lays before him. We do not have that complete understanding, so we cannot say for certain how the new era will come to fruition.

It is of course possible that as the new era, or age, begins, Jesus could make his return take place in a direct manner. Should this occur, it could be in response to Satan's extreme actions as he perceives his power being threatened – a response befitting the world's ultimate sociopath. Satan's actions could include causing social unrest or instigate world war. Or, they may cause "natural" disasters, as our controllers have the technology to cause devastation through earthquakes, volcano eruptions,

hurricanes, tornadoes, and so on. As the master deceiver, Satan will want to attach these acts to God to deceive the people into believing they are experiencing the wrath of God.

Whether subtle or apparent, if Jesus and his spiritual army have indeed returned, we can be sure they will support those humans who have worked tirelessly over decades to liberate and awaken others. These individuals have been instrumental in revealing how we the people have acquiesced our power, and who we have acquiesced that power to.

Any effort to take down our controllers before the end of Satan's uninterrupted rule would have been futile due to his iron grip on every aspect of society. But now, it's a different story. We will likely see progress finally being made, from what felt like defeat after defeat to more and more "wins". Nevertheless, we can anticipate that the transition into a new era will not be entirely smooth, due to who we are up against.

For instance, the account of Daniel 10 shows how, from the first day Daniel prayed for understanding, an angel was sent to answer his prayer. However, the "Prince of the kingdom of Persia" blocked him for 21 days. Now, we know this was speaking not of the physical prince, but rather a spirit prince. In fact, Michael, one of the chief princes (or archangel) had to step in to help. This account sheds light on a very important fact: This war taking place on the physical plane, for the souls of humanity, is also a war in the spiritual realm.

Sociopaths never give up. They do not believe it is possible for them to lose, so they will never stop fighting. What happens when a bad tenant receives an eviction notice? If spiteful, they may willfully vandalize or even destroy the place. Satan and his minions just received their eviction notice. He's enraged that he didn't fulfill his mission, especially due to the intentional actions of 'lowly' humans to block him from doing so. Just like any vengeful sociopath, he wants to burn it all down and take us down with him.

## **What to Expect in 2024: Disclosure**

As anxious as we may feel for the appearance of Jesus, it is more likely that Jesus will focus on what really matters – humanity waking up to whom they have acquiesced their power to.

Most do not realize that 2024 is a very significant year for elections. Worldwide, 64 nations will have elections, with a record number of voters – almost 50% of the world's population! While elections may seem laughable or trivial to some, we need to step back and understand what these elections represent: the expression of our sovereignty in deciding who will represent us. Satan has worked hard to ensure humanity remained ignorant to the slave system that we have allowed, desiring this ignorance to continue into this very important election year. ### **What to Expect in 2024: The Role of Russia**

Following the worldwide reset of the 19th century, Russia was situated to play an important role up into the 21st century as the world's antagonist. According to the letter written by Albert Pike, as mentioned previously, Russia (or the Soviet Union at the time) was to play a pivotal role in the growth of communism to counteract Christianity. The letter explains that during the third world war, Russia, along with other communist and socialist nations, would be instrumental in causing widespread chaos and destabilization in Western societies. They would lead the citizens of the nations to a state of exhaustion, both physically and spiritually.

However, this plan never came to fruition, and Satan continues to push for conflict with Russia. But why? The answer may lie in the same reason behind the increased military presence in the Arctic.

While military operations in the Arctic have been ongoing for decades, there has been a recent escalation. For instance, the U.S. Marines and several allies recently conducted joint training exercises in Northern Norway, the largest of such exercises since the Cold War. Similar drills have also taken place in Canada's Northern Arctic waters, involving participants from various countries, including

the U.S. They claim the concern is an escalation on the world scene, emphasizing that these drills are important for preparation for war with Russia, as approximately two-thirds of Russia's shoreline lies along the Arctic Ocean. What if their primary purpose for military presence in the Arctic is to prepare for a conflict with someone other than Russia?

Although it may seem far-fetched at first, the ongoing conflict in Ukraine is crucial to Satan's larger plan for waging war against Jesus' Kingdom. How so? We know that at some point, the "beloved city" and the "camp of the saints" will appear, as there would require a physical presence for "Gog and Magog" a vast army of humanity, to war against it. Hence, the world's military buildup in the Arctic may serve as a smokescreen for Satan's true intentions.

However, even though Russia has had a role to play in the short season, with rulers like Stalin and Putin playing very formidable foes while under the control of our ruling elite, recent developments suggest a change.

There are reports that claim that the controlled puppet, Vladimir Putin, was replaced by his own government. The original Vladimir Putin was said to be a tyrant who ruled through fear and violence, with many members of his own government living in constant fear. The claim is that Russian officials filed charges against him, leading to his swift execution in December 2011. Within weeks of his execution, a new Putin appeared. His wife, Mrs. Putin, claims the new Putin to be an imposter, and eventually they were divorced.
