
## Psychiatric Drug Cocktails:

All JNJ would need to do is seek FDA² approval for (and market) the lower dose. Right?

But, what if JNJ competitor Sandoz<sup>3</sup> makes a similar drug and recommends a 10 mg/day maximum dose too?

Next, add a nurse practitioner<sup>4</sup> and/or a psychiatrist<sup>5</sup> who have the unbridled power to prescribe both<sup>6</sup>?
