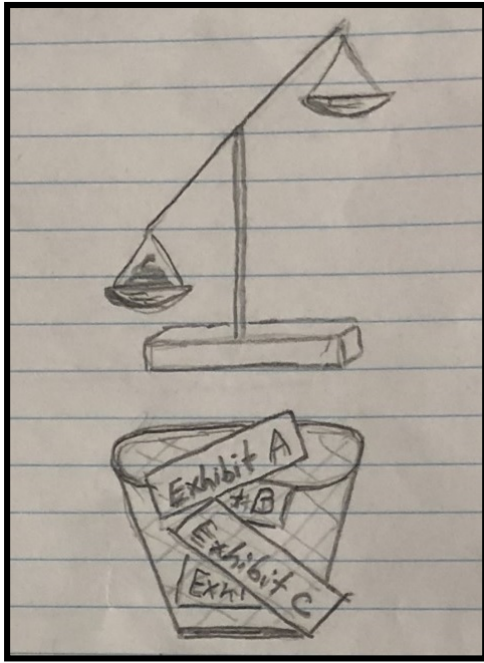


False-Positive Conviction
