Personal favourites for Ottawa include:

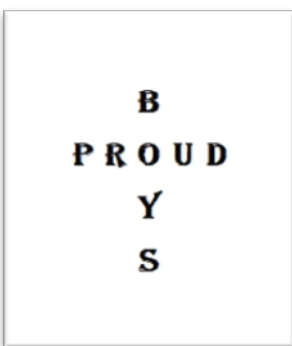
