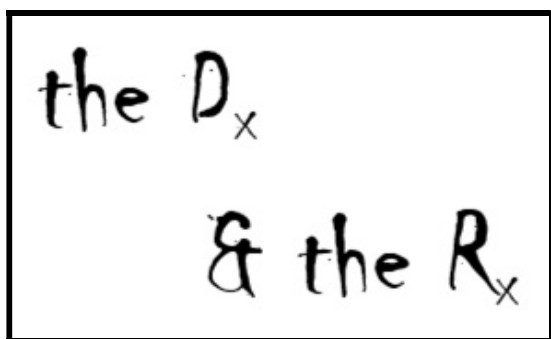


## The *further* Weaponization of Psychiatry: Gates-funded research and Canada's University of Manitoba
