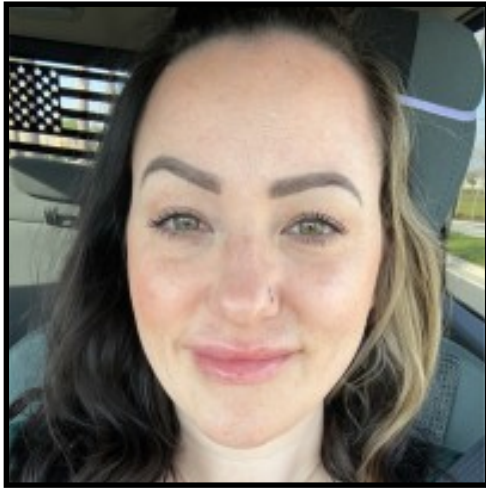


## Even If I'm Shunned
