Dear "Inmates" of Dorms 2

re: Yesterday's Performance

I know that you know that I am a Targeted Individual ("TI"). What you may not know is that:

1. Early in 2017, I began noticing the Technology-assisted Stalking & Harassment ("TASH") including, but not limited to:
 - a) iPhone-deployed techniques using various Applications such as iTunes, Voice Memo and Message,
 - b) Netflix streaming (eg. following a show, recommendation is "Better call Saul"¹),
 - c) YouTube streaming: a thinly-veiled sequence of songs intended to mock me² and
 - d) YouTubers deploying directed conversation (see 2. a) below) via two-way, big-screen devices.

2. Later in 2017, I began to recognize (and document) the many feet on the street ("FOS") techniques including, but not limited to:

- a) directed conversation,
- b) street theatre,
- c) brighting,
- d) home/car invasion (for gaslighting-to-induce-psychotic-break purposes),
- e) Raspberry Pi-assisted hacking of devices³ and
- f) blue-jacking/blue-fishing.

3. Throughout 2018, I became more aware of stalking-by-license-plate (eg. COFFIN (coffin), POASM (Power of Attorney, Sarah Merritt^{SP?})) while simultaneously being "informed" that I was "in training"⁴.

4. Late in 2018, I was compelled to purchase a Jack White CD: I thought he was some kid in Toronto who played guitar — more later.

5. Early in 2019, I received an anonymous e-mail which included a research paper on "gang-stalking"⁵, a term of which I had never heard: it posited that society is approximately 49-51% GSI-mal and the remainder are T/S (see the Gospel according to St. Matthew C13 v 24-30).

6. By the end of March 2019, I was using the term "Barney" to identify/label GSI-mal positioned to overtly harass/provoke me and the term "Bowler" to identify/label GSI-mal positioned to deceive me by posing as some undercover ally. "Hybrids" switched back and forth — likely, due to terrible direction (debatable).

7. Early in 2019, when my children, Sean Charles Kiska and Cate Stella Kiska ("Sean & Cate"), were court-rapped by the DPS-CAS-SCJ triumverate, I knew I was part of a "disassemble the CAS" operation.

8. Mid-2019, while travelling throughout the United States ("U.S."), I met someone who told me about the "language" of cant used by common thieves during the "1700s". I also realized that Jack White ("White") was a TI by:
- listening to the new The Raconteurs release,
 - seeing White's "Seven Nation Army" listed below Nick Drake's "Pink Moon" on a Consequence of Sound Top Songs list,
 - the lack of selection process and understatement of accomplishments for/at his 2019 Wayne State University ("WSU") doctorate award ceremony⁶,
 - the skimming likely occurring at one of his companies, Third Man Records ("TMR") via some duplicate sales/accounting system,
 - internalized concert-ticket skimming (that decreased attendance) and ...
 - back-stabbing "bandmate" Brendan Benson's Twitter account⁷.
9. Meanwhile, during May 2019, pfi.ROCKS was brainstormed by GSI-ben⁸ as I snuck into the American Psychiatric Association's Annual Meeting⁹ as an exhibitor with one of my companies, SAQOTU Inc., in order to get dirt on the psychiatric industry.
10. By December 2019, Brendan Benson ("Benson") had taught me all I need to know about GSI-mal bidding for TI contracts via the use of emojis¹⁰. Alerting teams (or, more accurately, terrorist cells) of new TIs is easily done via tagging on Instagram posts (for example). I also realized¹¹ that CNN articles contain instructions for GSI-mal cells via their version of cant and chosen/alterred photography.
11. 2020 — I travelled from March to September during the international lockdown: Veradero → Havana → Madrid → Dublin → Toronto → Playa del Carmen → Atlanta → Seattle → Anchorage¹² → Cheektowaga¹³ → St. Catharines → Ottawa until re-arrested; but, released with my first GPS-monitoring ankle bracelet. Highlights of 2020 included:
- exposing how IP Addresses were used by GSI-mal to organize cells, internationally¹⁴, as well as structure communications¹⁵ (20200812) and
 - exposing Apple's "PhotoShop" and IMDb.com¹⁶.
12. By April 2021, once I started evidencing more judicial involvement in GSI-mal, SAQOTU Inc.'s www.pfi.ROCKS site was forcibly removed from public view via another OPS-Crown-Bench "catch & release" event.
13. By August 2022, I had fled to St. John's to re-build the site and involve non-Ottawa-based law enforcement.¹⁷
14. September 2023, I landed back in Ontario without any meaningful financial cushion¹⁸. From Niagara Falls, I:
- documented how the shelter system had been infiltrated/captured by organized crime in the Niagara Region and
 - shared Policy Horizons Canada¹⁹ plans with biker gang(s), local businesses, international tourists and immigrant students.

15. By March 2024, I published evidence which incriminated several more psychiatrists in both St. Catharines and Ottawa, as well as exposed so-called shelter Montfort Renaissance²⁰ as merely part of Ottawa's human-trafficking syndicate. (distracted by "ammonia incident": see J20240618 at 1200-1400)
16. By June 2024, evidence of OCDC's involvement was circulated via my 100+ day mail campaign that included #KaraokeCover, #Puzzle²¹ and #Article outlines²² designed to raise awareness via dark humour... with a sense of urgency²³.
17. June 5-15: my 10-day marketing blitz netted evidence of infiltration/capture at the Shepherds of Good Hope; but, more importantly, a hint of what could be in store for the Satanic build back better capital of Canada - Ottawa:
- a) Bestiality Boulevard (Sussex = Sus sex? (su = pig in Greek or Hebrew?))
 - b) Prostitute Promenade (Rideau = curtain?)
 - c) Multicultural Mile (after "Cummings Bridge", Montreal (my trial?))
- Accordingly, yesterday's display was neither unusual nor impressive, just typical & expected.

Facts

Here are a collection of facts, followed by a collection of beliefs, that you may want to consider as you re-assess your options:

1. The Holy Spirit moves in mysterious ways? Perhaps. He also uses:
 - a) directed observation,
 - b) selective hearing & directed listening,
 - c) heightened "intuition" and

 at least, those are most of His techniques of which I am aware (so far).
2. I don't control the timing of "my work". For example, while I suspected SGT Room 4's "Valerie & Marveilleux" GSI-mal team fairly quickly, He "prevented" me from alerting them that "I know" until exactly when I did²⁴: Saturday, June 15th from ~18:00-18:15. And, within six hours, I was re-arrested.
3. I don't "predict" anything: I do try to interpret obvious-to-me symbolism and/or messaging with various degrees of success (see AJ.204 Letter to Senator Kim Pate, #pfiROCKS #KaraokeCover pfi.P051: "Fence" is High" and #Article outline pfi.A051: "Sell Recommendations" — collectively, a mosaic piece suggesting possible, upcoming, severe market manipulation).
4. I am just a scribe, an announcer and/or a distraction. Eliminating me does nothing to the momentum of GSI-ben as He, clearly, is familiar with the concept of succession planning (see the third book of Moses, Deuteronomy: Chapter 34 Verses 5-9).

5. My background includes software development, marketing and business analysis. Your syndicate's system has been reverse-engineered and re-developed with altruistic purpose.
6. My injuries sustained are due to my 20240605-15 tireless marketing of said re-designed system. (His "adrenalin" is one heck of an anaesthetic!)

Beliefs

1. As you are likely aware, in Ottawa, Duty Counsel + Crown + Bench = Circus Theatre designed to present the illusion of a legal-judicial system to unsuspecting TIs. It will be easy to disassemble: the entire process can be outsourced via Zoom immediately to remote, non-captured courthouses.

"You are permanently banned."

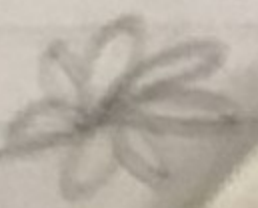

I trust you received a copy of my 20240616 letter to my Shepherds of Good Hope ("SGH") case manager, Beni, from which you can glean a bit of an update. My intention was to drop by in person after my unexpected 20240605 release; but, I was re-arrested shortly after a scandalous 20240612 courthouse event when — following receipt of my damning, evidence-linked response to the Crown's malicious "Attempt to Quash" — OJ's Justice Maria Sivar ("Sivar") called in sick and Crown's prosecutor Malcolm Savage ("Savage") was removed from the file.

Temporarily disabled from "overuse-to-survive" sprained ankles/knees, I am now in a dorm with nothing but inmates who represent a variety of competing interests that all want to keep Ottawa's multi-Ministry, highly-profitable, human trafficking operation intact. Thank you for any assistance in which you are in a position to provide.

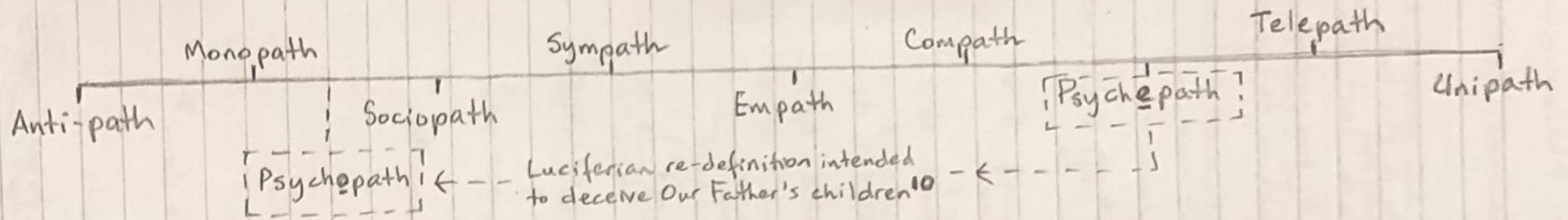

This is a re-drafting of pfi.ROCKS!' 2020 "Descending into Sociopathy" article outline¹. Why? People² can reverse their "descension"; however, the antonym for descension is "ascension" — a term which has been hijacked by "New Age" Christianity/Frequency/Christ Consciousness groups. 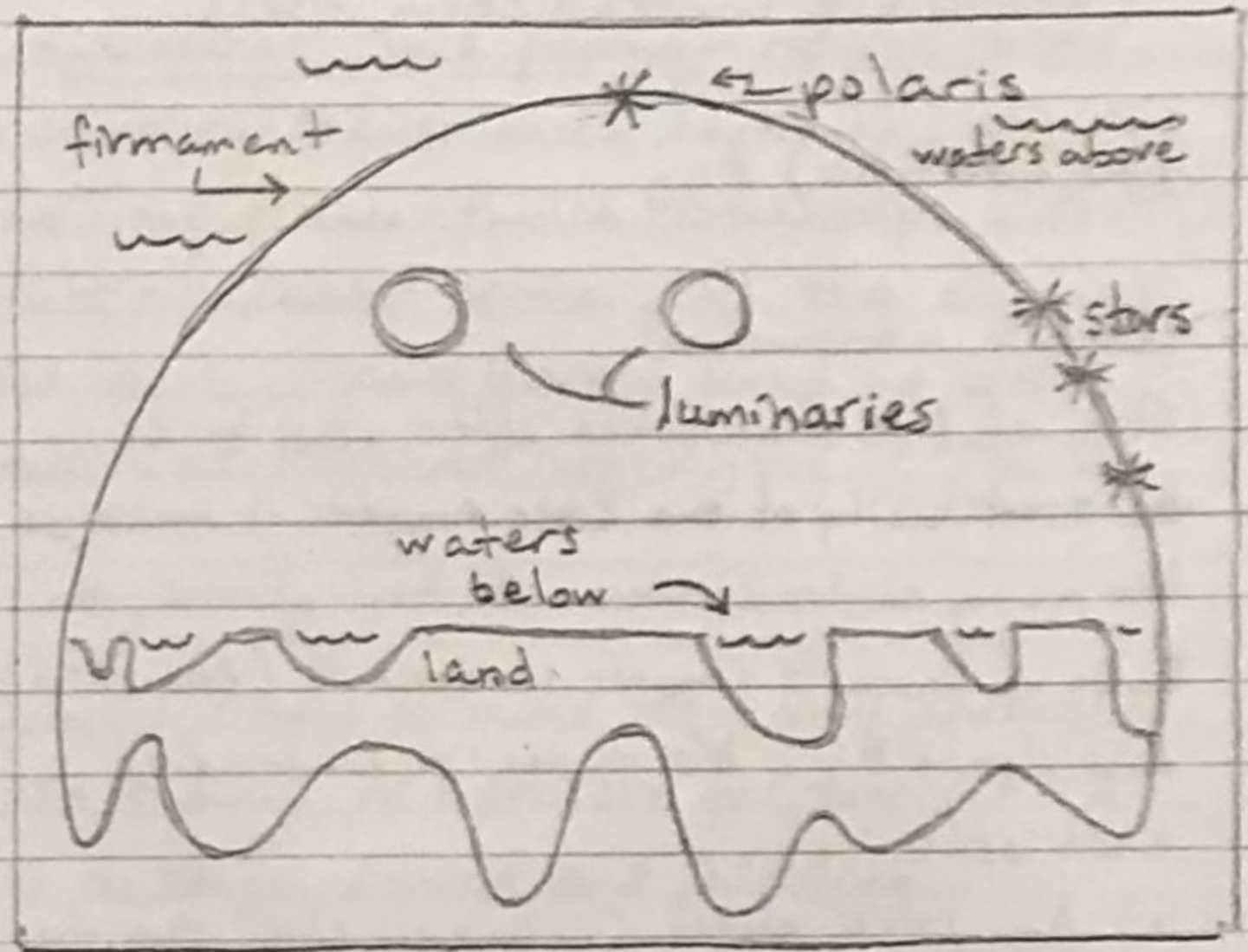

- b) Amos 8:12 states "they shall run to and fro to seek the word of the Lord, and shall not find it."

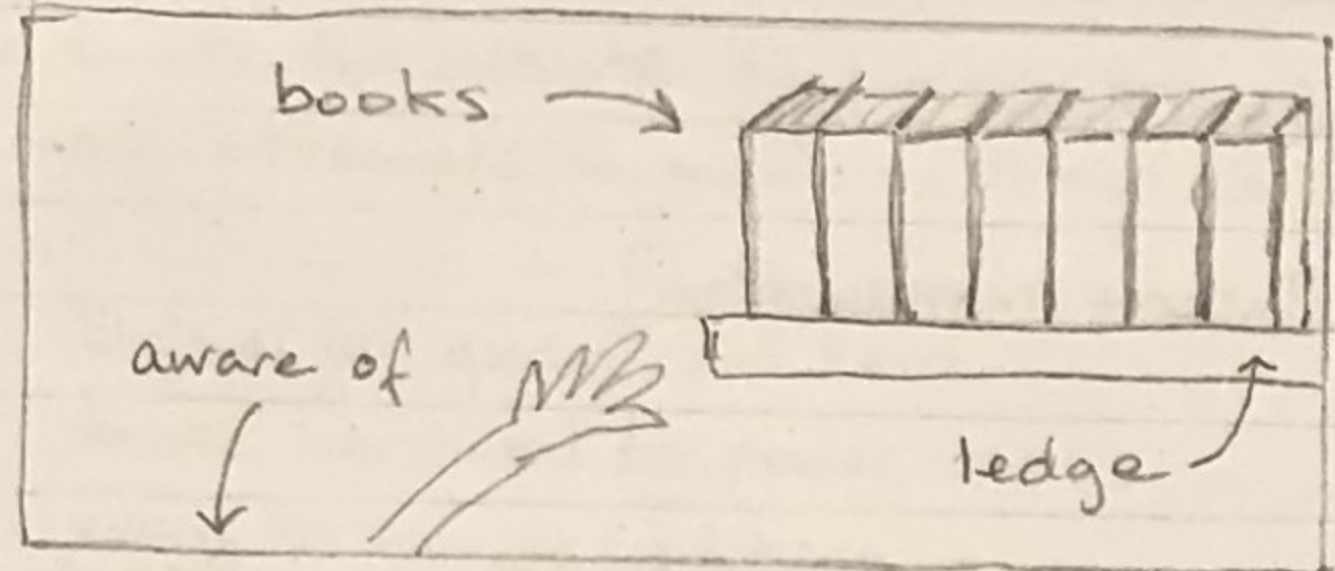

re: Ministry-level collusion, Organizational "negligence" & Private-Public Partnerships (#2/2)

I trust you received my 20240625 package #1/2 re: "Ottawa's Gangstalking Network, Spectrum of Pathology, Wheats & Tares" with seven enclosures. This package returns to the white-collar/"blue"-collar components of Ottawa's crime syndicate which testimony alleging Ministerial-level collusion, organizational "negligence" and Private-Public Partnership ("PPP") strategies that circumvent laws to facilitate multi-faceted crime. As the numbers of individuals involved and acts/omissions increase daily, I can barely keep up with the content. Even Staff Sergeant Costume-wearing Lewis was triggered into saying "F**k You!" at approximately 08:10 this morning.¹

As you'll see from copies of my Memos #111-136 enclosed, I have followed the proper protocols to request assistance and access to justice: there isn't any. As I prepare for tomorrow's Circus-Theatre Appearance ("CTA") #5 — access to evidence denied and fulfilling "Reverse-onus" requirements impossible — it is obvious to me that Ministerial-level collusion is the only thing keeping this operation going. At time of writing, my bogus 20240615 arrest/detention has defrauded taxpayers by over \$5,000, so far. Estimates for my 20231216 and 20240216 arrests/detentions are probably understated at \$20,000 and \$60,000, respectively. The Crown has zero case for any of the three files because:

- OPS failed to ask about my reasonable and/or lawful excuse — a key component required to assess criminal intent for the breach allegations — and
- OPS, among other things, waited for over five hours (and multiple threats) to arrest me after I first tried to file a complaint.

It's one ... big ... racket. And, it's costing us [insert adjective] [insert noun].

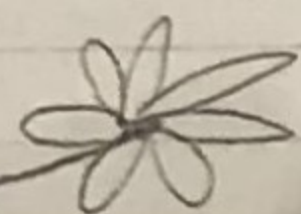

I have been attempting to receive assistance from your OCDC-positioned Elizabeth Fry Society ("E-Fry") representatives without success for the better part of six months. 

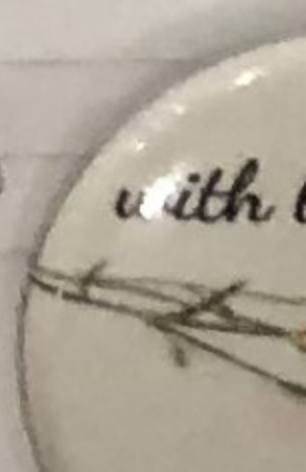

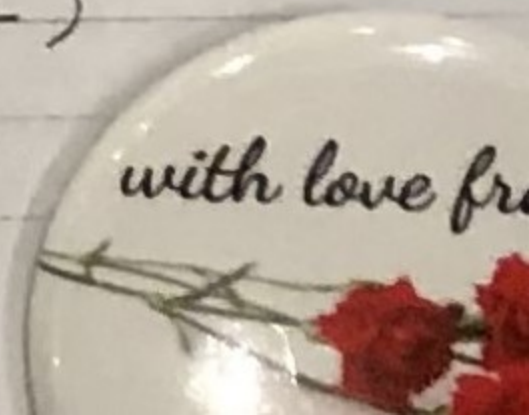

Introduction: It seems to me that OCDC's Head of Security Munro may have a vested interest in keeping this #HumanTrafficking #TaxDollarSkimming operation in tact.¹ Possibly, Munro read the OPS-Crown Disclosure from my 20240615 arrest — a bogus s. 140 charge (see AJ.313) as OPS refused to arrest the petty-theft/
#gangstalking operation that has infiltrated the Shepherds of Good Hope ("SGH") — and realized that, once again, the Disclosure implicates the incompetence, negligence and/or criminality of OPS + Ottawa's Crown Attorney's Office more than it implicates me.

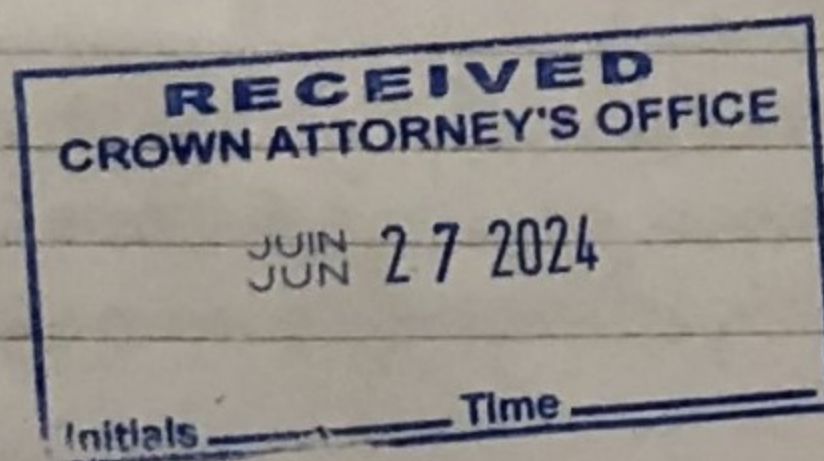

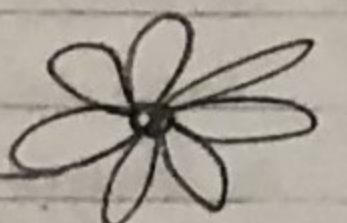
