Subject: Concern that The Black Keys (or Brendan Benson?) may have set up a Jack White Sub-Reddit in order to influence (destroy) your fan base

Dear Jack White,

I began receiving several death threats from your self-proclaimed “Band Stoner”, Brendan Benson, as documented in the About Us / Archives section of www.pfi.ROCKS between December 9-11, 2020.

I am fairly certain that he is *heavily* involved in organized stalking and harassment: a group that I have labelled GSI-mal. I have suspected him for a while; however, he became much more bold when he began combining a technique known as “directed conversation” (<https://www.facebook.com/OrganizedStalkingInformers/posts/313050825461644>) with Technology-assisted Stalking & Harassment (“TASH”) (<http://pfi.rocks/website-content/tash/>). I know much about GSI-mal because I am entering my *EIGHTH* year attempting to divorce a wicked sociopath whom is connected with this Group. I began studying them and collecting evidence against them three years ago.

What set Benson off?

1. My pinned November 19th Tweet at Robert Christgau and Rolling Stone magazine; for neither of which I have any respect:

2. My December 3rd Sub-Reddit r/ jackwhite post
(https://www.reddit.com/r/jackwhite/comments/k63qru/a_little_late_dissed_jack_white_yesterday_so_i/) that:
 - a. Linked to one of my Tweets directed at talk show host, Lilly Singh, who dissed you on her show, “It’s a Little Late”,
 - b. Honoured your accomplishments in an article that I wrote and promoted Third Man Store.
3. The fact that I began my multi-media review of your wicked ex-wife’s book:
http://pfi.rocks/living/story-time/00000000_the-red-flame_karen-elson_000_saqotu_andee-sea-cae-jak-002/
4. My December 4th Ask Reddit post which exposed my home town’s dirtiest secrets: The Ottawa Ticket and The Ottawa Pipeline
(https://www.reddit.com/r/AskReddit/comments/k5x78t/serious_what_is_your_small_town_dark_secret_story/gela3ka?utm_source=share&utm_medium=web2x&context=3)

By the following morning, my 20201203 r/ jackwhite post was DELETED by *some* Reddit moderator; so, I posted this:

Then, I started connecting with some of your devoted fans and by December 5th, I was permanently banned from the thread without explanation! Note that I get temporarily banned at Quora.com (under Deirdre Ann Moore) quite often and permanently banned from Sub-Reddits

often as well. I was kicked out of:

- a. Reddit's r/ Gangstalking (http://pfi.rocks/wp-content/uploads/2020/09/000130KJ_20200917_1100_Printscreen_Reddit_Banned-by-moderator-whom-is-protective-of-sociopaths_SAQOTU.jpg) despite having an entire, self-funded, free website devoted to preventing GSI-mal victimization and offering possible solutions for healing. (I have since been allowed back in.)
- b. Reddit's r/ unpopular opinion for exposing the fact that sociopathy is *not* a mental illness (It was a construct of sociopath "Sick-mind Fraud" in order to crush empaths.) and that certain cities may currently be plagued by a population which contains 40-60% sociopathic citizens.

By December 6th, I began to wonder who the heck was moderating r/ jackwhite with (possibly) your entire fan base at some "anti-Jack White" moderator's control.

On December 7th, I informed Benson (via my secondary Twitter persona @DenaliRyt—which I use primarily for evidence collection purposes and one of which Benson is well aware) that I was reaching out to your fans directly via Reddit direct message: http://pfi.rocks/wp-content/uploads/2020/12/000212KJ_20201206_1400_A-public-apology-to-a-Reddit-Contributor-by-Ande%C3%A9-Sea-Cae-Jak_SAQOTU.pdf.

5. At some point, I informed some of Benson's fans of my @DenaliRyt persona and *that* would have introduced them to my for-social-benefit site, pfi.ROCKS!
6. On December 10th, I reached out to 10 of the individuals who participate at r/ jackwhite with my concerns about whether or not you are also a target of GSI-mal: http://pfi.rocks/wp-content/uploads/2020/12/000216KJ_20201210_Sub-Reddit_jackwhite_Permanently-banned-by-a-pro-sociopath-moderator_extract-of-morning-messages-to-Jack-White-supporters_SAQOTU.jpg
7. In my view, four of them are sociopaths which would enjoy watching your demise. That is 40%! (If I am correct, whoever set up Sub-Reddit r/jackwhite is no friend of yours.)

I have my own opinion on who was behind the Christmas morning explosion: this is unfinished and looks "crazy" (http://pfi.rocks/wp-content/uploads/2020/12/000231KJ_20201225_1900_pfi.ROCKS-Exposing-Terrorism-with-CNN_Draft-Article_Who-is-responsible-for-Nashvilles-20201225-brutal-morning-attack_SAQOTU.pdf); however, there is no denying that the last photo was "doctored" and one has to ask "why"?

I believe that another explosion was intended for Valentine's Day as implied here: http://pfi.rocks/wp-content/uploads/2021/02/000282KJ_20210214_1106_Screenshot_Twitter_Doncallmekaren_Evidence-CANT_Threats-re-Jack-White-Third-Man-Records-and-its-employees_SAQOTU.pdf; however, this page was exposed to law enforcement on February 13th.

Now, according to the r/jackwhite sub-Reddit, the TMR Vault App is no longer supported. I have no idea how much of this requires your micro-management; however, as I did trip over that ticket sales fraud that was occurring in 2019, I thought I should let you know.
