Dear Mayor O'Connell,

As per below, I have been attempting to resolve an urgent issue with one of Nashville's *major* grant/donation recipients, **Room In The Inn** ("RITI"); however, their responses have been either inadequate or non-existent. Growing more desperate, last Monday I:

- spoke with one of your assistants, Keidron Turner, at length about the problem,
- left with him my draft 4-page letter (see attached and work-in-progress html version stored at <https://twb.rocks/living/exposure/room-in-the-inn>) and
- sought guidance regarding the manner in which I could file a formal civil rights complaint against RITI.

As advised, I sent an e-mail to Jane Dozier (see attached) which read:

I would like to submit a formal complaint against this entity as soon as possible; however, they have refused to provide any details on how I should proceed and my requests have either been fully ignored or answered with vague/glib replies while my matter is urgent. Are you in a position to assist?

At time of writing, I have not received *any* response.

Mayor O'Connell, by September 6th I will be forced to part with most of my remaining valuables: I equate this "harassment-by-omission" ("HBO") to orchestrated theft—a method of crime with which I've been exposed since 2019 (as partially evidenced at https://twb.rocks/about-us/stolen-property-1_deirdre-moore). Are you in a position to assist?

Mr. Myers,

I learned yesterday that RITI has a "re-instatement process" when individuals learn when and how their ban will be lifted. Why has nobody mentioned this process to me? Clearly, there's a lot of [monkey business] occurring at Room In The Inn and having an experienced Chartered Financial Analyst (who's done forensic accounting and extensive internal financial reporting at other not-for-profits) is *not* a welcome patron.

When reflecting upon your Executive Director's aggressive, knee-jerk reaction on July 29th and everything that's transpired since (partially evidenced in my 20260805 Agenda published at <https://twb.rocks/riti/riti-conflict-resolution-process/20260805-agenda>), I am left with five nagging questions (as I posted on Twitter yesterday, see attached and entry under August 7th at <https://twb.rocks/archives/y2026/m202608>):

1. Why does the RITI Expense report take so long for veteran Director of Finance Paul Spivey to submit (see image and associated link at <https://twb.rocks/riti/board-presentation>)?
2. Why are there only TWO gift cards offered by the RITI store (ie. Kroger's and McDonald's) when clearly patrons could benefit from access to other necessities like those offered by Goodwill (see previously-loved wheeled cases currently for sale at <https://twb.rocks/living/exposure/room-in-the-inn>)?
3. Why was a Jesus-following, experienced CFA (me) banned from RITI? Despite multiple requests for this answer, I've heard nothing but baseless allegations regarding some unacceptable behavior that "the volunteers are not equipped to handle" despite ALL volunteers thanking me for my attendance, my participation and/or my written material. I experience six weeks with nothing but accolades (see attendance record at <https://twb.rocks/riti/activity-dm>) until Rachel Hester learned of my existence.
4. Who, if anyone, does a complete financial audit of RITI's operations?
5. Are public and/or private funds being misused by RITI management? Have they found a way to commit fraud that can remain undetected as a 501(c)(3) church while seeking additional budget/donations claiming some benevolent service to Nashville's homeless population?

Mr. Myers, as an Asylum seeker (see evidence-linked submissions published at <https://twb.rocks/persecution/us-submissions>), I am not legally permitted to seek employment here until September 2026. I can, however, volunteer and I would gladly volunteer my time and expertise to complete an *extensive* audit of Room In The Inn. In addition to my previous requests (see below), to whom should I submit this offer? Do I leave it with you; or, should I contact your Finance Committee, Mayor Freddie O'Connell's review team or some other oversight agency?
